We wish to provide the following information on a consolidated basis with respect to the quarter ended 31 December 2024:

1. Customer franchise as of 31 December 2024 stood at 97.12 MM as compared to 80.41 MM as of 31 December 2023. In Q3 FY25, the Company recorded highest ever quarterly increase in its customer franchise of 5.03 MM.
2. New loans booked were highest ever at 12.06 MM in Q3 FY25 as compared to 9.86 MM in Q3 FY24, recording a growth of 22%.
3. Assets under management (AUM) grew by 28% to approximately ₹ 398,000 crore as of 31 December 2024 as compared to ₹ 310,968 crore as of 31 December 2023. AUM grew by approximately ₹ 24,100 crore in Q3 FY25.
4. Deposits book stood at approximately ₹ 68,800 crore as of 31 December 2024 as compared to ₹ 58,008 crore as of 31 December 2023, a growth of 19%.
