- 1. We have reviewed the accompanying Statement of Unaudited Financial Results of SMRUTHI ORGANICS LIMITED ('the Company') for the quarter ended 30th June 2024 ('Statement') attached herewith, being submitted by the company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Regulations').
