In continuation of our earlier letters dated July 08, 2024 and July 11, 2024 on the captioned subject, we wish to inform you that, in respect of the Issue, the Fund Raising Committee ("**Committee**") at its meeting held today, i.e., July 12, 2024, has inter alia, approved the issue and allotment of 1,22,04,424 Equity Shares to qualified institutional buyers at the issue price of ₹ 655.50 per Equity Share (including a premium of Rs. 645.50 per Equity Share), (which includes a discount of ₹ 33.97 per Equity Share (4.93% of the floor price, as determined in terms of the SEBI ICDR Regulations), against the floor price of ₹ 89,47 per Equity Share, aggregating to ₹ 80,000 Lakhs pursuant to the Issue.

The Issue opened on July 08, 2024 and closed on July 11, 2024 and the same was intimated to you through our letters dated July 08, 2024 and July 11, 2024, respectively.
