

[Indian Standard Time] (15T) on Wednesday, the 21st August 2024, through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM")

Dear Sir,

I, N Ganesan, a Chartered Accountant in Practice, have been appointed as Scrutinizer by the Board of Directors of Kothari Industrial Corporation Limited (the Company), having its Registered Office at Kothari Buildings, Nungarnbakkam High Road, Chennai-600034, for the purpose of scrutinizing the remote e-voting and e-voting during the EGM held at 11 A.M.(IST) on Wednesday, the 21st August 2024 through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"), in respect of the resolution as set out in the Notice of the EGM, pursuant to Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 and 21 of the Companies (Management and Administration) Rules, 2014 (the Rules), as amended by Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of the SEB! (Listing Obligations and Disclosure Requirements) Regulations, 2015:

- The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules made thereunder relating to remote e-voting and e-voting during the EGM in respect of the resolution set out in the Notice of the EGM of the Members of the Company.
- 2) My responsibility as Scrutinizer for the remote e-voting and e-voting during the EGM is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolution contained in the Notice of EGM which is detailed below, based on the reports generated from the -voting system provided by the Central Depository Services (India)Limited (CDSL).

Now pursuant to the completion of the EGM of the Equity Shareholders of the Company held on **Wednesday**, the **21**<sup>st</sup> **August 2024** at 11.AM, I submit my report as under;

- a) The e-voting facility for both remote e-voting and e-voting during the EGM through VC/OAVM was provided by Central Depository Services (India)Limited (CDSL).
- b) The e-voting period remained open from 9.00 AM on Sunday, 18th August 2024 up to 5.00 PM on Tuesday, 20th August 2024.
- c) The Company had also provided e-voting facility at the EGM held through VC/OAVM and also to those shareholders who had not cast their vote earlier through remote e-voting.
- d) The Equity shareholders holding shares as on 14<sup>th</sup> August 2024, "cutoff date" was entitled to vote on the resolution stated in notice of the EGM of the company.
