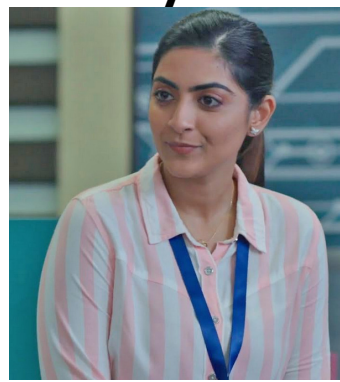

Groundwater crisis: Unregulated usage, high fluoride cause of concern



Ahmedabad, In Gujarat, there has been no regulation on the excessive use of water acquired from borewells, resulting in excessive extraction of groundwater. Despite the government spending millions on groundwater conservation, the water levels are yet not satisfactory. On the contrary, water levels are sinking, and groundwater is no longer safe for drinking. The Ministry of Water Resources has revealed that fluoride levels in groundwater have risen in 25 districts of Gujarat, making it hazardous for human consumption. Groundwater usage is excessive in Gujarat, and as a result, in North Gujarat, there is no water even at depths of 100 feet, suggested the reports. Experts say that if control is not imposed on the use of groundwater, it won't be long before groundwater runs out completely. In response to a question in the Rajya Sabha, the Ministry of Water Resources presented a report stating that the Central Ground Water Board

had taken a total of 632 water samples from various regions of Gujarat. Among these, 88 samples showed the presence of fluoride. A total of 25 districts in Gujarat have fluoride levels above 1.5 mg, which is considered hazardous. The districts with higher fluoride levels include Ahmedabad, Amreli, Anand, Aravalli, Banaskantha, Bhavnagar, Botad, Chhota Udupur, Dahod, Devbhumi Dwarka, Gir Somnath, Jannagar, Junagadh, Kutcha, Mehsana, Morbi, Narmada, Porbandar, Patan, Panchmahal, Rajkot, Sabarkantha, Surat, Surendranagar, and Vadodara. The fluoride levels in these areas are above the acceptable limit, which can prove harmful to human health. Consuming water with high fluoride content can lead to various health issues. The consumption of fluoride-contaminated groundwater has caused an increase in health problems in rural areas, including joint pain, weakened bones, dental decay, skin issues, digestive problems, weakened immunity, and hair loss.

Now BJP will divide Ahmedabad, there will be two presidents

Gandhinagar The work of organizational restructuring is underway in Gujarat BJP. Ahmedabad city is known as BJP Karnavati and currently the entire city has one organizational structure. According to information received from party sources, BJP will now divide Ahmedabad city into two divisions and it will be divided based on geographical area. After the division, two separate units will be formed which will be known as Karnavati East and Karnavati West and in them two separate organizational units will be formed and two presidents will also come.

entire structure will come under the heads of both the departments, from the ward president to all the fronts and the remaining members will report to their respective presidents. Apart from this, the main organizational structure of both the departments will report to the city in-charge. The work will be better with division.

BJP sources say that since the scope of workers in BJP has become very wide, many people are currently expecting them to get some position. The expectation of such workers who are constantly working is reasonable, but due to some limitations, it is not possible, but since Ahmedabad city is large in terms of area, it is possible to solve it if it is divided and two separate structures are formed. This is currently being considered in a very preliminary manner and probably a decision on this matter will have been taken before the new organizational structure is announced.

The division of the organization will make the work easier as work is divided. In this situation, interference in each other's areas will be reduced and division of the organization will make the division of work easier. Instead of the city president having the responsibility of the entire city, it was difficult to focus on all fronts, but since the team including the president and general secretary are from the respective area, it will become easier to work.

How to divide the areas will now be decided, new workers will get a chance A decision will now be taken on whether to divide Ahmedabad city into east and west by dividing the area on both banks of the Sabarmati river into east and west or to divide it by calculating the population and wards based on an imaginary line.

The BJP tries to maintain a balance between East and West in the Ahmedabad Municipality for the positions of Mayor, Standing Committee Chairman, Deputy Mayor, as well as President and General Secretary in the organization. Appointments will also be made to all fronts, from ward presidents.

According to the arrangement that has been considered at present, the
