The company is facing liquidity situation as a result of which there have been defaults in payments from its customers. The company is also facing high interest rates and other dues. However, considering substantial improvement in real estate sector recently, the Management is of the opinion that all such losses will be recovered in due course by required finance through alternate sources, including sale of non-core assets.
