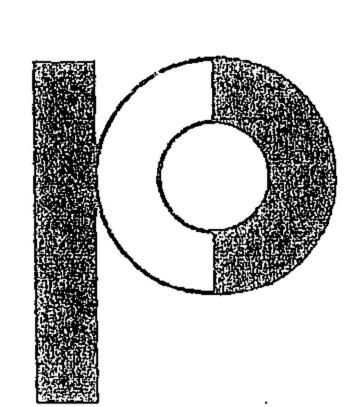

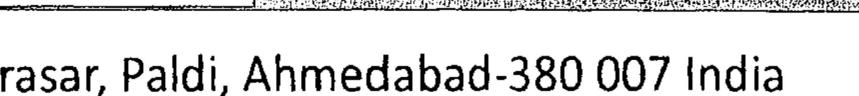

Scrutinizer's Report

Sub:- Scrutinizer's Report on Postal Ballot process conducted through electronic voting system in accordance with the provisions of Section 108 and Section 110 and other applicable provisions, if any, of the Companies Act, 2013 read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014

Dear Sir,

I, MR. ANISH SHAH, Proprietor of M/s. A. Shah & Associates, Practicing Company Secretaries was appointed as a scrutinizer by The Board of Directors of M/S PRATIKSHA **CHEMICALS LIMITED** ("the company") at its meeting held on 05th December, 2024 for conducting the Postal Ballot in terms of MCA Circular No. 14/2020 dated 8th April. 2020, MCA Circular No. 17/2020 dated 13th April, 2020, MCA Circular No. 22/2020 dated 15th June, 2020, MCA Circular No. 33/2020 dated 28th September, 2020, MCA Circular No. 39/2020 dated 31st December, 2020, MCA Circular No. I 0/2021 dated 23rd June, 2021, MCA Circular No. 20/2021 dated 8th December, 2021, MCA Circular No. 3/2022 dated 5th May, 2022 and MCA Circular No. 11/2022 dated 28th December, 2022 (collectively referred as "MCA Circulars") for the purpose of scrutinizing the electronic voting process through remote. E voting ("e-voting") in a fair and transparent manner under the provisions of Section 110 of the Companies Act, 2013 (the Act) read with Rule 22 of the Companies (Management and Administration) Amendment Rules, 2014 (Rules).

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to e- voting and Postal Ballot on the resolutions contained in the Notice of Postal Ballot and e voting of the Company. My responsibility as a Scrutinizer for the e-voting process and voting through postal ballot is restricted only to make a Scrutinizer's Report of the votes cast "in favour" or "against" for the resolutions stated above, based on the reports generated from the e-voting system provided by NSDL the authorized agency engaged by the Company to provide e-voting facilities for e-voting & Ballot paper received from the shareholders.

I hereby issue consolidated scrutinizer's report dated 07th January, 2025 on voting on the Resolutions contained in notice of Postal Ballot and as requested by the Management submit herewith my combined report on results of e-voting together with that of poll paper, if any as under:-

- 1. The E-voting period commenced on 08th December, 2024 from 09.00 A.M and concluded on 06th January, 2025 at 5.00 P.M.
- 2. The facility for e-voting and postal ballot was made available to the Members as on cut-off date i.e. **November 29, 2024.**
- 3. Physical Postal Ballots received till the time fixed for the closing of the Postal Ballot i.e. **5:00 p.m. on January 06, 2024** Were diligently scrutinized and reconciled with the records maintained by the Company / Registrar and Transfer Agent and the authorization logged with the Company.
- 4. The company has completed dispatch of the Notice of Postal Ballot through Electronic mode on 06th December, 2024 to its members, whose name(s) appeared on the register of members/ list of beneficiaries as on the close of business on 29th November, 2024.
- 5. I did not find any invalid postal ballot papers.
- 6. The votes on remote e-voting were unblocked after the conclusion of voting in the presence of two witness who are not in employment of the company and the votes were downloaded from e-voting website and the same are being handed over to the Chairman.
