With reference to the above orders and our above referred letters, by which it was informed to the stock exchanges about the order of the Spl. CBI Court convicting Shri Ramesh Jayaswal, Managing Director of the Company and subsequently Order of suspension of sentence for a period of sixty days and grant of bail.

Further, this is to inform you that, Shri Ramesh Jayaswal has filed an appeal under Section 415 (2) and an application under Section 430 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS), within the stipulated time period before the Hon'ble Delhi High Court, and the said Court has admitted the Appeal and the next date of hearing is 12<sup>th</sup> March, 2025. Further, he has also paid the stipulated fine within a specified time period.

Further, the Hon'ble Delhi High Court, has also extended the order of suspension of sentence passed by the Spl. CBI Court, dated 11<sup>th</sup> December, 2024 on the same terms and conditions till the next date of hearing i.e. 12<sup>th</sup> March, 2025.

We will update you any further material developments going forward in relation to above matter.
