This in continuation to our intimation letter dated 14th August 2023, whereby the Company has reported pending litigation/dispute with Department of Registration of Stamps, Government of Maharashtra with respect to the stamp duty matter in relation to the Scheme of Arrangement between the Sapphire Foods India Limited (previously known as Sapphire Foods India Private Limited) ("Company") & Sapphire Hospitality and Recreation Private Limited ("SHRPL"), Hansazone Private Limited ("HPL"), Pizzeria Fast Foods Restaurants (Madras) Private Limited ("Pizzeria"), KFCH Restaurants Private Limited ("KFCH"). In this regard, please find below further update on the said matter:

Particulars	Description
The details of any change in the status and / or any development in relation to such proceedings	The Company has received a Final Order from the Hon'ble Collector of Stamps, Enforcement I, Mumbai (the "Authority") dated 25 th June 2024 ("Order") as per which the total stamp duty determined by the Authority in relation to the Scheme of Arrangement now stands corrected to Rs. 32.47 lacs. The Company, as informed earlier vide intimation letter dated 14 th August 2023, has already paid Rs. 27.41 lacs to the Authority. The balance stamp duty payable of Rs. 5.06 lacs will be paid by the Company to the Authority within the stipulated timeline.
