With reference to above captioned subject related to Clarification/Confirmation on news item appearing in [www.business-standard.com](http://www.business-standard.com) on 14.10.2024 , kindly note that as per Regulation 30 of SEBI (LODR) Regulation, 2015 as amended from time to time the Company has duly informed the recognized Stock Exchanges i.e. NSE and BSE of all the events, information that have bearing on the operations/performance of the Company including price sensitive information immediately on having the knowledge/information of the events.

Reply: - There is no such circulated information for the general consumption/information of MTNL except that deliberations are being held since long in Govt for various options on way forward in case of MTNL, since Cabinet decision of 2022. However, no such specific decision or information is available at this point of time. As such there is no such circulated / written information that can be disclosed under Regulation 30 of the SEBI (LODR) Regulations, 2015 with MTNL.
