This is in reply to your email dated 28.06.2024 & 15.07.2024 regarding delayed compliance of Regulation 24A with submission of Annual Secretarial Compliance Report, we wish to state that we have filed Annual Secretarial Compliance Report pdf in the prescribed time on 30<sup>th</sup> May, 2024. But we could not file Annual Secretarial Compliance Report in XBRL mode due some technical error in the form. In the XBRL format we filled all sheets and validated the sheets except the "CURRENT REPORT" sheet . The said sheet was not able to validate because the drop box was not appeared to select particular word. Hence we could not validate the complete file. Then we sent the screen shot to xbrl team and they asked to send full file for verification and we sent to BSE XBRL Team. The XBRL team had given required instructions to validate sheets. Even after that we could not get drop box in the "CURRENT REPORT" sheet.

Due to technical error as stated above we could finally filed the report in XBRL mode after some delay.

Hence we wish to state that we have filed the report in pdf format on time and uploaded XBRL format after some delay due to reasons stated above. In view of the above and in response to your email dated 28.06.2024 we have requested in our letter No. OCL/BSE/2024-25/28, July 03, 2024(copy attached herewith) to kindly Waive this fine of Rs. 26,000/- plus Taxes levied by you (Total Rs.30,680) as a special case and as this is the first time delay in filing the return and due to poor financial conditions.

However we have received a reminder mail dated 15.07.2024 from your office reminding to pay the above fine of Rs.30,680/- immediately. We therefore again request you to kindly Waive this fine of Rs. 26,000/- plus Taxes levied by you (Total Rs.30,680) as a special case and as this is the first time delay in filing the return and due to poor financial conditions.

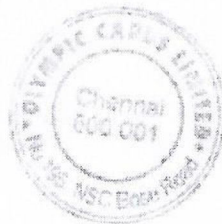
