ITEM NO. 1 & 2:

The Members vide Special Resolution passed at the Annual General Meeting on 11th September, 2014, had enhanced the borrowing power of the Company under Section 180(1)(c) of the Companies Act, 2013 up to Rs.100 Crore (Rupees One Hundred Crore Only), over and above the paid-up capital and free reserves (apart from temporary loans obtained or to be obtained from the Company's bankers in the ordinary course of business) of the Company. Considering the business requirements of the Company, it is proposed to increase the borrowing limits from Rs.100 Crore (Rupees One Hundred Crore Only) to Rs.500 Crore (Rupees Five Hundred Crore Only) over and above the paid-up capital, free reserves and securities premium of the Company in terms of provisions of Section 180(1)(c) of the Companies Act, 2013.
