Company Secretary confirmed that the convening of the virtual Annual General Meeting was in compliance of the circulars issued by the Ministry of Corporate Affairs (MCA), Government of India and the Securities and Exchange Board of India (SEBI) and that the company has appointed Central Depositories Central Depository Services (India) Ltd (CDSL) to conduct the voting by way of remote e-voting and e-voting during the AGM.

As the requisite quorum being present, the Chairman called the meeting in order. The Chairman commenced the proceedings with his opening remarks.

The notice convening the meeting, Director's Report, Corporate Governance Report, Management Discussion and Analysis Report, Independent Auditors Report including Financial Statements of the Company for the year ending 31<sup>st</sup> March, 2024 were taken as read.

The following items of business as per the notice of the AGM were transacted at the Meeting.

### **Ordinary Business:**

1. To consider and approve the Audited Financial Statements for the Year ended 31<sup>st</sup> March 2024 with the Report of the Board of Directors and the Auditors thereon.

2. To declare dividend of 25% i.e., Rs.2.50 per share on the equity shares for the financial year ended March 31, 2024.

3. To consider the appointment of a director in place of Mr. G Ganesh Kumar (DIN: 01009765) who retires by rotation and being eligible, offers himself for re-appointment.

#### **Special Business:**

4. To approve the remuneration payable to cost Auditor Mr. Sativada Venkat Rao, of the Company for the Financial year 2024-25.

The Company Secretary informed that the company had provided remote e-voting facilities to its members on all resolutions set out in the notice of AGM and which was commenced from Friday, the 27<sup>th</sup> day of September, 2024(9.00 a.m. IST) and available till Sunday, the 29<sup>th</sup> day of September 2024(5.00 p.m. IST). Company Secretary mentioned that Members who have joined the meeting through VC and who had not cast their vote though the remote e-voting, may vote through e-voting facility during the AGM.

Chairman informed that Mrs. D Renuka, Practicing Company Secretary has been appointed as the Scrutinizer to scrutinize the remote e-voting process in a fair and transparent manner and give a report thereon.

The Chairman informed the members that the consolidated report of the remote e-voting and voting at the Meeting will be posted on the website of the Company www.tycheindustries.net and the website of CDSL at www.cdslindiaindia.com within 2 working days from the conclusion of the meeting and the same will be informed to the Stock Exchange.
