# PMS' tilt towards mid, small-caps sparks concerns

Portfolio management services (PMS) schemes remain tilted towards small and mid-caps (SMIDs) despite lofty valuations.

One in two PMS schemes has over 60 per cent of assets under management in SMIDs, data from PMS Bazaar showed. Fifty nine out of 204 schemes under consideration had over 75 per cent of their assets parked in these categories.

Only 23 schemes had a cash holding of more than 10 per cent.

"Such high allocation may be seen as a red flag," said Amit Goel, Co-Founder and Chief Global Strategist, Pace 360, which runs a multi-asset PMS. "SMIDs are more volatile and sensitive to market corrections compared to large caps. A concentrated exposure can amplify the upside but carry higher risks when markets are overvalued."

PMS schemes were the most impacted in the after-

math of the crash in SMIDs in 2018, as such stocks went into free fall.

The Nifty Midcap 100 and Nifty Smallcap 100 indices trade at price to earnings multiples of 39.5x and 25x on a 12-month forward basis compared with the 10-year average multiples of 21.8x and 15.9x, respectively.

The extent of 'richness' in multiples is accentuated in broader markets, with financials being the only exception, a recent note by Kotak Institutional Equities said.

Vicky Mehta, an invest-

ment analyst, believes that it isn't uncommon for portfolio managers that follow a growth-oriented approach to invest in richly-valued stocks. Such investments can result in the fund experiencing more volatility than a typical peer, he said, particu-

larly if the companies fail to deliver on the lofty growth rates required to justify their valuations.

**REPOSITIONING**  
While large caps offer relatively better valuations, stability and liquidity, it may not be easy for PMS schemes to shift or reposition their portfolios drastically.

"Many schemes mandate a high degree of SMID holdings, making repositioning tricky. Repositioning portfolios after market correction may not work most times as

the market declines are already factored into the net asset value," said Sameer Kamdar, CEO, Smart Money.

Heavily concentrated SMID portfolios are less liquid compared to large caps, and substantial selling to rebalance could potentially exacerbate market declines, according to Goel.

"SMIDs often experience sharper declines during broad market corrections, making it difficult to exit positions without incurring losses. The process may also be constrained by low liquid-

ity of the stocks," he said.

Manish Bhandari, CIO at Vallum Capital Advisors, feels that PMS schemes should stick to their mandates and should not reposition their portfolios.

"If history has to repeat itself, similar to 2009 to 2014, when markets gave muted returns, stock picking will triumph over an index-hugging approach of investing," he said.

Goel feels investors should evaluate the historical performance of PMS schemes and the strategy

used by the portfolio managers. "Understand the liquidity of the underlying assets and the potential impact of large trades on the portfolio. Look for schemes that offer a balanced exposure," he said.

Ability to invest over longer periods of instability and to bear higher risks should be on the top of the mind, added Kamdar: "Returns should not be the sole criterion to invest. A longer holding period of at least 3-5 years should be considered while investing in SMIDs."

## ICAI sets up group on auditing standard changes

The CA Institute has constituted a 16-member group to guide the Central Council on the issues around NFRA's proposed changes to a key auditing standard, SA 600, on 'Using the Work of Another Auditor'.

This group is expected to present a report and a note for the consideration of the ICAI Central Council, which is to meet on September 17 to discuss the situation and decide the next course of action, sources close to the development said.

The group, which includes at least four former ICAI Presidents and past AASB chiefs, is being headed by Debashis Mitra, former ICAI President, they added.

The National Financial Reporting Authority (NFRA) wants the Institute of Chartered Accountants of India (ICAI) to bring changes to its two decades-



The NFRA wants to go ahead to bring changes if the ICAI is not moving on the matter. Already, the NFRA has indicated that it would bring a consultation paper on the issue and expose it for public comments before sending it to the Corporate Affairs Ministry (MCA) for notifying the revised auditing standard.

**FIRMS AT RISK**  
ICAI president Ranjeet Kumar Agarwal recently told *businessline* that the CA Institute is not in favour of any update to the two decades-old SA 600 that would lead to the concentration of the audit market in a few hands.

He had then said that the NFRA plan would affect small practitioners, and virtually kill a majority of the 96,000 CA firms in the country.

India cannot "afford" to allow the audit market to be concentrated in the hands of a few firms, according to Agarwal.

## SpiceJet's Ajay Singh may sell over 10% stake in airline

SpiceJet promoter and Chairman Ajay Singh may offload more than 10 per cent stake in the struggling carrier as part of the latest funding round that is expected to close by the end of September, according to sources.

The budget carrier, which is grappling with multiple woes, including financial challenges, legal battles and grounding of aircraft, is looking to raise money that will help it meet various obligations.

One of the sources said that Singh could offload up to a 15 per cent stake in the airline if certain conditions are conducive.

Singh, who is the Chairman and Managing Director, would be offloading around 10 per cent shareholding and the quantum could go up, the second source said.

For the proposed QIP (Qualified Institutional Placement), there is already a commitment for up to ₹2,000 crore, and the airline is in discussions with potential investors.

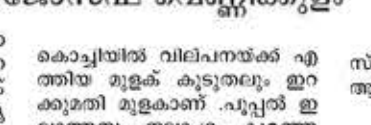
