Independent Auditor's Review Report on the Unaudited Financial Results of Decillion Finance Limited for the Quarter and nine months ended December 31, 2024 pursuant to the Regulation 33 of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015, as amended

Review Report to the Board of Directors of Decillion Finance Limited


