Dear Sir/Madam,

This is in reference to the disclosure submitted by Cheviot Company Limited ('the Company') on January 30, 2024 with respect to Outcome of Board Meeting - Appointment/Re-appointment of Independent Directors of the Company.

As per Sub-para 7 of Para A Part A of Schedule III of SEBI (LODR) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, in case of appointment of directors, key managerial personnel (Managing Director, Chief Executive Officer, Chief Financial Officer, Company Secretary etc.), senior management, Auditor and Compliance Officer shall be disclosed to the Stock Exchanges by the listed entities within 30 minutes of conclusion of the Board Meeting.

In the above case, it was observed that the intimation regarding appointment of Mr. Sutirtha Bhattacharya, Mr. Deo Kishan Mohta, Mr. Siddharth Jhajharia and re-appointment of Mrs. Rashmi Prashad were submitted with the Stock Exchange with a delay beyond the timeline prescribed in the aforesaid provisions.

The aforesaid non-compliance on your part is viewed seriously. You are hereby advised to be cautious in future, exercise due diligence and initiate corrective steps to avoid recurrence of such lapses so as to ensure due compliance with the applicable provisions of SEBI (LODR) Regulations, 2015 and SEBI Circulars. Any aberration in future will be viewed seriously and appropriate action would be initiated.

The Company is required to disseminate a copy of this Cautionary Letter on the Stock Exchanges where they are listed. Additionally, the Company is advised to place before their Board of Directors Cautionary Letter and the corrective measures taken by the company to avoid such lapses.
