Subject: - Update on receipt of amounts towards first and final call on the partly paid-up equity shares of the Company.

The Company, pursuant to fixing of January 15, 2024 as the record date for payment of First and Final Call on the partly paid-up equity shares of the Company, had sent the Notice to the shareholders of the Company as on the record date for payment of ₹ 333/- per partly paid-up equity share towards First and Final Call, during the period from January 23, 2024 to February 5, 2024.

The Company has received an amount of ₹ **29,10,47,994/-** (Rupees Twenty Nine Crores Ten Lakhs Forty Seven Thousands Nine Hundred and Ninety Four Only) on **8,74,018** equity shares. The Right's Issue Committee of the Board of Directors of the Company at its meeting held on February 15, 2024 (which commenced at 2:00 p.m, and concluded at 2:25 p.m.), approved conversion of 8,74,018 partly paid-up equity shares having a face value of Rs.10/- each bearing ISIN: IN909EO01012 in to fully paid-up equity shares having a face value of Rs.10/- each bearing ISIN: INE09EO01013 (hereinafter referred to as the Converted Rights Equity Shares").

The Company is in process of completing necessary formalities for corporate actions / obtaining listing and trading approvals in respect of the Converted Rights Equity Shares.

Further, in relation to the balance **18,273** partly paid-up Rights Equity Shares on which the First and Final Call money aggregating to ₹ **60,84,909/-** remains unpaid and once all the requisite formalities are completed, the Right's Issue Committee will convene a meeting to approve, sending a Reminder Notice to the shareholders of the partly paid-up equity shares for payment of unpaid First and Final Call money together with interest.
