K'taka HC to resume hearing on CM's petition challenging Guv prosecution order

The Karnataka High Court is set to resume hearing on Chef Minister Siddaramaiahs legality of the Governor Theawarchandis sanction for his prosecution in the Mysuru Urban Development Authority (MUDA) case on Thursday.

The Governor on August 16 accorded sanction under Section 17A of the Prevention of Corruption Act, 1988 and Section 17A of the Prevention of Corruption Act, 1988 and Section 218 of the Bharatity alagarik Suraksha Sanhita, 2023 for the commission of the alleged offences as mentioned in the petitions of Pradeep Kumar S P, T J Abraham and Senhamayi Krishna.
