SUB: REPORT ON POSTAL BALLOT PROCESS THROUGH REMOTE E-VOTING CARRIED OUT DURING 20TH DECEMBER 2024 TO 18^{TH} JANUARY 2025

I, Mr. Prasen Naithani, in the capacity of the Scrutinizer, furnish the scrutinizer report as under:

- The Company engaged the services of Central Depository Services (India) Limited (the "CDSL") (hereinafter referred to as the "Service Provider") to offer the e-voting facility to its shareholders. The evoting facility was offered and kept open by the Company to its Shareholders for the period commencing on 20th December, 2024 (09.00 am) and ending on 18th January, 2024 (5.00 pm). The shareholders whose names appeared in the Register of Members / List of Beneficial Owners as on 13th December, 2024 (i.e. cut - off date) were allowed to participate and vote electronically during the aforesaid period of e-voting
- 2. As per Ministry of Corporate Affairs General Circular Nos. 14/2020 dated 8th April, 2020, 17/2020 dated 13th April, 2020, 22/2020 dated 15th June, 2020,33/2020 dated 28th September, 2020, 39/2020 dated 31st December, 2020, 02/2021 dated 13th January, 2021, 21/2021 dated 14th December, 2021, 02/2022 dated 5th May, 2022, 10/2022 dated 28th December, 2022, 09/2023 dated 25th September, 2023 and 09/2024 dated 19th September, 2024 ("MCA Circulars") and any other applicable laws and regulations (including any statutory modification(s) or re-enactment(s) thereof for the time being in force) and as amended from time to time), the Company had sent the Postal Ballot Notice dated 11th November, 2024 by email to all Members, whose e-mail addresses were registered with Company and Depositories (i.e. CDSL and NSDL) and whose names were recorded in the Register of Members of the Company or in the Register of Beneficial Owner maintained by the Depositories as on the Cut-off date i.e. 13th December, 2024.
- 3. After closure of E-voting, the votes cast through remote e-voting were unblocked and downloaded from the e-voting website of Central Depository Services (India) Limited in the presence of two witnesses i.e. Ms. Praggya Tripathi and Ms. Khushboo Siddiqui who are not in the employment of the company. The e-voting data / results downloaded from the E-voting system of CDSL were scrutinized and reviewed, the votes were counted and the results were prepared.
- 4. Particulars of votes cast through electronic means only have been entered in the register separately maintained for the purpose. Since there was no voting by physical postal ballot form, the question of keeping them under my safe custody before commencing the scrutiny does not arise. Since the voting on Postal Ballot was Conducted only through remote e-voting, reporting on number of envelopes containing postal ballot form received after due date and up to the date of this report and returned undelivered does not arise and reporting on finding of defaced or mutilated ballot paper does not arise.
- 5. I am herewith enclosing the details containing inter alia, list of shareholders, who cast their votes through E-voting on the resolution.
