ORDER

1. Heard learned counsel for the parties at length.
2. Issue notice to the respondent which is accepted by counsel Mr. Arjun Natarajan who is seeking time to file Vakalatnama, to take instructions and to file reply in the application for condonation of delay. Time, as prayed for, is granted to the respondent till 3.3.2025 and rejoinder by the appellant, if any, by next date of hearing.
3. Learned Counsel for the appellant is praying for grant of interim relief as was granted by this Tribunal vide its order dated 31.1.2025 in a similar matter, being T.A. 4/2025.
4. Accordingly, having heard the learned counsels for both the sides and looking to the facts and circumstance of the case, by way of interim measure, the respondent is restrained from taking any coercive steps against the appellant to realize the impugned demands, till the next date of hearing.

5. List the matter under the same heading on 3.4.2025.

6. Learned Counsel appearing for the respondent vehemently submitted that certain documents regarding reminders issued by TRAI after the Financial Disincentive orders have not been annexed with the memo of this Telecom Appeal. Learned Counsel for the Appellant agrees to respond to this issue.
