# Panel set up to probe Delhi coaching centre deaths

Treasury, Opposition benches indulge in blame game in Rajya Sabha

NIKHILA HENRY & ANONNA DUTT New Delhi, July 29

THE SHORT DURATION discussion in the Rajya Sabha on Monday over the death of three UPSC aspirants due to flooding of the basement of a coaching centre in Delhi saw a blame game between the Treasury and Opposition benches, with the BJP ministers and MPs accusing the Aam Aadmi Party (AAP) government over the incident

Hitting back, the AAP and  $the\,Opposition\,INDIA\,bloc\,tar$ geted the Centre over the incident that occurred at Rau's IAS Study Circle in Delhi's Old Rajinder Nagar following heavy rains on July 27.

Education minister Dharmendra Pradhan and minister for housing and urban affairs Manohar Lal Khattar spoke during the debate in the Upper House, which was allowed by chairman Jagdeep Dhankar

after the Question Hour. Pradhan said that while education is in the Concurrent List, states cannot shirk their responsibility when it comes to cracking down on illegal coaching institutes.

The education minister told the House that the Union government had sent directives to all states in 2017, 2019, 2020 and 2024 to regulate coaching institutes. The directives were aimed at registration of coaching institutes and prescribing minimum standards that the coaching institutes must follow, he said. The directives also made it clear to the states that they should monitor the function $ing\, of\, such\, coaching\, institutes$ and penalise them for any lapses, he added.

ing centres. If that was followed this incident would not have done. It is the state's responsibility. You cannot shirk the responsibility," Pradhan said, adding, "We must pin responsibility to prevent such incidents from recurring."

Minister Khattar, who

spoke after Pradhan, accused the AAP-led Delhi government of "carelessness". He said the government's alleged negligence led to the deaths of three students. Those who were responsible for these deaths is the AAP-run Munici pal Corporation of Delhi (MCD) or the Delhi government, he said, accusing the AAP government of not maintaining sewerage lines that

extend even up to Haryana. Khattar said that the errant coaching institute was given a No Objection Certification (NOC) by the MCD despite having no clearance to run classes in the basement of the building. He said that on the complaints portal of the MCD a student of the errant institute had lodged a complaint pointing to the poor condition of the institute. This too was "ignored", he said. AAP member Sanjay Singh,

however, defended the Delhi government, stating that the Delhi government has managed the sewers well. The AAP government has provided piped water to 99.6% people in unregulated colonies, installed over 4,000 km sewer lines in 1,000 plus unregulated colonies, changed 3,500 km of water pipeline and 3,100 km sewer lines, and installed 7,300 km new water pipeline, he said.

On why the errant coaching centre was allowed to operate, Singh said that such coaching centres have been functioning for the last 20-25 years, during which the BJP was largely running the MCD. He added that the Delhi minister in-charge had asked the officers to carry out desilting activities in the city, but "they were not listening with the control of services being with the Lt Governor", who reports

to the Centre. The debate also witnessed several Opposition leaders accusing the Union government of allowing coaching institutes to mushroom in the country.

Treading with care, the INDIA bloc MPs tried to steer clear of blaming the AAP, their alliance partner, in the

While some like Tiruchi Siva of the DMK placed the blame squarely on the L-G for not allowing the elected AAP government to function, leaders of the Congress, RJD, CPI(M), CPI and IUML were of the opinion that the coaching institutes should be blamed and that the Union government, under whom education falls, should be held responsible for the mushrooming of these institutes.

Meanwhile, the ministry of home affairs (MHA) has constituted a committee to inquire into the incident. The committee will enquire about the reasons, fix responsibility, suggest measures and recommend policy changes.

# Paris cheers for Rafa's 'last dance'


INSIDE THE MEGA kitchen of Paris's biggest, most famous patisserie, the chef is overcome by bittersweet emotions.

# Shooter Arjun misses medal

AS AN ALMOST teary-eyed author Deepti Babuta shows her son Arjun Babuta's trophy cabinet moments after the 25-yearold finished fourth in the men's 10m air rifle final at the Paris Olympics, the award-winning author points towards an anthology of poems Sab toh Khatarnak by Punjabi poet Avtaar Singh Paash.

The author and emotional mother recites a verse as a message to her son post the heartbreaking finish at the Chateauroux range. *"Sab toh khatarnak hunda* 

hai sade supnayen da mar jana (The most dangerous thing is the death of our dreams). It's just the start of Arjun's Olympic dream and a fourth place can't end his journey as a shooter or his dream to win an Olympics medal for India some day," Deepti, whose short story collection Bhukh Eon Sah Laindi Hai (Hunger breathes like this) had won the Dhahan Prize for Puniabi International Literature last

While Arjun's father Neerai was cheering for the youngster during the eight-shooter final, where Arjun was among the top three for the major part, the retired station superintendent kept himself in his room after

the near-miss for his son.

Arjun's fascination with shooting began when his father read an article about a shooter winning multiple medals in 2012. A teenaged Arjun would approach Olympic gold medallist Abhinav Bindra's coach JS Dhillon for training in 2013. He would accompany her mother on a scooter with his equipment in an auto-rickshaw. Ariun would win a bronze

medal at the ISSF Junior World Cup and an Asian Championships silver in 2016. But he suffered a setback in 2018 when he fell during practice at the

### COACHING CENTRE DEATHS: AAP GOVT-L-G BLAME GAME CONTINUES

# Claims, counter claims In note, CS points fly on drain declogging

 $FOLLOWING\,THE\,deaths\,of\,three$ UPSC students in the flooded  $basement \, of \, a \, coaching \, centre \, in \,$ Old Rajinder Nagar the war of words continued between the AAP-Delhi government and the Lieutenant Governor — this time,

over shoddy drain desilting . While Urban Development Minister Saurabh Bharadwaj Monday accused L-G V K Saxena and Chief Secretary Naresh Kumar of not carrying out desilting work properly ahead of the monsoon season, the L-G office accused the Delhi government in general, and Bharadwai in particular, of sitting on these files.

"After sitting on the file for over five months, Bharadwaj sent the file back to the Principal Secretary (I&FC) asking for a meeting of all stakeholders and demanding a presentation. Thereafter, the file was sent back to Bharadwaj on 08.04.2024. Since then the proposal is lying pending with him," the L-G's office stated.

Alleging that desilting of drains was carried out only on paper, Bharadwaj in a press con-ference Monday said the Chief Secretary ignored his directions to conduct a third-party audit of desilted drains. He said the coaching centre deaths was a result of this negligence.

"The CS, in writing, even said the minister cannot seek details  $of \, desilting \, citing \, Model \, Code \, of \,$ Conduct (in place during the Lok

Sabha polls," Bharadwaj alleged. The Chief Secretary did not respond to a request for com-ment on Bharadwaj's claim.

The minister also alleged Kumar misled the High Court about desilting of drains and waterlogging situation in the city. I would like to request the High Court to file a case of contempt of court against them, be-

cause they also submitted a false report... on cleaning of drains. he alleged, adding that he had complained about this to the Union Home Minister's Office through a letter on June 14, 2024.

He also raised questions about the central government giving extensions to Kumar: The Centre has given two extensions to Kumar... There are senior officers in line... but he was given extensions... He is doing nothing except ruining the city.

Bharadwaj also alleged that he had been writing to Kumar and other department secretaries concerned since February for a meeting to chalk out a comprehensive plan for drainage management to avoid waterlogging in Delhi but neither they hey respond nor did they attend the meeting.

... I issued a call for a meeting on February 6 to the Chief Secretary, DDA Vice-Chairman, MCD Commissioner, DJB CEO, Principal Secretary PWD, Secretary I&FC, and others. The meeting was scheduled for February 13 but not even one IAS officer turned up. This is the seriousness of these officers..., he alleged.

He claimed only executive engineers attended the meeting

meeting, he said, "What can an ngineer-level officer do? What decision will he take? So I ex-

pressed displeasure over this." The Minister also alleged that he wrote to the Chief Secretary to take action and issue a showcause notice against the officers who did not attend the meeting on February 23 but he did not take any action.

"Again on May 20, I wrote to the Chief Secretary on the im-portance of desilting and sought a progress report on work done by the department concerned, timeline, current status, and targeted date of completion... I did not receive any response from the CS on this either... I waited 15 days for his reply and wrote to him again seeking the report but there was no reply...," the Aam Aadmi

On June 5, the Minister al-leged, he received an "absurd" reply from the Chief Secretary. It is important to note that none of these lines mentioned in the report fall under the Municipal Corporation of Delhi.

The CS's note also speaks about the Drainage Master Plan prepared by IIT-Delhi, which was not accepted by the Delhi gov-ernment. "Subsequently, while it was decided on 06.09.2021 to prepare three separate Drainage Master Plans for Najafgarh Basin; Barapullah Basin & Trans-Yamuna Basin, however, no sub-stantive work could take place," the note stated.

It added that consultancy work for the Najafgarh Basin was awarded on June 16, 2023. with a detailed project report expected in February 2025; for the Barapullah and Trans-Yamuna Basin, it had been awarded on May 25 this year and the DPR was expected in April, 2025 "despite delays".

Reacting to the note, the senior government official denied any delay on part of the Delhi government in issuing instructions related to the desilting of drains in Delhi, adding that work in this regard was not only ongoing but progressing

## Classroom construction violations: 24 PWD engineers served notices

New Delhi: The Directorate of Vigilance issued a show-cause notice to 24 PWD officials, including superintendent and executive engineers, for alleged violations in construction of classrooms in Delhi government schools. The notices were issued by Special Secretary (Vigilance) Y V V J Rajasekhar.

In 2015, the Education Department, after observing that student-classroom ratio is verv high, moved a proposal to construct additional classrooms in government schools, the notice revealed. Subsequently, the then Secretary, Education, told the then PWD Secretary to carry out a survey and prepare an estimate.

"The PWD, instead of submitting a single consolidated estimate... submitted 16 preliminary estimates thereby splitting

the project...," the notice said. "... the PWD split the 16 sanctions into 63 tenders, further splitting the project into smaller parts," it added. The AAP, in response, said, ".

## 'Denial of approval to probe Punjab officials, ex-post facto nod show Sisodia's influence'

DELAYIN commencing the trial inthe excise policy case was due to "delaying tactics" adopted by former Deputy Chief Minister Manish Sisodia and other accused, CBI told the Supreme Court. It added that if released on bail, "there are reasons to believe Sisodia, who is "highly influential..., may influence witnesses" and 'tamper or destroy evidence...

In an affidavit filed before the top court on July 27, where Sisodia's bail plea is pending, the central probe agency said, 'Investigation in the case is at the last stage and is likely to be concluded within a short period."

The affidavit said Sisodia "was holding very high and powerful posts in the Aam Aadmi Party as well as Government of NCT of Delhi for the last decade. He was controlling around 18 departments under different ministries in the government. He continues to have great influence over officers/officials who have worked under him during his minister-ship and is highly influential.

The CBI said investigation was conducted into the "role of excise officials of Punjab government, instrumental in closure of distilleries of some manufacturers in Puniab to pressure them to pay 6% commission out of 12% profit margin of their wholesalers in Delhi. One wholesaler, M/s Mahadev Liquors, did not pay the said commission and distilleries of its manufacturers in Punjab were allowed to operate only af-

ter the said wholesaler surrendered its wholesale liquor licence in Delhi in May 2021. However, owing to influence of AAP and its top leadership, including the petitioner, permission to investigate under Section 17-A (of) Prevention of Corruption Act against public servants in Punjab 'was denied"

ing before the court of Justice Neena Bansal Krishna, submitted, "Within one month (of Kejriwal's arrest), we filed a chargesheet. It means our investigation was at such an advanced stage. The amount of evidence that has come in the last month


