बजट में राजकोष व वृद्धि में संतुलन

मुंबई, 19 फरवरी

•कल घरेलू (जीडीपी) के प्रतिशत राजकोषीय घाटे के लक्ष्य के साथ केंद्रीय बजट 2025-26 राजकोषीय मजबूती और वृद्धि के मकसद के बीच संतलन साधने में कामयाब रहा है। भारतीय रिजर्व बैंक के सदस्यों द्वारा लिखी गई एक रिपोर्ट में यह कहा गया है।

फरवरी के लिए रिजर्व बैंक बुलेटिन में यह रिपोर्ट प्रकाशित हुई है। रिपोर्ट के मुताबिक केंद्रीय बजट, राजकोषीय अनुशासन को लेकर सरकार की प्रतिबद्धता को एक बार फिर पुष्ट करता है। साथ ही यह बजट 'विकसित भारत' के दृष्टिकोण के अनुरूप समावेशी, दीर्घकालिक आर्थिक विकास को बढावा देने वाला है।

केंद्रीय बजट में वित्त वर्ष 2025-26 के दौरान सकल राजकोषीय घाटा (जीएफडी), जीडीपी का 4.4 प्रतिशत बनाए रखने का लक्ष्य रखा गया है, जो 2024-25 के संशोधित अनुमान 4.8 प्रतिशत से कम है। इसका मतलब है कि सरकार 2025-26 तक जीएफडी को सकल घरेलू उत्पाद के 4.5 प्रतिशत से नीचे लाने के अपने उद्देश्य पर कायम है।

इसके अलावा 2026-27 और उसके बाद सरकार ने राजकोषीय घाटे के लक्षित अनमान पर बने रहने

का इरादा जताया है, जिससे यह सुनिश्चित होता है कि सार्वजनिक ऋण और जीडीपी का अनुपात मार्च 2031 तक करीब 50 प्रतिशत पर पहंच जाएगा। केंद्रीय बजट में वृद्धि को गति देने. समावेशी विकास सुनिश्चित करने, निजी क्षेत्र के निवेश को बढ़ावा देने, परिवार की भावनाओं को बढ़ावा देने और भारत के बढ़ते मध्यम वर्ग की खर्च करने की क्षमता को बढ़ाने पर ध्यान केंद्रित किया गया है। सकल घरेलू उत्पाद के 12 प्रतिशत

प्रत्यक्ष कर में 1 लाख करोड़ रुपये की कर राहत के बजट प्रस्ताव से घरेल खर्च वाली आमदनी बढ़ने और उपभोग, बचत और निवेश को प्रोत्साहन मिलने की संभावना है।

रिपोर्ट के मुताबिक वित्त वर्ष 2024-25 के संशोधित बजट अनुमान में जीएफडी घटकर जीडीपी का 4.8 प्रतिशत रह गया है, जबिक बजट में जीडीपी का 4.9 प्रतिशत रहने का अनुमान लगाया गया था। राजकोषीय घाटे में 10 आधार अंक की गिरावट कम

पूंजीगत व्यय की वजह से आई है। रिपोर्ट में कहा गया है कि वित्त वर्ष 2025-26 में राजकोषीय घाटा कम करके 4.4 प्रतिशत किए जाने का लक्ष्य हासिल किया जा सकता है। इसके लिए राजस्व व्यय को सकल घरेल उत्पाद के 11.0 प्रतिशत पर सीमित रखने और पुंजीगत व्यय को सकल घरेल उत्पाद के 3.1 प्रतिशत पर बनाए रखने तथा सकल कर राजस्व को

तक बढ़ाने की जरूरत होगी। इसके साथ ही सरकार का कर्ज भी घटकर जीडीपी के 56 प्रतिशत पर आने की संभावना है, जो वित्त वर्ष 2025 के संशोधित अनुमान में 57.1 प्रतिशत था।

रिपोर्ट में कहा गया है, 'सरकार ने संकेत दिया है कि वह राजकोषीय घाटे के स्तर को बनाए रखेगी. जिससे 31 मार्च, 2031 तक केंद्र के ऋण-जीडीपी अनुपात को 50 से 1 प्रतिशत कम या ज्यादा के स्तर पर लाने में मदद मिलेगी।'

कम भेजा गया विदेश में धन

वित्त वर्ष 2025 में अप्रैल-दिसंबर के दौरान भारतीय रिजर्व बैंक की उदारीकृत धनप्रेषण योजना (एलआरएस) के तहत विदेश भेजा गया धन सालाना आधार पर 10.15 प्रतिशत कम हुआ है। सभी क्षेत्रों में

अप्रैल-दिसंबर 2024 के दौरान भारत में शुद्ध प्रत्यक्ष विदेशी निवेश (बाहर भेजे गए धन को निकालकर) घटकर 1.18 अरब डॉलर रह गया है, जो 2023 की समान अवधि में 7.84 अरब डॉलर था। भारत के फर्मों द्वारा विदेश में धन भेजने व निवेश बढ़ाने के कारण ऐसा हुआ है। रिजर्व बैंक के आंकड़ों के मुताबिक अप्रैल-नवंबर 2024 के दौरान सकल प्रत्यक्ष विदेशी निवेश (एफडीआई) की आवक सालाना आधार पर 20.6 प्रतिशत बढ़कर 62.5 अरब डॉलर रही है, जो एक साल पहले 51.8 अरब डॉलर थी।

बीमा कानून में संशोधन लागू करने के लिए समिति

भारतीय बीमा नियामक व विकास प्राधिकरण (इरडाई) ने बीमा अधिनियम 1938 के प्रस्तावित संशोधनों पर विचार और इन्हें लाग् करने के प्रारूप पर सुझाव के लिए सात सदस्यीय समिति गठित की है। इस समिति की अध्यक्षता भारतीय स्टेट बैंक के पूर्व चेयरमैन दिनेश खारा करेंगे।

वित्त मंत्रालय ने बीमा अधिनियम 1938 के विभिन्न उपबंधों में संशोधन का प्रस्ताव दिया है। इसके तहत बीमा क्षेत्र में प्रत्यक्ष विदेशी निवेश (एफडीआई) की सीमा बढ़ाकर 100 फीसदी करना, चुकता पूंजी में कमी और समग्र लाइसेंस सहित अन्य संशोधन प्रस्तावित किए गए हैं। इस समिति के अन्य सदस्यों में आईसीआईसीआई

प्रुडेंशियल लाइफ इंश्योरेंस के पुर्व मख्य कार्याधिकारी (सीईओ) एन. कन्नन, भारतीय रिजर्व बैंक के पर्व कार्यकारी निदेशक सौरभ सिन्हा, युनाइटेड इंडिया इंश्योरेंस के पूर्व चेयरमैन व प्रबंध निदेशक (सीएमडी) गिरीश राधाकृष्णन,

माइक्रो फाइनैंस इंस्टीट्यूट नेटवर्क (एमएफआईएन) के प्रबंध निदेशक व मुख्य कार्याधिकारी आलोक मिश्रा, इरडाई के पूर्व सदस्य राकेश जोशी और कानून विशेषज्ञ एल. विश्वनाथन शामिल हैं। बीमा क्षेत्र में उच्च पदस्थ सूत्रों ने स्पष्ट किया कि समिति कोई नया संशोधन प्रस्तावित नहीं करेगी और इसका दायित्व प्रस्तावित संशोधनों पर कार्य करना है।

सुत्र ने बताया, 'बीमा अधिनियम में एक बार संशोधन होने के बाद 100 फीसदी प्रत्यक्ष विदेशी निवेश, दायरा बढ़ाने, नई कंपनियों के प्रवेश से जुड़े कई संशोधन लागू किए जाएंगे। समिति को नई सीमाएं तय करने का दायित्व सौंपा गया है। समिति यह देखेगी कि इन प्रावधानों को विनियमन और प्रपत्रों के जरिये कैसे लागु किया जा सकेगा।'

सूत्रों के मृताबिक, 'अधिनियम में संशोधन लागू किए जाने से पहले ि नियामक तैयार रहना चाहता है।' बीमा अधिनियम, 1938 व्यापक कानूनी ढांचा मुहैया करवाता है जिसके तहत उद्योग संचालन करता है। यह अधिनियम उद्योग के लिए इरडाई के एक नियामक के तौर पर स्थापित करने का रास्ता प्रशस्त करता है। यह भारत में जीवन, सामान्य और स्वास्थ्य बीमा क्षेत्रों में विभिन्न बीमा पॉलिसियों का ब्योरा देता है।

वित्त मंत्री निर्मला सीतारमण ने केंद्रीय बजट में भारतीय बीमा क्षेत्र में प्रत्यक्ष विदेशी निवेश की सीमा 74 फीसदी से बढ़ाकर 100 फीसदी करने की घोषणा की थी। वित्त मंत्री ने यह भी घोषणा की थी कि केंद्र बीमा क्षेत्र में और संशोधनों के लिए कार्य कर रहा है। वित्तीय सेवा विभाग के सचिव एम. नागराज ने बीते सप्ताह बताया था कि बीमा संशोधन अधिनियम के लिए आंतरिक परामर्श पूरा हो चुका है।
