Dear Shareholders.

I am pleased to present our Annual Report for the financial year 2023-24, a comprehensive reflection of a year characterised by unwavering resilience and steadfast commitment. Despite the tumultuous nature of FY 24, our company stood strong, demonstrating its ability to navigate challenging times.

FY 24 was difficult at the global and domestic level.

Heightened human conflict leading to elevated inflationary conditions spooked consumer confidence worldwide, especially in the advanced markets, namely the US and Europe, which are also large and growing fashion hubs. The plummeted buying sentiment forced leading retailers and their channels to destock aggressively, leading to a drop in business prospects for the domestic textile sectors, which, over time, cascaded to the spinning segment.







Subdued consumer spending in rural markets impacted the textile sector in the domestic market. Moreover, the progressive shift in urban spending from possession to experience lowered the priority for garments. The transition lessened the demand for high-value products.

Nevertheless, our strong foundation established over the years empowered us to confront these adversities with resilience and determination. Through our journey, we have evolved into a dynamic and agile enterprise that responds adeptly to changing market conditions, a testament to our strategic initiatives and forward-thinking approach.

Our unwavering focus on developing value-added products and widening our product basket with newer variants helped us navigate these trying times. This approach protected us from severe financial erosion and highlighted our product strategy's effectiveness.

Further, our investments in the previous year (FY 23) towards modernising our equipment paid rich dividends in enhancing productivity and delivering high-quality products to our customers. Moreover, as the trend reversed in international markets, we witnessed a healthy inflow of orders, improving our financial numbers.

While our topline dropped by 5.97%compared to FY23, the Net Profit dropped by 18.93% over the same period. I am exceedingly happy with these numbers because when larger players in the spinning sector dipped into the negative, we generated a positive bottomline – a heartening

watermark to our robust and resilient operating model.

What lies ahead is indeed promising.

The world has moved on from the fragilities that impeded its progress in 2023. The world economy is now projected to grow by 2.7% in 2024 (against 2.4% forecasted earlier) on the back of the better-than-expected performance of the United States and some improvement in the outlook for several large emerging economies. This is a harbinger of better times for the domestic textile sector, closely dovetailed to the fortunes of the international markets.

Also, the China+1 strategy appears to be regaining momentum after a pause in FY24. This trend is only expected to accelerate over the coming years. This should widen the opportunity window for the Indian spinners. Additionally, there is optimism that the FTA talks with the UK, which began in January 2022, will conclude soon. This should be a game-changer for the domestic textile sector.

The domestic market should regain momentum, while the rural markets are expected to regain normalcy after a normal monsoon. The penetration of e-commerce to Tier 3-5 towns will play an important role in growing the domestic demand for textile products.

Considering the significant relevance of the domestic textile industry, the Government is working overtime to enhance its competitiveness in the global landscape. In the Union Budget, the Finance Ministry has increased the budgetary allocation for the textile ministry to ₹4,417 crore for the financial year 2024–25 from ₹4,389 in the previous year, signalling a strong commitment to growing the sector.

Our plan over the coming years

We have set up a 2.9 MW solar installation, which commenced in April 2024, which should go a long way in optimising our energy costs.

Further, we plan to invest about ₹65 crore in the current and following fiscals to modernise our equipment. The contemporary equipment will significantly upgrade our capability and flexibility to widen our basket of valueadded and niche products.

We will also enhance our efforts in new product development specifically for international markets and intensify our marketing efforts in diverse geographies to strengthen our global presence.

As part of our global strategy, we are working on reducing our carbon footprint, which should enhance our acceptance of global marquee brands. As a first step, we will replace our fossil fuel with agro-based fuel for our boilers by the end of the current year. Further, we will draft our ESG Policy, which should be rolled out in the next 12-24 months.

In closing, I would like to express my sincere appreciation to all our stakeholders for their confidence and support. I am certain that we will script an exciting growth journey ahead. Looking forward to our prosperous future. Thank you.






Proportion of revenue contributed by exports

manufacturing does not require much water, yarn dyeing processes consume significant water. With global concerns over declining water tables, water management and conservation have become critical issues. We have taken proactive steps towards water conservation by implementing wastewater reuse in our dyeing operations, thereby minimising freshwater consumption. Additionally, we have initiated the recovery and reuse of dyeing salts, creating a closed-loop system that enhances sustainability in its dyeing processes.

Water Management: While yarn

Material management: The dyes and chemicals used in yarn and fibre dyeing processes pose environmental hazards. We exclusively utilise dyes and chemicals free from AZO, NPEO, APEO, phenyls, and formaldehyde to mitigate these risks.

Highlights, FY24 **Energy Management**

The Company is making continuous efforts for energy conservation by adopting innovative measures to reduce wastage and optimise consumption. All efforts are made to install energysaving devices wherever required by the Company. Some of the major initiatives are like:

 Installed contemporary spinning equipment, which resulted in considerable power savings.

- Replaced conventional lighting with LED solutions at various places in the operating facility, which helped generate considerable saving
- Installed an economiser in Boiler 18TPH, which helped in significant heat recovery to be used in other manufacturing processes.




















AN OVERVIEW OF THE ECONOMIC **ENVIRONMENT**

Global Economy: In 2023, the global economy surpassed predictions, displaying immense resilience. The global output is expected to have grown by 3.1%. However, escalating geopolitical tensions and the rising occurrence of extreme weather events heightened underlying risks and vulnerabilities.

The world economy showed remarkable strength in taming the elevated and sticky inflation owing to a concerted effort by the Central Banks of most nations to raise interest costs. Additionally, a marked expansion in the supply of goods and services following the aftermath of the pandemic also helped reduce inflationary headwinds.

Global trade dipped 3% to US\$ 31 trillion in 2023. The decline was primarily due to reduced demand in developed economies and a weakened trading environment across East Asia and Latin America. Developing nations endured a more significant impact as their imports and exports dropped by 5% and 7%, respectively, compared to a 4% decrease in imports and a 3% decrease in exports in developed nations.

Global growth is expected to remain at 3.1% in FY24 as the overall economic activity is expected to remain slow. Tightened financial conditions are expected to persist alongside escalating geopolitical tensions



Indian Economy: India's GDP numbers beat expectations with 8.2% growth in FY24 (against the RBI estimate of 7%) as the economy saw a rise in investment spending even as consumption spending stayed tepid.

Significant contributions from sectors such as manufacturing, construction, public administration, defence and other services underpinned the Indian economic growth. Particularly noteworthy is the manufacturing sector, which experienced an impressive growth of 9.9%, bouncing back from a contraction of 2.2% recorded in FY23.

Healthy expansion in manufacturing activity provides a significant impetus to the Government's revenue - GST collection for FY24 rose by 11.7% to reach ₹20.14 lakh crore.

The sluggish consumption is due to spending in urban India having petered down after the post-COVID bump in sales and rural spending being slow due to the unevenness of the monsoon in 2023. With this year's monsoon forecast, there is an expectation that rural spending will resume.


The government's initiatives to tackle retail inflation in FY24 have been successful. Consumer Price Index inflation dropped from 6.7% in FY23 to 5.4% in FY24, which aligned with the upper ceiling of the inflation-targeting framework. Government actions such as reducing petrol, diesel, and LPG prices have further contributed to this achievement in controlling inflation.

India's total exports rose to US\$ 776.68 billion for the fiscal year concluding on

March 31, as per preliminary figures released by the commerce ministry. This achievement is noteworthy, considering the global challenges.

The RBI forecasts a 7% GDP growth for FY25, supported by expectations of a normal monsoon, decreasing inflationary pressures, and sustained growth in the manufacturing and services sectors.

However, amidst these optimistic projections, it's important to acknowledge and address potential risks to the economic landscape. Prolonged geopolitical tensions and escalating disruptions in global trade routes pose significant challenges that could hinder the growth trajectory.









THE SECTORAL SPACE

Global Textile sector: The year 2023 proved to be a considerable strain for the global textile industry as it witnessed a significant drying up of investments. This phenomenon arose from a concerning global trend – a decline in demand for textile products, particularly in the major textile-consuming geographies such as the US and Europe.

Companies worldwide and across all segments faced a "perfect storm" scenario, with high production costs and relatively low demand. This translated into destocking by the global textile trading channel, which resulted in muted order flow for textile players.

Though the luxury segment initially fared well, weaker overall demand also seeped into the luxury sector as the year progressed. While some brands and product categories managed to maintain momentum, others witnessed a significant drop in sales.

The US retail sector is undergoing a big transformation. Recently, major US retailers declared their Q3 financial results, which showed falling sales with increasing profits (owing to reduced markdowns). The US garment imports fell by 22.8% in value terms in September 2023. Hence, retailers preferred to reduce garment imports and worked on minimal stocking. This trend will likely continue for a few quarters until market equilibrium is reached. We expect this to start happening from the last quarter of 2024 and consequently better yarn orders from June 2024 quarter.

Sustainability gaining centre stage:

Experts suggest a surge in demand for sustainable and eco-friendly clothing. Consumers are becoming increasingly aware and concerned about the environmental and social impact of the apparel industry. This awareness is steadily translating into a significant shift in buying habits. There will be a growing demand for transparency throughout the supply chain. Consumers will want to know where their clothes come from, how they are made and the environmental and social footprint of the production process.


This shift in consumer behaviour will push brands to adopt more sustainable practices. Reducing waste, minimising pollution and implementing fair labour practices will no longer be seen as fringe concerns but essential for success. Brands demonstrating a commitment to these values will resonate with the evolving consumer.

In addition, the ever-increasing apparel demand from the fashion industry and the meteoric growth of e-commerce platforms are expected to drive market growth. Digital transformation has redefined the textile market, fostering online retailing platforms and customisation capabilities and allowing consumers to engage directly with brands.

Short-term outlook: McKinsey's fashion forecasts predict that the global industry will grow by 2 to 4% in 2024, varying by region. While luxury brands are expected to rake in the maximum profits again, it's not a foregone conclusion. They may face tough times as luxury growth worldwide is expected to slow down to 3 to 5% from 5 to 7% in 2023. Europe and China will likely witness this slowdown, while the U.S. is expected to perform better than in 2023.

Medium- to long-term outlook: The global textile market size was valued at US\$ 1,840.12 billion in 2023 and is anticipated to reach around US\$ 3,767.92 billion by 2033, growing at a CAGR of 7.43% from 2024 to 2033. The rising demand for natural fibres globally will drive the growth of the textile market.





Indian Textile Sector: FY24 proved to be a difficult one for the Indian textile sector. Exports, an important segment of the overall sectoral performance, declined further in FY 2023-24 to US\$ 34.4 billion. This is a consecutive decline year on year after the boom immediately after COVID-19.

Geo-political issues across the major markets and higher interest rates to regulate inflation were primarily responsible for the drop. The buying by the US and EU has remained quite low, and that too for an unusually long period, which has affected the exports badly.





The other challenges were the fluctuating cotton prices, diminishing demand, capacity under-utilization and dumping of imported fabrics and garments from China and Bangladesh. Additionally, escalated logistic costs due to the Red Sea crisis also played spoilsport, affecting textile exports.

Indian Textile & Apparel exports dwindled approximately 3% from FY23's benchmark of US\$ 35.5 billion. Readymade garments, around 42% of the export basket, declined 10% in 2023-24 to US\$ 14.5 billion.

Within the textile sector, the segment encompassing cotton yarn, fabrics, made-ups, and handloom products witnessed a notable year-on-year increase in exports by \$740 million in 2023-24 over the previous year, attributed to a surge in cotton yarn exports. Also, apparel exports are expected to perform better in the current financial year (FY25) than last year's dismal performance.

Among the export markets, North America topped with US\$ 11 billion, followed by Europe at US\$10 billion, while West Asia and North Africa contributed US\$ 4 billion.

However, green shoots of recovery were visible towards the close of FY24 and in the initial months of FY25, with an increase in orders for the domestic textile players.

Export opportunities: Economic stability in key textile markets should improve the prospects for exports in FY25. The free trade agreements (FTAs) that India has entered into with other nations will hopefully open up more opportunities for textile exports.

The Government, on its part, has approved the continuation of an export

incentive scheme- the Rebate of State and Central Taxes and Levies (RoSCTL) - for apparel, garments, and made-ups up to March 31, 2026. The scheme aims to compensate for the state and central taxes and levies in addition to the rebate provided under the duty drawback scheme on exporting apparel/garments and made-ups.


The government has set an ambitious target to achieve US\$100 billion in export for textile products by 2030.

Domestic market growth: A resilient and steadily growing economy, progressive increase in per capita income and the rapidly growing e-commerce penetration will drive the demand for textile products in India.

Regional brands see the value in going national with careful planning, a deep understanding of the target market, and a commitment to deliver quality products and experiences. In such a scenario, regional textile brands can reach out to a much bigger market in collaboration with national-level brands.

The textile industry has welcomed the relaxation of the mandatory Quality Control Order (QCO) for polyester fibre, filament yarn and spun yarn imported under the advance authorisation scheme. Manufacturers can now import these materials without being restricted to (Bureau of Indian Standards) BIS-licensed suppliers, potentially giving them access to a wider range of options and better prices.

After two years of consolidation, the Indian textile industry has shown positive signs across categories. Textile exports experienced a decline of 17.7% and 2.5% in FY23 and FY24, respectively, due to higher cotton prices, elevated inventory levels, and a slowdown in the US and the EU markets.



The positive news is that the inventory de-stocking phase for global retailers has ended, with positive feedback from major players. This is expected to benefit Indian textile exporters, leading to better growth in FY25.



Indian Spinning Sector: India's spinning mill industry is a significant player in the global textile market. With the second-largest spinning capacity globally, totalling around 48 million spindles, India leads globally and dominates the yarn trade, exporting around 1.2 million tons of yarn, commanding a substantial 30% market share.

Tamil Nadu is a central hub in India's spinning mill sector. Key cities such as Coimbatore, Salem, Tirupur and Erode are pivotal locations for the state's spinning mills.

Performance in FY24: Yarn, the building block for any textile product, faced the heat of the global meltdown in textile demand. The spinners endured suboptimal capacity utilisation, leading to them incurring significant losses. The situation in Tirupur was unprecedented and unwarranted, and in many ways worse than the Covid crisis. However,

towards the end of FY24, the sector saw an improvement in fortunes owing to an uptick in demand. Moreover, higher cotton arrivals resulted in the normalisation of cotton prices, thereby improving spinners' margins.

FY24: Indian cotton prices were lower than global prices, driving higher demand for Indian cotton spinners. Near-optimal capacity utilisation by large players, driven by demand recovery from

Positive trends towards the close of

players, driven by demand recovery from China, supports growth. China's share of India's yarn exports increased to 14% in FY24 from 4% in FY23.

Optimism for FY25: For FY25, the spinning sector appears optimistic as cotton prices are expected to remain stable. This should help boost operating profits, with analysts predicting an increase of 150 to 200 basis points, resulting in margins between 10.5% and 11%.

Indian Cotton Production: Termed as 'White-Gold', cotton is one of India's most important commercial crops. It plays a major role in sustaining the livelihood of an estimated 6 million cotton farmers and 40-50 million people engaged in related activities such as cotton processing & trade.

India is also the 2nd largest consumer of cotton in the world with an estimated consumption of 317 lakh bales (5.39 Million Metric Tonnes, i.e. 22.69% of world cotton consumption of 1397 lakh bales (23.75 Million Metric Tonnes).

Cotton and clothing are among India's leading contributors to net foreign exchange through its exports. India accounts for almost 23% of total global cotton production.

Regarding cotton acreage, 130.61 lakh hectares of India are under cotton cultivation, the highest in the world. Of







this total acreage, 67% is produced in rain-fed areas and 33% on irrigated lands.

According to the Ministry of Textiles, in 2022-2023, India produced 343.47 lakh bales, or 5.84 million metric tons, which was 23.83% of the world's total production. However, the Committee on Cotton Production and Consumption estimated that production for the 2023-2024 season (October 2023 to September 2024) would be lower at 323.11 lakh bales

Bangladesh emerged as the primary importer of Indian cotton yarn, contributing to over 34% of exports in FY24 until January 2024. This shift occurred as China, once the leading importer, witnessed a decline in purchases due to factors such as increased domestic production and a slowdown in its textile industry.

The imposition of customs duty of 11% on import of cotton has been a big impediment in the growth of the cotton based textile industry making indian cotton more expensive than imported cotton.

Government initiatives: In response to these dynamics, the Union textiles ministry is gearing up to launch an upgraded Cotton Technology Mission. The objective is to elevate the quality and yield of India's 'white gold'.

Kasturi Cotton Bharat programme of the Ministry of Textiles is a first-of-its-kind branding, traceability, and certification exercise carried out jointly by the Government of India and other trade and industry bodies.

By adopting best practices, these initiatives aim to position India as a significant hub for textile sourcing and foreign investment. Ultimately, the mission seeks to reduce dependence on imports for this crucial raw material while bolstering the income of India's vast cotton farming community.





ABOUT THE COMPANY

Headquartered in Chandigarh, Winsome Textile Industries Limited (Winsome Textile) is a premier manufacturer specialising in yarns and fabrics for knitting and weaving applications.

Situated in Baddi, the Company's state-of-the-art manufacturing facilities produce a diverse range of high-quality products, including 100% cotton melange yarn, cotton and synthetic blended mélange, speciality and dyed yarns (both carded and combed), tailored for downstream weaving and knitting processes.

The Company's extensive product line encompasses raw white yarns, dyed yarns, fancy yarns, melange yarns, knitted fashion and striper fabrics. Widely recognised for their excellence, the Company's products are trusted by over 250 clients across 50 countries globally.

FINANCIAL PERFORMANCE

The prevailing challenges in the textile sector impacted the Company's financial performance.

Revenue from operations dipped by 6% from ₹876.03 crore in FY23 to ₹823.32 crore in FY24, primarily owing to a drop in sales volumes. EBITDA dropped from ₹92.56 crore in FY23 to ₹87.80 crore in FY24, a fallout of price erosion. Likewise, EBITDA margin increased from 10.57% to 10.66% over the same period. The drop in EBITDA was partly cushioned by the Company's focus on growing the sales of value-added products. Net Profit stood at ₹18.69 crore in FY24 against ₹24.52 crore in FY23. This was a significant positive for the Company, even as its peers reported significant losses for FY24.

Net Cash Flow from operations dropped from ₹93.76 crore in FY23 to ₹75.98 crore in FY24 as increased balance in Trade receivables blocked liquid cash. The Company has deployed an appreciable amount of cash in capital expenditure (equipment modernisation), which should help it improve operations and optimise costs going forward. The Company's Networth stood at ₹275.06 crore as on March 31, 2024 against ₹256.22 crore as on March 31, 2023. Total debt increased from ₹278.10 crore as on March 31, 2023 to ₹286.03 crore as on March 31, 2024. The debt-equity ratio was a comfortable 2.05x as on March 31, 2024.

PERFORMANCE REVIEW/STATE OF AFFAIRS OF THE COMPANY, MODERNISATION AND EXPANSION

A. Yarn Spinning, Dyeing and Fabric

During the year 2023-24, geopolitical situation due to conflicts in middle east and Europe have impacted performance of textile manufacturing companies around the globe. During the year under review your company turnover decreased by 5.99% to ₹82576.39 Lacs against ₹87839.77 Lacs as compared to previous year. PAT has decreased in 2023-24 at ₹1868.51 Lacs as







against ₹2451.79 Lacs achieved during year 2022-23. Export sales during the year was up by 8.09% at ₹43198.34 Lacs against ₹39963.88 Lacs during 2022-23.

During the year under review the company has completed its modernization/upgradation and expansion project with total cost ₹5395 Lacs out of which ₹3884 Lacs was funded by banks and balance cost was met by internal accruals with completion of above project. Overall efficiency and utilization of spinning has improved and would result in higher production with improved quality for current as well as subsequent years.

As envisaged in project, capacity of dye house has also improved from 30 MT per day to 31.5 MT per day. With the completion of waste water recovery plant your company is recovering around 600 kilo liters of waste water per day and using it again in process.

Continuing its efforts on sustainability and environment protection your company executed project of solar power roof top plant in one of its units located in Kaundi, near Baddi with a capacity of 2.89 MW with cost of 983 Lacs. The project was funded by banks to the limit of ₹620 Lacs and balance cost was met by internal accruals. This project is expected to generate approx. 39 Lacs units annually and would result in substantial saving on power bills of unit at Kaundi, near Baddi.

Company has formed ZDHC platform as signatory last year and have embraced "Supplier to Zero Programme (STZ)" and have successfully reached "Progressive Level". This reflects our ongoing commitment to sustainability and company's dedication to reducing our environmental impact across the supply chain.

B. Hydro Power Project

During the year 2023-2024, 3.5 MW hydropower project of the company at Dharamshala, Distt. Kangra, Manuni Khad (H.P.) has generated 12.87% higher units at 123.09 Lac units as compared to 109.05 Lac units during 2022-23. The increase in units were primarily due to enhanced rains in catchment

area and entire generated units were captively consumed at our plant at Baddi.

ACCOLADES AND RECOGNITIONS

We are very pleased to inform you that our company has been awarded the "Silver" award for exports of "Processed yarns" from India for the F.Y. 2021-2022 and 2022-2023 in Category-Ill (Above ₹250 Crores) by The Cotton Textile Export Promotion Council (TEXPROCIL). Now overall in India Winsome is at No.2 in exports of processed yarns.

SHARE CAPITAL

The Authorized Share Capital of the Company is ₹25,00,00,000/- (Rupees Twenty Five Crores) divided into 2,50,00,000 (Two Crore Fifty Lac) Equity Shares of ₹10/- each.

The paid up Equity Share Capital as at March 31, 2024 was ₹19,82,00,000/- (comprised of 1,98,20,000 equity shares of ₹10/- each). During the year under review, the Company has neither issued any shares nor granted stock options or sweat equity, preference shares and also not made any provision for purchase of its own shares by employees or by trustees.

PARTICULARS OF LOANS, GUARANTEES OR INVESTMENTS

The Company has not given any loan or provided any security/guarantee as per section 186 of the Companies Act, 2013 during the year 2023-24. The Investments under section 186 of the Act are given in the Financial Statements forming part of the Annual Report.

PUBLIC DEPOSITS

The Company has not accepted /renewed any deposits from the public during the FY 2023-24.

DIVIDEND & RESERVES

Keeping in view to conserve resources, your Directors have not recommend any dividend for the FY 2023-24.



During the year under review no unclaimed and unpaid dividend was pending for transfer to IEPF Authority. Although, the unclaimed dividend and shares already transferred to the IEPF Authority by the Company in the previous years can be claimed by the concerned shareholders by approaching the Investor Education and Protection Fund Authority.

There was no change in the Directors and Key Managerial Personnel during the year.

ANNUAL EVALUATION OF BOARD AND ITS COMMITTEES AND OF INDIVIDUAL DIRECTORS.

As per Companies Act 2013 and Listing Regulations, Board has adopted formal mechanism for evaluating its performance and as well as that of its committees, individual Directors, including the Chairman of the Board in compliance of Companies Act 2013 and Listing Regulations. The exercise was carried out through a structured evaluation process covering various aspects of the Boards functioning such as composition of the Board, its committee & members, their experience & competencies, performance of specific duties & obligations, governance. Broadly the performance of Non-Independent/Executive/Whole Time Director(s) was evaluated on the basis of their own performance, expertise, intelligence, their qualitative & quantitative contribution achievements, towards operational organizational performance etc. The performance of Non-Executive Independent Directors were evaluated on the basis of their constructive participation's in Board/Committee/General meetings, their informed & balanced decision-making, ability to monitor financial controls, systems & certain allied parameters. The annual performance evaluation of various Board Committees constituted under Companies Act & Listing Regulations was made on the basis of their respective terms of reference, discharge of functions, governance etc.

The separate Meeting of independent Directors was held on 12th February, 2024 to review the performance of Non-Independent directors including the Chairman and the Board as a whole as per Code of Independent Directors under Companies Act 2013 and Listing Regulations. The Independent Directors also reviewed the quality, content and

timeliness of follow of information between Management and the Board.

REMUNERATION POLICY

The Board has on the recommendation of the Nomination and Remuneration Committee, framed a policy for selection and appointment of Directors, Key Managerial Personnel, Senior Management and their Remuneration. Further the Company has made and maintained proper cost records as specified by the central government under sub-section (1) of section 148 of the Companies Act, 2013 for its business activities carried out during the year.

Furthermore, the Board has re-appointed M/s K.K. Sinha & Associates, Cost Accountants as Cost Auditors of the





Company for the financial year 2024-25 on a remuneration of ₹75,000/- (Rupees Seventy Five Thousand Only) same as in the previous year subject to the approval of Shareholders. The Company has received written confirmation(s) from M/s K.K. Sinha & Associates, Cost Accountants, to the effect that their re-appointment, if made, would be in accordance of provisions of section 148 of Companies Act 2013 and that they are not disqualified for such appointment within the meaning of section 141 of Companies Act, 2013 read with Companies (Audit & Auditors) Rules 2014.

Annexure I

Nomination and Remuneration Policy of Winsome Textile Industries Limited

1. Introduction

This policy on nomination and remuneration of Directors, Key Managerial Personnel and Senior Management has been formulated by the Nomination and Remuneration Committee to align the objectives and goals of the Company with the requirements of the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended from time-to-time) ('Listing Regulations').

2. Key Objectives of Policy

The Policy is formulated in compliance with Section 178 of the Companies Act, 2013 read with the applicable rules thereto and as per SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended time to time. The primary objective of this Policy is to provide a framework and set standards for the nomination and remuneration of the Directors, Key Managerial Personnel and officials comprising the senior management. The Company aims to achieve a balance of merit, experience and functional skills amongst its Directors, Key Managerial Personnel and Senior Management and to remunerate them appropriately.

3. Applicability

This policy is applicable to:

- Directors viz. Executive Directors, Non-executive Director, Whole Time Director, Managing Director and Independent Director
- 2. Key Managerial Personnel
- 3. Senior Management Personnel
- 4. Other Employees of the Company

4. Definitions

- i "Act" means Companies Act, 2013 and rules thereunder, as amended time to time.
- ii "Board of Directors" or 'Board', in relation to the Company, means the collective body of the directors of the Company including the Chairperson/Chairman of the Company.
- iii **"Company"** means Winsome Textile Industries Limited
- iv **"Committee"** means Nomination and Remuneration Committee of the Company as

- constituted or reconstituted by the Board, in accordance with the provisions of Section 178 of Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended time to time.
- v **"Compliance Officer"** means the Company Secretary and any officer of the Company
- vi "Director" means a Director appointed to the Board of a Company.
- vii "Executive Director" means the Managing Director, Whole-time Director, as the case may be and includes Directors who are in the full time employment of the Company.
- viii "Independent Director" means a Director referred under provisions of Section 149 of the Companies Act, 2013 and rules thereunder and as provided under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended time to time.
- ix **"Key Managerial Personnel"** mean key managerial personnel as defined under the Companies Act, 2013 & rules made thereunder, including any amendment or modification thereof, and includes
 - Managing Director, or Chief Executive Officer or manager and in their absence, a whole time director;
 - ii. Company Secretary
 - iii. Chief Financial Officer and
 - iv. Such other officer as may be prescribed.
- "Senior Management" means personnel of the Company who are members of its core management team excluding Board of Directors. This would include all members of management one level below the executive directors, including all the functional heads.
- xi **"Remuneration"** means any money or its equivalent given or passed to any person for services rendered by him and includes perquisites as defined under the Income-tax Act, 1961.
- xii "Policy or This Policy" means "Nomination and Remuneration Policy."





xiii "Interpretation" The terms, words & expressions, that have not been defined in this Policy shall have the same meaning respectively assigned to them in the Companies Act, 2013, rules made thereunder, SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended from time to time.

Major Functions of Nomination and Remuneration Committee

The Board is ultimately responsible for the appointment of Directors and Key Managerial Personnel. The Board has delegated responsibility for assessing and selecting the candidates for the role of Directors, Key Managerial Personnel and the Senior Management of the Company to the Nomination and Remuneration Committee which shall make recommendations & nominations to the Board. In this regard, the said Committee, apart from other functions as assigned/delegated to it, shall look after the following functions:

- To identify persons who are qualified to become directors and who may be appointed in senior management in accordance with the criteria laid down, recommend to the Board their appointment and removal.
- To formulate the criteria for determining qualifications, positive attributes and independence of a director and recommend to the Board a policy, relating to the remuneration for the directors, key managerial personnel and other employees.
- To carry out/to perform such other function as may be necessary or appropriate or as may be assigned/ delegated/mandated to it by the Board from time to time and/ or enforced by any Statutory notification, Amendment or Modification, as may be applicable.

The aforesaid Policy shall ensure that:

- (a) the level and composition of remuneration is reasonable and sufficient to attract, retain and motivate directors of the quality required to run the company successfully;
- (b) relationship of remuneration to performance is clear and meets appropriate performance benchmarks;
- (c) remuneration to directors, key managerial personnel and senior management involves a

balance between fixed and incentive pay reflecting short and long-term performance objectives appropriate to the working of the company and its goals.

6. APPOINTMENT AND REMOVAL OF DIRECTOR'S, KMP'S AND SENIOR MANAGEMENT PERSONNEL

- (1) Appointment criteria and qualifications:
 - A The Committee shall identify and ascertain the suitable person(s) and recommend to the Board his/her appointment/re-appointment for appointment as Director(s), KMP(s) or at Senior Management level.
 - B A person should possess adequate qualifications, expertise and experience for the position he/she is considered for appointment/re-appointment. The appointee may be assessed by the committee against a range of criteria which include but not limited to integrity, qualification, expertise, industry experience, inter-personal skill, and such other appropriate qualities of the person(s), as may be required, to handle/perform successfully the position so chosen with due regard for the benefits from diversifying the Board.

The Committee/Board has discretion to decide whether the qualification, knowledge, expertise, functional skill and experience etc. possessed by a person are sufficient / satisfactory for the concerned position.

- C The Company shall appoint or re-appoint the Director/Managing Director/Whole-time Director/Manager in accordance with the provisions, rules and regulations as framed under the Companies Act 2013, rules made thereunder and under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended time to time.
- D Appointment of Independent Director is subject to the compliance of provisions of section 149 of the Companies Act, 2013, read with schedule IV and rules made thereunder, and under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended time to time.



(2) Term/Tenure:

- (i) Managing Director/Whole-time Director/ Manager (Managerial Person):
 - The Company shall appoint or re-appoint any person as its Managerial Person for a term not exceeding five years at a time. No re-appointment shall be made earlier than one year before the expiry of term.

(ii) Independent Director:

An Independent Director shall hold office for a term up to five consecutive years on the Board of the Company and shall be eligible for reappointment on passing of a special resolution by the Company and disclosure of such appointment in the Board's report.

No Independent Director shall hold office for more than two consecutive terms, but such Independent Director shall be eligible for appointment after expiry of three years of ceasing to become an Independent Director. Provided that an Independent Director shall not, during the said period of three years, be appointed in or be associated with the Company in any other capacity, either directly or indirectly.

No Independent Director of the Company shall hold office after completion of the age of seventy five years unless his appointment/ continuation have been approved through a special resolution by the shareholders of the Company.

The term/ tenure of Independent Directors and reckoning of the limit of Companies, in which a person can appointed as Director, Independent Director, Managerial Person, as the case may be, shall be fixed or determined as per the provisions of Companies Act 2013, rules made thereunder and as per SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended time to time.

(3) Letter of Appointment

Each Independent Director/KMP's/Senior Management Personnel, as the case may be, is required to sign the Letter of appointment with the Company containing the terms & conditions of his/her appointment/re-appointment and the role/profile assigned in the Company.

(4) Removal

Due to reasons for any disqualification(s) mentioned in the Companies Act, 2013, rules made thereunder, under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 or under any other laws, rules & regulations, the Committee may recommend to the Board with reasons recorded in writing, for removal of Director and for removal/termination/suspension/dismissal of KMP's or Senior Management Personnel subject to the compliance of applicable Acts, Rules & Regulations, if any.

Although for removal//termination/suspension/dismissal of KMP's or any other Senior Management Personnel of the Company, the Committee may, if so required, refer the HR Policy of the Company.

(5) Retirement

The Director, KMP's and Senior Management Personnel shall retire as per the applicable provisions of the Companies Act, 2013 and as per the prevailing HR policy of the Company, as amended time to time. The Board shall have the discretion to retain the Director, KMP's, Personnel of Senior Management in the same position/ role, remuneration or otherwise, even after attaining the retirement age, in the bonafide interest and for the benefit of the Company, if so required.

7. PROVISIONS RELATING TO REMUNERATION OF DIRECTORS, KMP's, SENIOR MANAGEMENT PERSONNEL AND OTHER EMPLOYEES

The Guiding Principle is that the level and composition of remuneration shall be reasonable & sufficient so as to attract, retain, motivate Directors, Key Managerial Personnel's, Senior Management Personnel & other employees. The Directors, Key Managerial Personnel's, Senior Management Personnel & other employee's salary shall be based & shall be determined on the basis of individual person's qualifications, profile, related experience, responsibilities, role in the organization and his/her performance and in accordance with the limits as prescribed Statutorily, if any.

Further, the Nomination & Remuneration Committee while determining the individual remuneration packages/structure for Directors, KMP's, Senior Management Personnel and for other employees of the Company shall consider all relevant factors including but not limited to Company's HR Policy,





market survey, business performance & prevailing practice in comparable companies, benchmarks fixed for same grade of employees, particular industry growth, prevailing laws, government guidelines and also having due regard to financial health/profitability of the Company,

7A General Provisions:

- i The remuneration/compensation/commission etc. to Directors, KMP's, Senior Management Personnel shall be determined by the Committee and recommended to the Board for approval. The remuneration of Senior Management Personnel shall be as per remuneration policy as amended from time to time.
- ii The remuneration / compensation / commission etc. to be paid to Directors, shall be as per the Statutory provisions of Companies Act, 2013, and rules made thereunder for the time being in force and shall be subject to the approval of shareholders of the Company, as required by the law for the time being in force.
- behalf of its Managing Director, Whole-time Director, Manager, Directors, Chief Executive Officer, Chief Financial Officer or Company Secretary for indemnifying any of them against any liability in respect of any negligence, default, misfeasance, breach of duty or breach of trust for which they may be guilty in relation to the Company, the premium paid on such insurance shall not be treated as part of the remuneration payable to any such personnel.
- 7B Specific Provisions regarding remuneration to Directors, KMP's, Senior Management Personnel and Other Employees:

(1) Fixed Pay/ Base Compensation

i Directors, KMP's and Senior Management Personnel shall be eligible for a monthly remuneration as may be approved by the Board on the recommendation of Committee in accordance with the provisions of Companies Act, 2013, and the rules made thereunder for the time being in force. The basic pay, break-up of remuneration structure, quantum of perquisites, perks, allowances & certain

other statutory/non statutory benefits etc. shall be decided and approved by the Board on the recommendation of the Committee and shall be approved by the shareholders and Central Government, wherever required/applicable.

iii Increments to the existing remuneration structure if any shall be approved by the Committee for KMP's and Senior Management Personnel and for other employees of the Company. However increments to the Whole Time Director, Managing Director, Executive Director or Manager (as the case may be) shall be within the limits/slabs as approved by the Shareholders in their general meeting & shall be paid in accordance with their respective terms and conditions of appointment/ re-appointment.

The increments shall be effective from 1st April in respect of Whole-time Director, Managing Director, Executive Director (as the case may be) as well as in respect of other employees of the Company, unless otherwise decided.

iii The Committee may refer Company's HR Policy, if so required, in respect of aforesaid matters.

(2) Minimum Remuneration

If, in any financial year, the Company has no profits or its profits are inadequate, the Company shall pay remuneration to its Managing Director, Whole Time Director or Manager in accordance with the provisions of Schedule V of the Companies Act, 2013 & rules made thereunder, as amended from time to time, subject to the required approval(s).

(3) Provisions for excess remuneration

If Managing Director, Whole Time Director or Manager draws or receives, directly or indirectly by way of remuneration any such sums in excess of the limits prescribed under the Companies Act, 2013 & rules made thereunder, as amended from time to time, subject to the approval of shareholders,



wherever required, he/she shall refund such sums to the Company and until such sum is refunded, hold it in trust for and on behalf of the Company.

7C Remuneration to Non-Executive / Independent Directors

i Remuneration / Commission

The remuneration / commission shall be in accordance with the Statutory Provisions of the Companies Act, 2013, and the rules made thereunder and as per SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended time to time for the time being in force.

ii Sitting Fees

The Non- Executive / Independent Directors may receive remuneration by way of fees for attending meetings of Board or Committee thereof, provided that the amount of such fees shall not exceed the maximum amount as provided in the Companies Act, 2013, per meeting of the Board or Committee

or such amount as may be prescribed by the Central Government from time to time.

Further the boarding, lodging, traveling expenses & out of pocket expenses, if any shall be reimbursed to the Non- Executive/ Independent Directors on actual basis, residing out of Chandigarh.

iii Stock Options

Pursuant to the provisions of the Companies Act, 2013 & rules made thereunder, an Independent Director shall not be entitled to any stock option of the Company.

8. Review and Amendment

The Nomination and Remuneration Committee shall periodically review the Nomination and Remuneration Policy. The Board of Directors after considering the recommendations of Nomination and Remuneration Committee is empowered to amend this policy either in whole or in part, at any time consistent with requirements of applicable laws, rules and regulations.

The Company has established procedures and systems to be fully compliant with the requirements stipulated by the Securities and Exchange Board of India under the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 ["SEBI (LODR) Regulations"]. in the securities, on the Company/some of its Directors. How-ever, the company had filed an appeal (No: No: 348/2022) before the Securities Appellant Tribunal challenging the said orders of SEBI. The penalties imposed by SEBI has been partially overruled by SAT. The Company/effected directors have since paid the penalties ordered by SAT. However the period of restriction in dealing in the securities by the company and some of its directors was also reduced by SAT up to the period of its orders. The matter now stands settled. Further Mr. Ashish Bagrodia, as Ex-Director of Winsome Yarns Limited had also filed an appeal with Securities Appellant Tribunal challenging the SEBI order in the matter of M/s Winsome Yarns Limited, which has been since been dismissed vide SAT order dated 25/04/2023. The penalty imposed by SEBI in this regard has also since been paid. The matter now stands settled.



Report on the Audit of Financial Statements

Opinion

We have audited the accompanying financial statements of **M/s Winsome Textile Industries Limited** ('the Company'), which comprise the Balance Sheet as at 31 March 2024, the Statement of Profit and Loss (including Other Comprehensive Income), Statement of Changes in Equity and Statement of Cash Flow for the year on that date, and Notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ('Act') in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India including Indian Accounting Standards ('Ind AS') specified under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, of the state of affairs (financial position) of the Company as at March 31, 2024, and its Profit (financial performance including other comprehensive income), its cash flows and the changes in equity for the year ended on that date.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing ("SA"s) specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued

by the Institute of Chartered Accountants of India ('ICAI') together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. For each matter below, our description of how our audit addressed the matter is provided in that context.

We have determined the matters described below to be the key audit matters to be communicated in our report. We have fulfilled the responsibilities described in the Auditor's responsibilities for the audit of the Ind AS financial statements section of our report, including in relation to these matters. Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risks of material misstatement of the Ind AS financial statements. The results of our audit procedures, including the procedures performed to address the matters below, provide the basis for our audit opinion on the accompanying Ind AS financial statements.



Inventories (refer note 4.1 to the financial statements)

Key Audit Matter

Inventories held by the Company comprising of Raw Material, Work-in-Progress, Finished Goods and Others represents 37.44% of the Company's total assets.

Under Ind AS, the Company is required to measure inventory at lower of Cost or Net Realizable Value (NRV). However, the raw material and work-in progress is not written down below cost when finished goods are expected to be sold at or above cost.

Assessing NRV

Net realisable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and the estimated costs necessary to make the sale.

The assessment and application of write-down of inventory to NRV are subject to significant judgement by Company.

Considering the company's present situation, significant judgements made by the company in light of future market & economic conditions for determination of NRV and considering materiality in context of total assets of the Company, we have considered the valuation of inventory to be the key audit matter.

How the matter was addressed in our audit

Our audit procedures included:

- Through discussions with management, we understood the Company's basis of estimated selling price for the goods;
- Evaluating the design & testing controls related to Company's review of key estimates, including estimated future selling prices and estimated cost of completion for work-in-progress inventory.

Information other than the Financial Statements and Auditor's Report thereon

The Company's Board of Directors is responsible for the other information. The other information comprises the information included in the Annual Report, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information we are required to report that fact. We have nothing to report in this regard.

Responsibilities of Management and Those charged with Governance for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act with respect to the preparation of these financial statements that give a true and fair view of the state of affairs (financial position), profit or loss (financial performance including other comprehensive income), changes in equity and cash flows of the Company in accordance with the accounting principles generally accepted in India including the Ind AS specified under section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate implementation and maintenance of accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of



adequate internal financial controls that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

1. CORPORATE INFORMATION

Winsome Textile Industries Limited ("the Company") is a public limited company domiciled and incorporated under the provisions of the Companies Act, 1956 on 18th September, 1980 in India and its shares are publicly traded on the Bombay Stock Exchange ("BSE"), India. The Registered Office of the company is situated at 1 Industrial Area, Baddi, Solan, Himachal Pradesh – 173205 India and the Corporate office is situated at SCO # 191 - 192, Sector # 34-A, Chandigarh, 160022.

The principal business activity of the company is manufacturing of Cotton Yarn, Cotton Melange, Cotton Blended Dyed Yarn/Fibre, Yarn made of natural and manmade fibre and other fibres, Knitted Fabric and Power generation in Textile Sector.

The financial statements were authorised for issue in accordance with a resolution passed by the Board of Directors on 17th May, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of preparation of financial Statements

The financial statements of the Company have been prepared on accrual basis in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 and the provisions of the Companies Act, 2013.

These financial statements for the year ended 31st March 2024 have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 and the provisions of the Companies Act, 2013.

The financial statements have been prepared on a historical cost basis, except for certain financial assets and liabilities which have been measured at fair value (refer accounting policy regarding financial instruments).

The financial statements are presented in Indian Rupees ("INR" or "Rs.") and all amounts are rounded to the nearest Lacs, except as stated otherwise.

2.2 Estimates and Judgements

The preparation of the financial statements in conformity with Ind AS requires management to make estimates, judgments and assumptions. These estimates, judgments and assumptions effect the application of

accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the period. Application of accounting policies that require critical accounting estimates involving complex and subjective judgments and the use of assumptions in these financial statements have been disclosed in note 2.23. Accounting estimates could change from period to period. Actual results may differ from those estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

2.3 Current versus non-current classification

The Company presents assets and liabilities in the balance sheet based on current/ non-current classification.

An asset is treated as current when it is:

- Expected to be realised or intended to be sold or consumed in normal operating cycle
- o Held primarily for the purpose of trading
- Expected to be realised within twelve months after the reporting period, or
- Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period

All other assets are classified as non-current.

A liability is current when:

- o It is expected to be settled in normal operating cycle
- o It is held primarily for the purpose of trading
- o It is due to be settled within twelve months after the reporting period, or
- o There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period

All other liabilities are classified as non-current.

Deferred tax assets and liabilities are classified as noncurrent assets and liabilities.

2.4 Property, Plant and Equipment

The Company had applied one-time transition exemption of considering the carrying cost on the transition date i.e. 1st April, 2016 as the deemed

cost under IND AS and hence regarded thereafter as historical cost.

Leased hold Land is carried at cost less reduction in proportionate annual Lease Rental.

Freehold land and Capital Work in progress is carried at cost. All other items of Property, plant and equipment are stated at cost, less accumulated depreciation. The Cost of an item of Property, Plant and Equipment comprises of:

- (a) its purchase price including freight, duties, and non-refundable purchase taxes after deducting trade discounts and rebates;
- (b) any attributable expenditure directly attributable for bringing an asset to the location and the working condition for its intended use; and
- (c) the initial estimate of the costs of dismantling and removing the item and restoring the site on which it is located, the obligation for which the company incurs either when the item is acquired or as a consequence of having used the item during a particular period for purposes other than to produce inventories during that period.

Depreciation on property, plant and equipment is calculated using the straight-line method to allocate their cost, net of their residual values, over their estimated useful lives. Depreciation on addition/sale is provided on Pro-rata basis with reference to the month of addition/sale. The useful lives estimated for the major classes of property, plant and equipment are as follows:

The useful lives have been determined based on technical evaluation done by the management's experts, which in few cases are different than the lives as specified by Schedule II to the Companies Act, 2013. The residual values are not more than 5% of the original cost

of the asset except in case of plant & machinery where the residual values are not more than 10% of the original cost of the asset. The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Advances paid towards the acquisition of property, plant and equipment outstanding at each balance sheet date is classified as capital advances under other non-current assets and the cost of assets not put to use before such date are disclosed under 'Capital work-in-progress'.

Subsequent expenditures relating to property, plant and equipment is capitalized only when it is probable that future economic benefits associated with these will flow to the Company and the cost of the item can be measured reliably. Repairs and maintenance costs are recognized in net profit in the statement of profit and loss when incurred. The cost and related accumulated depreciation are eliminated from the financial statements upon sale or retirement of the asset and the resultant gains or losses are recognized in the statement of profit and loss. Assets to be disposed off are reported at the lower of the carrying value or the fair value less cost to sell.

2.5 Intangible Assets

Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment loss.

On transition to Ind AS, the company had elected to continue with the carrying value of all its intangible assets recognised as at 1st April 2016 measured as per the previous GAAP and use that carrying value as the deemed cost of intangible assets.

The useful lives of intangible assets are assessed as either finite or indefinite.

Intangible assets with finite lives are amortised on a straight-line method over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset are reviewed at least at the end of each reporting period and adjusted, if appropriate. The useful economic lives estimated for various classes of intangible assets are as follows:

Intangible assets with indefinite useful lives are not amortised, but are tested for impairment annually.

2.6 Inventories

Inventories are valued at cost or net realizable value, whichever is lower except waste which is valued at net realisable value. The cost in respect of the various items of inventory is computed as under:

Raw Materials - At weighted average cost plus direct expenses. The cost includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition. However, materials and other items held for use in the production of inventories are not written down below cost if the finished product in which they will be incorporated are expected to be sold at or above cost.

Stores and Spares - At weighted average cost plus direct expenses. The cost includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition.

Work-in-Progress - At raw material cost plus conversion costs depending upon the stage of completion and other related overhead costs.

Finished Goods - At raw material cost plus conversion costs, packing cost and other overheads incurred to bring the goods to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and the estimated costs necessary to make the sale.

2.7 Cash and cash equivalents

Cash and cash equivalents in the balance sheet comprise cash at banks and on hand and short-term deposits with a maturity period of twelve months or less from the balance sheet date, which are subject to an insignificant risk of changes in value and is freely available for the company. Bank overdrafts are shown under borrowings in the balance sheet.

Earmarked bank balances and/or short-term deposits which are lien marked against borrowings are shown under the head "Bank balances other than Cash and Cash Equivalent".

2.8 Financial instruments

A. Financial Instruments - Initial recognition and measurement

Financial assets and financial liabilities are recognised in the company's statement of financial position when the company becomes a party to the contractual provisions of the instrument. The company determines the classification of its financial assets and liabilities at initial recognition. All financial assets are recognised initially at fair value plus, in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset. Transaction costs of financial assets and liabilities carried at fair value through the Profit and Loss are immediately recognized in the Statement of Profit and Loss.

B.1. Financial assets –Subsequent measurement

The Subsequent measurement of financial assets depends on their classification which is as follows:

a. Financial assets at fair value through profit or loss

Financial assets at fair value through profit and loss include financial assets held for sale in the near term and those designated upon initial recognition at fair value through profit or loss.

b. Financial assets measured at amortised cost Loans and receivables are non derivative financial assets with fixed or determinable payments that are not quoted in an active market. Trade receivables do not carry any interest and are stated at their nominal value as reduced by appropriate allowance for estimated irrecoverable amounts based on the ageing of the receivables balance and historical experience. Additionally, a large number of minor receivables are grouped into homogenous groups and assessed for impairment collectively. Individual trade receivables are written off when management deems them not to be collectible.

Financial assets at fair value through OCI
 All equity investments, except investments in subsidiaries, joint ventures and associates, falling within the scope of Ind AS 109,

are measured at fair value through Other Comprehensive Income (OCI). The company makes an irrevocable election on an instrument-by-instrument basis to present in other comprehensive income subsequent changes in the fair value. The classification is made on initial recognition and is irrevocable.

If the company decides to designate an equity instrument at fair value through OCI, then all fair value changes on the instrument, excluding dividends, are recognized in the OCI.

B.2. Financial assets – De-recognition

The company derecognises a financial asset when the contractual rights to the cash flows from the assets expire or it transfers the financial asset and substantially all the risks and rewards of ownership of the asset.

Upon de-recognition of equity instruments designated at fair value through OCI, the associated fair value changes of that equity instrument are transferred from OCI to Retained Earnings.

C.1. Financial liabilities – Subsequent measurement

The Subsequent measurement of financial liabilities depends on their classification which is as follows:

a. Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading, if any.

b. Financial liabilities measured at amortised cost

Interest bearing loans and borrowings of the company are subsequently measured at amortised cost using the effective interest rate method (EIR). Amortised cost is calculated by taking into account any discount or premium on acquisition and fee or costs that are integral part of the EIR. The EIR amortised is included in finance costs in the statement of profit and loss.

C.2. Financial liabilities – De-recognition

A financial liability is derecognised when the obligation under the liability is discharged or expires.

D. Offsetting financial instruments

Financial assets and financial liabilities are offset and the net amount reported in the statement of financial position, if and only if, there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

E. Derivative financial instruments

The Company holds derivative financial instruments such as foreign exchange forward and option contracts to mitigate the risk of changes in exchange rates on foreign currency exposures. The counterparty for these contracts is generally a bank. Although the Company believes that these derivatives constitute hedges from an economic perspective, they may not qualify for hedge accounting under Ind AS 109, Financial Instruments. Any derivative that is either not designated a hedge, or is so designated but is ineffective as per Ind AS 109, is categorized as a financial asset or financial liability, at fair value through profit or loss. Derivatives not designated as hedges are recognized initially at fair value and attributable transaction costs are recognized in net profit in the statement of profit and loss when incurred. Subsequent to initial recognition, these derivatives are measured at fair value through profit or loss and the resulting exchange gains or losses are included in Exchange Rate Variation Gain. Assets/ liabilities in this category are presented as current assets/current liabilities if they are either held for trading or are expected to be realized within 12 months after the balance sheet date.

F. Fair value measurement

The company measures certain financial instruments at fair value at each reporting date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on presumption that the transaction to sell the asset or transfer the liability takes place either:

- in the principal market for the assets or liability or
- in the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible to the company.

The company uses valuation technique that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

2.9 Government Grants

The government grants are recognized only when there is reasonable assurance that the conditions attached to them shall be complied with, and the grants will be received. Government grants related to assets are treated as deferred income and are recognized in the statement of profit and loss on a systematic and rational basis over the useful life of the asset.

Government grants related to revenue are recognized on a systematic basis in the statement of profit and loss over the periods necessary to match them with the related costs which they are intended to compensate.

2.10 Non-current assets held for sale

Non-current assets are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use and a sale is considered highly probable. They are measured at the lower of their carrying amount and fair value less costs to sell.

Non-current assets classified as held for sale and their related liabilities are presented separately in the balance sheet. Non-current assets are not depreciated or amortised while they are classified as held for sale.

2.11 Provisions, Contingent Liabilities and Contingent Assets

A provision shall be recognised when:

- (a) an entity has a present obligation as a result of a past event;
- (b) it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation; and
- (c) a reliable estimate can be made of the amount of the obligation.

If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the

provision due to the passage of time is recognised as a finance cost.

A Contingent liability is not recognised but disclosed in the notes to the accounts, unless the probability of an outflow of resources is remote.

A contingent asset is generally neither recognised nor disclosed.

2.12 Revenue Recognition

Effective April 1, 2018, the company adopted Ind AS 115, "Revenue from contracts with customers". The effect of adoption of Ind AS 115 was insignificant. The following is a summary of significant accounting policies related to revenue recognition.

Revenue is recognised upon transfer of control of promised product or services to customer in an amount that reflects the consideration the company expects to receive in exchange for those product or service, regardless of when the payment is received. Revenue is measured at the Transaction price, excluding amounts collected on behalf of the third parties. The amount disclosed as revenue is net of returns, trade discounts, volume rebates, Goods and Services Tax. The company recognizes revenue when the amount of revenue can be measured reliably and it is probable that the economic benefits associated with the transaction will flow to the entity.

The specific recognition criteria for the various types of the company's activities are described below:

(i) Sales of goods

Revenue from sale of goods is recognised at the point in time when control of the goods are transferred to the customers, the customer has full discretion over the channel and price to sell the products, there is no unfulfilled obligation that could affect the customer's acceptance of the products and the company retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold. The said conditions are generally fulfilled upon delivery of goods to the customers.

Delivery occurs when the goods have been shipped to the specific location, the risks and rewards of obsolescence and loss have been transferred

to the customer, and either the customer has accepted the goods in accordance with the sale contract, the acceptance provisions have lapsed, or the company has objective evidence that all criteria for acceptance have been satisfied.

(ii) Services

Revenue from sale of services is recognised on the basis of the stage of completion. When the contract outcome cannot be measured reliably, revenue is recognised only to the extent that the expenses incurred are eligible to be recovered.

(iii) Export Incentives

Revnue in respect of the export incentives incentives are recognized on accrual basis in the period in which the related exports have been made.

Revenue in respect of the RoDTEP export incentives are recognized in the period in which the related exports have been made based at an estimated value based on historical realisations, taking into consideration the type of transaction and the specifics of each arrangement.

(iv) Power Generation

Sale of power is recognised on the basis of meter reading confirmed by buyers in accordance with the respective agreement.

Renewable Energy Certificate are accounted for on certification of energy sale quantity by the buyer and is valued at minimum sale price fixed by Central Electricity Regulatory Authority after adjusting expected outgo.

(v) Interest

Income from interest is recognized using the effective interest rate (EIR). EIR is the rate that exactly discounts the estimated future cash payments or receipts over the expected life of the financial instrument or a shorter period, where appropriate, to the gross carrying amount of the financial asset. When calculating the effective interest rate, the Company estimates the expected cash flows by considering all the contractual terms of the financial instrument but does not consider the expected credit losses.

(vi) Dividend

Dividend income is recognized when the right to receive the payment is established.

(vii) Insurance and other claims are recognized when no significant uncertainty exists with regard to ultimate collection thereof, and same is adjusted from corresponding heads of expense.

2.13 Employees Benefits

(i) Short term Employee Benefits:

Liabilities for wages, salaries and other employee benefits that are expected to be settled within twelve months of rendering the service by the employees are classified as short term employee benefits. Such short term employee benefits are measured at the amounts expected to be paid when the liabilities are settled. Short Term Employee Benefits are recognized as an expense on an undiscounted basis in the statement of profit and loss of the year in which the related service is rendered.

(ii) Post Employment Benefits

(a) Defined Contribution Plans:

Provident Fund

Retirement benefit in the form of provident fund is a defined contribution scheme. The Company has no obligation, other than the contribution payable to the provident fund. The Company recognizes contribution payable to the provident fund scheme as an expense, when an employee renders the related service.

(b) Defined Benefit Plans

Gratuity

The Company provides for gratuity, a defined benefit retirement plan ('the Gratuity Plan') covering eligible employees of the Company. The Gratuity Plan provides a lump-sum payment to vested employees at retirement, death, incapacitation or termination of employment, of an amount based on the respective employee's salary and the tenure of employment with the Company. Liabilities with regard to the Gratuity Plan are determined by actuarial valuation,

performed by an independent actuary, at each balance sheet date using the projected unit credit method.

The Company recognizes the net obligation of a defined benefit plan in its balance sheet as an asset or liability. Re-measurements comprising of actuarial gains and losses, the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability) and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability) are recognised in Other Comprehensive Income which are not reclassified to profit or loss in subsequent periods.

(iii) Long-term employee benefits

The liability of accumulating compensated absences is determined by actuarial valuation performed by an independent actuary at each balance sheet date using Projected Unit Credit Method.

2.14 Borrowing Costs

Borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalized as part of the cost of the asset. Other borrowing costs are recognized as an expense in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs.

2.15 Foreign Currency Transactions

The foreign currency transactions are recorded, on initial recognition in the functional currency (i.e. Indian Rupee), by applying to the foreign currency amount the spot exchange rate between the functional currency and the foreign currency at the date of the transaction. The foreign currency monetary items are translated using the closing rate at the end of each reporting period. Non-monetary items that are measured in terms of historical cost in a foreign currency shall be translated using the exchange rate at the date of the transaction. Exchange differences arising on the settlement of monetary items or on translating monetary items at rates different from those at which they were translated

on initial recognition during the period or in previous financial statements shall be recognised in profit or loss in the period in which they arise.

Foreign exchange differences recorded as an adjustment to borrowing costs are presented in the statement of profit and loss, as a part of finance cost. All other foreign exchange gains and losses are presented in the statement of profit and loss on net basis.

In respect of foreign branch, which is in the nature of integral foreign operations, all transactions are translated using the exchange rate at the date of the transaction. The translation of monetary assets and liabilities is performed using the exchange rate in effect at the balance sheet date. Fixed assets are translated as at the date of transaction. Depreciation is translated at the rates applied for translation of fixed assets.

2.16 Leases

Effective from April 1, 2019 the company adopted Ind AS 116, "Leases". The effect of adoption of Ind AS 116 was insignificant. The following is a summary of significant accounting policies related to Leases.

A. Company as a Lessee

The Company assesses whether a contract contains a lease at inception of a contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. To assess whether a contract conveys the right to control the use of an identified asset, the Company assesses whether: (i) the contract involves the use of an identified asset (ii) the Company has substantially all of the economic benefits from use of the asset through the period of the lease and (iii) the Company has the right to direct the use of the asset.

The company applies a single recognition and measurement approach for all leases, except for leasehold land, short-term leases and leases of low-value. For short-term and leases of low value, the Company recognises the lease payments as an operating expense on a straight line basis over the term of the lease.

Leasehold land is carried at the acquisition cost i.e. one-time lease premium paid at the time of acquisition of leasehold rights. However, if there

is no reasonable certainty that the company will obtain ownership by the end of the lease term, the asset is amortized over the shorter of the estimated useful life of the asset and the lease term. For all other leases, the Company recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

The right-of-use assets are initially recognized at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or prior to the commencement date of the lease plus any initial direct costs less any lease incentives. They are subsequently measured at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated from the commencement date on a straight-line basis over the shorter of the lease term and useful life of the underlying asset. Right of use assets are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable.

The lease liability is initially measured at amortized cost at the present value of the future lease payments. The lease payments are discounted using the incremental borrowing rate at the lease commencement date. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is re-measured if there is a modification, a change in the lease term, a change in the lease payments or a change in the assessment of an option to purchase the underlying asset.

Right-of-use assets are included in the Leased Assets and lease liabilities are included in other current and non-current financial liabilities in the balance sheet. Lease payments have been classified as financing cash flows in the Statement of Profit and Loss.

B. Company as a Lessor

Leases for which the company is a lessor is classified as finance or operating leases. Leases in which the Company does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income arising is accounted for on a straightline basis over the lease term, unless the receipts are structured to increase in line with expected general inflation.

2.17 Income Taxes

Income tax expense comprises current tax and deferred tax. Income tax expense is recognized in net profit in the statement of profit and loss except to the extent that it relates to items recognized directly in equity or other comprehensive income, in which case it is also recognized in equity or other comprehensive income respectively.

Current Taxes:

Current income tax for current and prior periods is recognized at the amount expected to be paid to or recovered from the tax authorities, using the tax rates and tax laws that have been enacted or substantively enacted by the balance sheet date.

Deferred Taxes:

Deferred income tax assets and liabilities are recognized for all temporary differences arising between the tax base of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date except when the deferred income tax arises from the initial recognition of an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profit or loss at the time of the transaction. Deferred tax assets and liabilities are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realized.

Deferred income tax assets and liabilities are measured using tax rates and tax laws that have been enacted or substantively enacted by the balance sheet date and are expected to apply to taxable income in the years in which those temporary differences are expected to be recovered or settled. The effect of changes in tax rates on deferred income tax assets and liabilities is recognized as income or expense in the period that includes the enactment or the substantive enactment date. A deferred income tax asset is recognized to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences and tax losses can be utilized.

The Company offsets current tax assets and current tax liabilities, where it has a legally enforceable right to set off the recognized amounts and where it intends either to settle on a net basis, or to realize the asset and settle the liability simultaneously.

Minimum Alternate Tax credit is recognised as a tax asset only when and to the extent there is convincing evidence that the Company will pay normal income tax during the specified period. Such asset is reviewed at each Balance Sheet date and the carrying amount of the MAT credit asset is written down to the extent there is no longer a convincing evidence to the effect that the Company will pay normal income tax during the specified period.

2.18 Impairment of assets

a) Financial assets

The company recognizes loss allowances using the expected credit loss (ECL) model for the financial assets which are not fair valued through profit or loss. Loss allowance for trade receivables with no significant financing component is measured at an amount equal to lifetime ECL. For all other financial assets, expected credit losses are measured at an amount equal to the 12-month ECL, unless there has been a significant increase in credit risk from initial recognition in which case those are measured at lifetime ECL. The amount of expected credit losses (or reversal) that is required to adjust the loss allowance at the reporting date to the amount that is required to be recognised is recognized as an impairment gain or loss in statement of profit or loss.

b) Non-financial assets

Intangible assets and property, plant and equipment are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the Cash Generating Unit to which

the asset belongs. If such assets are considered to be impaired, the impairment to be recognized in the statement of profit and loss is measured by the amount by which the carrying value of the assets exceeds the estimated recoverable amount of the asset. An impairment loss is reversed in the statement of profit and loss if there has been a change in the estimates used to determine the recoverable amount. The carrying amount of the asset is increased to its revised recoverable amount, provided that this amount does not exceed the carrying amount that would have been determined (net of any accumulated amortization or depreciation) had no impairment loss been recognized for the asset in prior years.

2.19 Earnings per Share

The Basic earnings per share (EPS) is calculated by dividing the net profit or loss for the year attributable to the equity shareholders by the weighted average number of equity shares outstanding during the year.

Diluted earnings per equity share is calculated by dividing the net profit attributable to the equity holders of the company by the weighted average number of equity shares considered for deriving basic earnings per equity share and also the weighted average number of equity shares that could have been issued upon conversion of all dilutive potential equity shares. The dilutive potential equity shares are adjusted for the proceeds receivable had the equity shares been actually issued at fair value (i.e. the average market value of the outstanding equity shares). Dilutive potential equity shares are deemed converted as of the beginning of the period, unless issued at a later date. Dilutive potential equity shares are determined independently for each period presented.

2.20 Dividends

Final dividends on shares are recorded as a liability on the date of approval by the shareholders and interim dividends are recorded as a liability on the date of declaration by the company's Board of Directors.

2.21 Cash flow statement

The cash flow statement is prepared in accordance with the Indian Accounting Standard (Ind AS) - 7 "Statement of Cash flows" using the indirect method for operating activities.

2.22 Exceptional items

Exceptional items refer to items of income or expense within statement of profit and loss from ordinary activities which are non-recurring and are of such size, nature or incidence that their separate disclosure is considered necessary to explain the performance of the company.

2.23 Critical accounting estimates

Property, plant and equipment

Property, plant and equipment represent a significant proportion of the asset base of the Company. The charge in respect of periodic depreciation is derived after determining an estimate of an asset's expected useful life and the expected residual value at the end of its life. The useful lives and residual values of company's assets are determined by management at the time the asset is acquired and reviewed periodically, including at each financial year end. The lives are based on historical experience with similar assets as well as anticipation of future events, which may impact their life, such as changes in technology.

Intangible assets

The company tests whether intangible assets have suffered any impairment on an annual basis. The

recoverable amount of a cash generating unit is determined based on value in use calculations which require the use of assumptions.

Trade Receivables

As per Ind AS 109, the company is required to apply expected credit losses model for recognising the provision for doubtful debts. The expected credit losses are determined based on past trends and assumptions.

Employee Benefits

The Union Ministry of Labour issued draft rules under section 67 of the Code on Wages Act in July, 2020 in the Gazette and the Act is yet to be effective. The three labour codes, the Occupational Health, Safety and Working Conditions Code 2020, the Industrial Relations Code 2020 and the Code on Social Security, 2020 have been passed by the parliament and have also received the assent of the President of India on September, 2020. However, the date on which these Codes will come into effect has not been notified. The Company will assess the impact of these Codes and will record any related impact in the period these Codes become effective.

11.3 Financial Risk Management

The principal financial assets of the Company include loans, trade and other receivables, and cash and bank balances that derive directly from its operations. The principal financial liabilities of the company, include loans and borrowings, trade and other payables and the main purpose of these financial liabilities is to finance the day to day operations of the company.

The Company is exposed to market risk, credit risk and liquidity risk. The Company's senior management oversees the management of these risks and that advises on financial risks and the appropriate financial risk governance framework for the Company.

This note explains the risks which the company is exposed to and policies and framework adopted by the company to manage these risks.

Market Risk

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprise three types of risk: foreign currency risk, interest rate risk, investment risk.

(i) Foreign currency risk

The company operates internationally and business is transacted in several currencies.

The export sales of company included in the total sales of the company, Further the company also imports certain assets and material from outside India. The exchange rate between the Indian rupee and foreign currencies has changed substantially in recent years and may fluctuate substantially in the future. Consequently the company is exposed to foreign currency risk and the results of the company may be affected as the rupee appreciates/ depreciates against foreign currencies. Foreign exchange risk arises from the future probable transactions and recognized assets and liabilities denominated in a currency other than company's functional currency.

The company measures the risk through a forecast of highly probable foreign currency cash flows and manages its foreign currency risk by appropriately hedging the transactions. The Company uses a combination of derivative financial instruments such as foreign exchange forward and option contracts to mitigate the risk of changes in exchange rates on foreign currency exposures.

(iii) Credit Risk

Credit risk refers to the risk of default on its obligation by the counterparty resulting in a financial loss. The maximum exposure to the credit risk at the reporting date is primarily from trade receivables which are typically unsecured. Credit risk on cash and bank balances is limited as the company generally invests in deposits with banks and financial institutions with high credit ratings assigned by credit rating agencies. The Company's credit risk in case of all other financial instruments is negligible.

The company assesses the credit risk based on external credit ratings assigned by credit rating agencies. The company also assesses the creditworthiness of the customers internally to whom goods are sold on credit terms in the normal course of business. The credit limit of each customer is defined in accordance with this assessment. Outstanding customer receivables are regularly monitored and any shipments to overseas customers are generally covered by letters of credit.

The impairment analysis is performed on client to client basis for the debtors that are past due at the end of each reporting date. The company has not considered an allowance for doubtful debts in case of trade receivables that are past due but there has not been a significant change in the credit quality and the amounts are still considered recoverable.
