Nagpur Records 56 Degrees After Delhi's 52.9 Amidst Continued Heatwave

Nagpur, Pankaj Peth:
Amid severe heatwave conditions in most parts of the country, Nagpur's two of the four automatic weather stations (AWS) set up by the Indian Meteorological Department (IMD) showed temperatures measuring over 50 degrees, even higher than what Delhi's Mungeshwar AWS recorded on Wednesday. According to a TOI report, the Nagpur AWS situated in the middle of the 24-hectare open agriculture land belonging to PDKV at Ramdaspath, off North Ambazari Road, recorded 56 degrees on Thursday. The other AWS along the Regional Meteorological Centre (RMC) at Sonagaon too recorded 54 degrees. Delhi Mungeshwar had recorded 52.3 degrees on Wednesday.



However, a day later, the IMD had raised questions about the accuracy of the sensors. "It could be due to an error in the sensor or the local factor. IMD is examining the data and sensors," the weather agency had stated. The continued heatwave conditions in several parts of the country, especially

the northern region has claimed 54 lives so far. Worst affected places such as Delhi, Punjab, and Odisha have been logging maximum temperatures above 45 degrees Celsius over the last few days. Twelve people died of suspected heatstroke in Odisha's Sundargarh during the past 24 hours amid sweltering heat, news agency IANS reported. According to Press, four people, including a woman, were killed due to heatwave-related

symptoms in Jharkhand's Palamu district, which recorded the state's highest maximum temperature at 47.4 degrees Celsius on Thursday. In Bihar, sunstroke killed eight on Thursday.

Decision to close the Ghadda Circle road for vehicles on the day of counting of votes

Dombivali, Pramod kumar:
Counting of votes for Kalyan Lok Sabha constituency will be held on June 4 at the indoor sports hall of Sawlaram Maharaj Sports Complex near Ghadda Circle. During this time, in view of the possibility of workers of various parties, office bearers and citizens coming on the main busy roads outside the sports complex, all the roads adjacent to Ghadda Circle in front of Sawlaram Maharaj Sports Complex will be closed by the traffic department from 5 am to 8 pm on June 4. During this time, Deputy Commissioner of Police Dr. Vinay Kumar Rathod has advised citizens to use alternative road routes near Ghadda Circle. However, Ghadda Circle Road will remain open for emergency services ambulances, LPG cylinders, fire engines, police vehicles and green corridor. Vehicles coming from Kalyan-Shilphata, Kalyan, Badlapur areas enter Dombivali city via Ghadda Circle. The traffic department has decided to close the Ghadda Circle road for vehicles on the day of counting, as there is a possibility of traffic jam in this area due to the movement of these vehicles. All types of vehicles coming from Dombivali city towards Ghadda Circle via Tilak Chowk, Shelar Naka will be stopped near Shivam Hospital. These vehicles will turn right from



Shivam Hospital and go towards the destination via Dombivali Gymkhana, Sagarli. All types of vehicles coming towards Ghadda Circle will be stopped via Suyog Hotel, Regency Anantam, Pendharkar College till RR Hospital. These vehicles will turn left from RR Hospital and go towards the destination via Milap Nagar, Kaveri Chowk. All types of vehicles coming from Khambalpada, 90 Feet Road, Thakurli Road, Panchayat Bavdi and going towards Viko Naka will be closed for traffic near Bandish Palace Hotel. These vehicles will go towards the destination via Khambalpada, 90 Feet Road, Tata Naka. All vehicles coming from Ajde Village, Aajdepada Common towards Ghadda Circle, going towards Bandish Palace will be stopped at Ghadda Circle. These vehicles will reach Ghadda

Circle and go to Shivam Hospital and from there will go towards their destination via Dombivali Gymkhana. All types of vehicles coming from Vico Naka towards the hotel via Bandish Palace will be stopped at Hotel Manish Garden. These vehicles will turn right near Manish Garden and go towards their destination.

1 The company has defaulted in payment of Rs. 5,26,84,473/- towards corporate guarantee given for loan availed by K Sera Sera & Vikram Bhatt Studio Virtual World Private Limited. Petition for initiation of Corporate Insolvency Resolution Process under Section 7 of the Insolvency and Bankruptcy Code 2016 filed against the Company by Micro Capitals Private Limited (Financial Creditor) for default amount of Rs. 5,26,84,473/- has been admitted against the Company vide Honourable National Company Law Tribunal, Mumbai Bench order dated 18th December, 2023. Mr. Dharmendra Dheliariya (having registration no. IBB/PA-001/PA-P00251/2017-18/10480) has been appointed as Interim Resolution Professional by the Honourable National Company Law Tribunal, Mumbai Bench under Section 131(c) of the Insolvency and Bankruptcy Code 2016 and moratorium period under Section 14 of the Insolvency and Bankruptcy Code 2016 is declared. The Company is continued as going concern. The Committee of Creditors in its first CoC meeting appointed Mr. Dharmendra Dheliariya as Resolution Professional.
2 The above Financial Results for the Quarter and year ended 31st March, 2024 were reviewed and approved by the Resolution Professional on 30th May 2024. The Statutory Auditors of the Company have reviewed the said Results.
3 The Statement of financial result has been prepared in accordance with the Indian Accounting Standards (Ind AS) prescribed under section 133 of the Companies Act, 2013, read with the relevant rules issued thereunder and the recognised accounting practices and policies to the extent applicable.
4 These Financial Results have been signed by the Resolution Professional (RP) while exercising the power of Board of Directors of the Company, which has been him in terms of the Provision of Section 17 of the Code. Interim Resolution Professional has signed these financials in good faith, solely for the purpose of Compliance & Discharge of his duty under the Code.
5 As per the requirements of Ind AS-108, no disclosure is required as the Company is operating in single business segment.
6 Demand of Rs 179.51 Lacs including the interest and penalty under GVAT. The authorities have approved a refund amount of INR 15 lakhs vide Refund Order dated 21st August 2020 and the same was received by the company in its bank account.
7 The company name in the list of shell companies (Vide SEBI on its letter bearing no. SEBI /HO/SD/OWP/2017/18183 dated August 7, 2017). Exchanges had initiated a process of verifying the credentials / fundamentals of the company through exchange. Exchanges had appointed an auditor to conduct audit of the company to verify its credentials/fundamentals."On verification, if Exchanges do not find appropriate credentials / fundamentals about existence of the company, Exchanges may initiate the proceeding for compulsory delisting against the company, and the said company shall not be permitted to deal in any security on exchange platform and its holding in any depository account shall be frozen till such delisting process is completed."Accordingly, the forensic audit was conducted, however, till date the company has not received any further communication from BSE."
8 Company had received a demand of Rs. 25 Lacs from SEBI vide its order no. EAD/BJD/NJR/2017-18 with regards to redressal of investor grievances through SEBI Complaints Redress System (SCORES). The company has filed an appeal against the demand with Securities Appellate Tribunal Mumbai and vide order dated 7th August 2019, the appeal was dismissed. Later the company contested the same in Supreme Court and vide order dated 24th July 2020, the appeal is dismissed. Thus, in the said quarter, the company has recognised the liability of Rs. 25 lakhs payable towards the penalty imposed by SEBI on account of non-redressal of investor grievances.
9 Previous period's figures have been reclassified, wherever necessary, to correspond with those of the current period.
