Report of Scrutinizer on voting by Postal ballot through remote e-voting of the Unitholders of Indian Highway Concessions Trust ("IHCT" or" Trust") in respect of passing of resolution contained in Postal ballot notice dated October 09,2024, in terms of applicable provisions of the Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014 ("InvIT Regulations") and circulars issued by Securities and Exchange Board of India ("SEBI") from time to time.

Dear Directors,

I, Mr. Jatin Prabhakar Patil, Partner of M/s. Mayekar & Associates, Practicing Company Secretaries, Mumbai (Firm U.I.N - P2005MH007400), have been appointed as Scrutinizer by the Investment Manager (acting on behalf of IHCT) on October 09, 2024, to scrutinize the voting process of postal ballot of the IHCT through remote e-voting, in a fair and transparent manner.

Scrutinizer's Responsibility

My responsibility as scrutinizer is restricted to making a scrutinizer report of the votes cast by the Unitholders in respect of resolution contained in the Postal ballot notice. My report is based on verification of the votes received through remote e-voting by 17:00 hours (IST) on Wednesday, November 13, 2024.

I submit my report as under:

- The Investment Manager (acting on behalf of IHCT) has followed the procedure laid down under Regulation 22 of the InvIT Regulations, as amended, permitting Infrastructure Investment Trusts ("InvITs") to pass the resolution by way of postal ballot by voting through remote e-voting process only.
- 2. The Postal ballot notice dated October 09, 2024, was circulated electronically to all the Unitholders whose email addresses were registered with the IHCT or their Depository Participant(s).
- 3. The Investment Manager (acting on behalf of IHCT) had appointed National Securities Depository Limited ("NSDL") for the purpose of extending the facility for remote e-voting.
- 4. NSDL had set up e-voting facility on their website www.evoting.nsdl.com to facilitate the Unitholders to cast their vote electronically.

- 5. Unitholders holding units as on Friday, October 11, 2024 i.e. cut-off date, were eligible to cast their vote.
- 6. The remote e-voting commenced at 09:00 hours (IST) on Tuesday, October 15, 2024 and ended at 17:00 hours (IST) on Wednesday, November 13, 2024 (both days inclusive) and the remote e-voting portal was blocked immediately thereafter for voting.
- 7. 13 (Thirteen) Unitholders had availed the facility of remote e-voting provided by NSDL.
- 8. After conclusion of the remote e-voting period i.e at 17:00 hours (IST) on Wednesday, November 13, 2024, the votes received through facility of remote e-voting were duly unblocked by me and were reconciled with the details of Unitholders as per the Beneficiary Position as on the cut-off date obtained from the Registrar and Transfer Agent of IHCT.
- 9. No invalid votes were received through remote e-voting.
