Scrutinizer's Report on voting through remote e-voting for Postal Ballot conducted in terms of Sections 108 and 110 of the Companies Act, 2013 (" Act") read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014

Dear Sir,

I, Dinesh Kumar Deora, Company Secretary in practice (Membership No. FCS 5683 COP No. 4119) have been appointed as Scrutinizer by the Board of Directors of PATEL INTEGRATED LOGISTICS LIMITED ("the Company") for the purpose of scrutinizing the Postal Ballot conducted by way of remote e-voting process ("e-voting") in a fair and transparent manner on the Resolution(s) contained in the postal ballot notice dated May 17, 2024 ("Notice") issued in accordance with the provisions of Section 110 read with Section 108 and other applicable provisions, if any, of the Companies Act, 2013 (the "Act"), Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification(s) or re-enactment thereof for the time being in force), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR Regulations), Secretarial Standard on General Meetings (SS-2) to the extent applicable.

The hard copy of this Postal Ballot Notice along with Postal Ballot forms and pre-paid business envelope were not sent to the Members for the postal ballot in accordance with the requirements specified under MCA circulars.
- c) The Company has appointed M/s Bigshare Services Private Limited ("BSPL") to provide e-voting facility to the Members of the Company to cast their votes through a secured electronic mode on the resolution(s) to be transacted in the Postal Ballot Notice, the report contains the details of E-Voting only.
- d) The Company has completed the dispatch of Postal Ballot Notice by e-mail on 17th May, 2024 in accordance with the MCA Circulars, no physical ballot notice was dispatched to the Members.
- e) The requisite advertisement pursuant to Section 108 of the Companies Act,2013 read with Rule 20(4)(v) of the Companies (Management and Administration) Rules,2014, as amended and in compliance with Ministry of Corporate Affairs Circulars were published in "Free Press Journal" and "Nav Shakti" (in English and Marathi) regarding the dispatch of Postal Ballot along with Remote E-Voting information and containing all the matter required under the Companies Act,2013 and relevant Rules thereon on 18th May, 2024.
