QUESTIONS RECEIVED FROM THE SHAREHOLDERS AT THE 37TH ANNUAL GENERAL MEETING

1. What do you plan to do with this company? How do you plan to take it ahead? Do you want to relocate the Company?

Ans. We have just taken over the company recently and from 1st August, we have started the business. Our all business force and I basically belong to Jaipur, Rajasthan. Our head office will be in Mumbai only and very soon company is going to have a new office in Mumbai. As far as our business is concerned, It's only just two months, only 1.5 months. We are planning to have a small size of business loans, personal loans, secured loans and unsecured loans. We have just only deploy approx 50 to 75 lakhs around, small sizes of loans. So very soon you will get, your company will be on a track with small size of loans and our main working will be in Rajasthan and slightly in Mumbai. Very soon, we will have another meeting, not AGM and where we will try to give all the answers again.

2. What is the road mate capex and R and D program of your company and how do you think you will fund it? What is the impact of logic budget on our company and who are our competitors? And how many verticals are there for revenue generation and give the breakup, sir? Any merger Demerger acquisition?

Ans. We are very small company. We have just started the work. There is no merger, no Demerger, no competitions. Let us work smoothly. At least give us 6 to 12 months so that we can tell you what's the planning and which areas we are working. This is the starting, it's just only 45-47 days to start the work. Please have patience, everything will be shared.

3. What is the road map and future business model and are there any plans for fundraising provided that you are starting a new business?

Ans. We have just started work. It's only 45 days. At least for next three to four months, there is no question of fundraising. We are already having enough cash to meet out next three to four months loans disbursement. We just try to give a small size of loans, secured loans and unsecured loans and personal loans. We are just searching the market, just trying to find out the best way to give that loan disbursement very soon. We will have the long term planning but right now our target is to disburse three, four, five lakhs rupees loan, business loan.
