Accident near Kotambi Stadium on Vadodara-Halol Highway

Pick-up van carrying 10 passengers plunges into drain



Vadodara, The accident took place near the Kotambi Cricket Stadium near the Vadodara-Halol highway. The empty side tire hit the divider and the full pick-up van plunged into a water-filled drain. There were 10 people in the car. In which four people including two children have died. While 6 people are currently under treatment at Sayaji Hospital.

Jashubhai Vaghela, Sub Fire Officer of ERC Fire Station, who carried out rescue work, said that the accident took place right next to the stadium. We reached the spot immediately after receiving the message. It was found that the accident occurred due to burst tire of pick-up Dala. When we checked, the tire was flat. After that the drain beside the road was full of water. The pickup truck overturned. When we reached there, we rescued four people. They included two young children and two men. Another patient has been shifted to Sayaji Hospital from Jarod. Whose name is Lalitaben Shankarbai Wakha (B.O. 22). Suddenly, no one knew what happened: The passenger car overturns after getting tire deflating. Driver Bolero pickup driver Vimal Damor said, I have been driving Bolero pickup for a year. We were coming from Jalod to Vadodara, when the empty side tire hit the divider, causing the vehicle to overturn. 10 to 15 people were sitting in the car. We went to Jalod to cut firewood. All the passengers were sitting in the car named Shankarbai Wakhar said that he was a native of Rajasthan and used to come to Vadodara for work. He was sitting at the back. Suddenly, I did not know what happened. Suddenly there was an accident and the pickup overturned.

Thunderstorm likely in four districts of the state Ahmedabad will experience unbearable gusts, there is no chance of rain in Gujarat at present

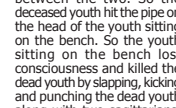
Ahmedabad Weather department has predicted the weather of Gujarat for the next five days. According to which, during the next three days, there are chances of cyclonic storm with dust clouds in four districts of Gujarat. In which dust will fly in Kutub, Sabarkantha, Patan and Surendranagar districts. Apart from this, currently there is no possibility of rain in any district of the state of Gujarat during the next five days, but due to the disturbance in the Arabian Sea, fishermen have been instructed not to venture into the sea in the Gulf of Kutch. Fishermen have been instructed not to venture into the sea during the next four days. Also, a yellow alert has been declared in the sea.

The maximum temperature is predicted to be 43 degrees Celsius, the heat intensity has reduced in various districts of Gujarat including Ahmedabad, Gandhinagar. Today, the maximum temperature in Ahmedabad and Gandhinagar has been predicted by the Meteorological Department to be 43 degrees Celsius. The temperature will remain unchanged in most of the districts of the state for the next five days. Some districts may also see a drop in temperature by one to two degrees Celsius. At present, winds are blowing from south-west and west direction over Gujarat. Due to this, moisture from the Arabian Sea, has been drawn, due to which Gujarat has a cool climate, but due to this there are no chances of rain. Only the wind will blow at a fast speed. The speed of this wind will be 25-30 km per hour.

Urbanites will get partial relief from the heat from today the maximum temperature of the districts of Central and North Gujarat will decrease. Apart from this, the wind will blow at a speed of 25-30 km per hour, due to which the urbanites will get partial relief from the heat, but today the people of Ahmedabad will have to face Baffara. Baffara may be experienced not only in Ahmedabad, but in North and Central Gujarat including Gandhinagar. Because, currently, winds are blowing over Gujarat from West and South West direction, which brings the sea moisture to different parts of Gujarat. Due to this, for the last four days, after normal cloudy weather in Ahmedabad city in the early morning, the clouds disappear as the temperature increases. Even today, there are clouds in the sky of Ahmedabad city since early morning, but as this is not a rain cloud, there is no forecast of rain at present.

Youth kicked and punched to death in Surat

3 men beat youth to death for sitting on bench



Surat In Surat's Katargam, 3 persons have killed a youth due to a brawl over sitting on a bench. A young man was sitting on a bench. The deceased youth came there and said, I want to sit here. But when the killer youth refused to get up from the bench, a brawl broke out between the two. So the deceased youth hit the pipe on the head of the youth sitting on the bench. So the youth sitting on the bench lost consciousness and killed the dead youth by slapping, kicking and punching the dead youth along with two sightgazers. The entire incident has also been captured on CCTV. However, when the matter reached the police, the three killers were arrested and further action was taken.

According to the information received, 24-year-old Shyamal Lalit Chokhokhi was working as a laborer and living on the pavement near Katargam Lalita Chokhokhi in Surat, was killed by 3 persons around 9 pm. Rickshaw drivers Sohan Singh Marwara, Rahul Sakkal and Mehul Unagar brutally kicked and punched him. So, the injured Shyamal was taken to Smeem Hospital by ambulance. After Shyamal died in the hospital, Katargam police was informed. The police arrested 3 accused after investigating the brawl over sitting on the bench. According to the confession made by the accused before the police, Sohan Singh was sitting on a bench on the footpath near Marwara Lalita Chokhokhi on the night of the incident. That time Shyamal came there and asked Sohan Singh to get up saying that he wanted to sit here. When Sohan Singh refused to get up, there was a fight between the two.

The youth died due to cattle slaughter. During the brawl, Shyamal hit Sohan Singh with a piece of pipe in his hand, bleeding him on the head. With this attack, Sohan Singh became uncontrollable and broke down on Shyamal. Sohan Singh rained slaps, kicks and punches on Shyamal's head and face. Rahul Sakkal and Mehul Unagar, two friends of Sohan Singh, also broke up with Shyamal. Shyamal's body was blown away due to the beating of the three men. However, now the Katargam police have arrested the killers and taken further action.

Complaint against six game zones in Surat Fire permission, no emergency exit gate, 14 owner-managers booked

Surat The fire incident at TRB Game Zone in Rajkot is reverberating across the state. Due to which action is being taken on Jamzom. Then it has been ordered to file a complaint against those who do not have Fire NOC. First action has been taken against 6 game zones in Surat. A fire complaint has been filed against 14 owners, managers of 6 GameZones. A crime was filed against 14 owners-managers of the game zone in the game zone running in Surat, especially the municipality, DGVC, fire, road and building department checked with the police. In which fire permission was not taken in some game zones. Above all, emergency exit gates were not made in some of them. Also, the work was not done according to the plan of the municipality, so the police have registered a crime late at night against 14 owners and managers of 5 game zones. According to information coming to light, a joint team of Police Department, Surat Municipal Corporation, Fire Department, Roads and Buildings Department and DGVL in connection with the

incident of fire in TRP Game Zone, Rajkot under the instructions and guidance of the Commissioner of Police, in Game Zone in Surat city. A check was made. 17 Owners, Managers of game zones kept necessary documents and necessary license verification of related departments and necessary verification of fire and construction and electrical power on site. Out of which, in 5 game zones, there was a deficiency regarding the required license of the affiliated departments.
