2) The Statutory Auditors of the Company have carried out a Limited Review of the aforesaid Results under regulation 30 of SEBI (LODR) Regulation 2015.
3) The Company operates in only one segment i.e. paper and therefore as per Ind AS 108 segment reporting is not required.
4) Results for the quarter ended on Dec 31, 2024 are in accordance with Indian Accounting Standards (Ind AS) as prescribed under section 133 of the Companies Act, 2013 read with relevant rules issued there under.
The company has incurred cash loss of Rs.251.70 lacs during the quarter under review. During the quarter, the company's production and earnings were impacted due to planned annual maintenance, decrease in realizations and rising input costs.
5) However, strategically this maintenance period was also utilised for upgradation of plant and machinery to improve the quality and brightness of paper. The production of improved white paper is implemented from 08th January 2025.
6) The Management is of the view that the net worth of the company will improve in the upcoming Quarters due to the turnaround in production strategies. Further the promoters are planning to infuse more capital in the company to improve the working and Net Worth of the company.
7) Previous period's figures have been regrouped wherever necessary to confirm current period's classification.
