We, M/s. ALAP & CO. 1. Special Resolutions for Sub-division/Split of Equity Shares of the Company and consequent amendment to the Memorandum of Association of the Company;

#### WE HEREBY REPORT AS UNDER;

- On the basis of the register of members and the list of beneficiary owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on Friday, October 25, 2024, the Company completed dispatch of the Notice of the Postal Ballot through E-Mail on October 30, 2024 to the members whose E-Mail Id's are registered with company/depository participant.
- 2. The Company had also placed the Notice of Postal Ballot on its web site as well as web site of E-voting Agency and web site of BSE Limited.
- 3. The Company has published the newspaper advertisement for date and time of commencement and end of remote e-voting and Postal Ballot in;
