The Company shall continue to run Radio Business till proposed sale transaction is completed. Consequent to the above proposal, no impairment losses have been provided in the quarter and nine months period ended December 31, 2024. 4. In previous year, exceptional item represents amount recorded on decline in valuation of radio business. Basic and diluted earnings without impact of such exceptional item would have been Rs. 10.07 for the year ended March 31, 2024. During the quarter/ nine months period ended December 31, 2024, the Company has regrouped certain expenses to reflect the nature of such expenses more appropriately. 5 The figures for the previous quarters/ period/ year have been regrouped/ reclassified, wherever necessary, to conform classification in current quarter/ period.
