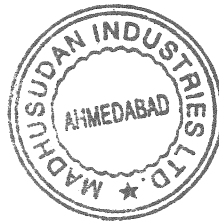

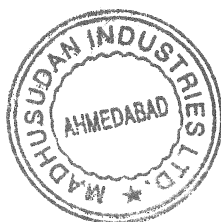
#### Notes :
