The Company is in the process of providing adequate replies to the alleged violations and believes that there will not be any impact. However, the outcome and related implications cannot be predicted with certainty at this stage.
Reason for delay in submission of disclosure	The Company was undertaking internal assessments with regard to the impact because of the Show Cause Notice. The Company believes that there will not be any impact and hence the disclosure is being submitted now to the Stock exchanges.
