Dear Members,

Your Directors have pleasure in presenting the **Thirty First Annual Report** of the Company together with the Audited Financial Statement for the year ended 31st March, 2021.

1. FINANCIAL AND OPERATIONAL PERFORMANCE

a. Standalone Financial Results

b. Operations:

The Company's total revenue is Rs. 11,04,806/- in F.Y. 2020-21 as compared to Rs. 1,06,81,16,075/- in F.Y. 2019-20. The Company made a loss of Rs. 23,66,44,445/- in financial year 2020-21 as compared to loss of Rs. 47,82,61,571/- posted in financial year 201920.

The Company had huge loans and interest payments but due to financial constraints the Company couldn't repay the loans taken from Saraswat Bank. Hence Saraswat Bank vide their letter dated February 18, 2020 sent to the Company a notice declaring the company as Non-Performing Asset (NPA) and thereafter the Company handed over the assets of the Company to Saraswat Bank.

c. Report on Performance of Subsidiaries:

The Company does not have any subsidiary company.

d. Dividend:

Your Directors have not recommended any dividend for the financial year ended 31st March, 2021 and no amount has been transferred to reserves.

e. Transfer to reserves:

During the year under review, the Board of Directors has not recommended transfer of any amount to reserves.

f. There was no change in the nature of business of company during F.Y. 2020-21.

g. Disclosures under section 134(3)(I) of the Companies act, 2013:

Except as disclosed elsewhere in this report, no material changes and commitments which could affect the Company's financial position have occurred between the end of the financial year of the Company and date of this report.

h. Share Capital:

There was no change in the Company's Capital during the year under review.

I. DISCLOSURE OF INTERNAL FINANCIAL CONTROL:

The Internal Financial Control with reference to financial statements as designed and implemented by the Company are adequate. During the year under review, no material or serious observation for inefficiency or inadequacy of such controls are reported.

II. PARTICULARS OF LOANS, GUARANTEES, INVESTMENTS AND SECURITIES:

Full Particulars of Loans & Guarantees Given, Investments made and Securities provided along with the purpose for which the loan or guarantee or security is proposed to be utilized by the recipient are provided in the financial statement. (Please refer to Notes [13 of the Financial Statement.)

III.PARTICULARS OF CONTRACTS/ ARRANGEMENTS/ TRANSACTIONS WITH RELATED PARTIES:

All contracts / arrangements / transactions, falling within the purview of Section 188 of the Companies Act, 2013, entered into by the Company during the financial year with related parties were in the ordinary course of business and on an arm's length basis. None of the transactions entered into by the Company with related parties were material in nature i.e. exceeding the limit 10% of annual turnover of the Company.

The particulars of contracts or arrangements with related parties are forming part of notes to Accounts in this Annual Report.

All Related party transactions have been placed before the Audit Committee and subsequently before the Board for its approval. As per the policy on Materiality of and Dealing with Related Party Transactions, omnibus approval was obtained on annual basis for transactions which are of repetitive nature. The policy on related party transactions as approved by the Board of Directors has been uploaded on the website of the Company.

Seven (7) meetings of Board of Directors were held during the financial year under review details of which are furnished in the Corporate Governance report forming part of Annual report.

B. DIRECTOR'S RESPONSIBILITY STATEMENT:

In terms of Section 134(5) of the Companies Act, 2013, in relation to the audited Annual Financial Statements of the Company for the financial year ended March 31, 2021, the Board of Directors hereby confirms that:

a. in the preparation of the annual accounts for the financial year ended 31st March, 2021, the applicable accounting standards have been followed along with proper explanation relating to material departures.

- b. such accounting policies have been selected and applied consistently and the Directors made judgments and estimates that are reasonable and prudent so as to give a true and fair view of the state of affairs of the Company as at 31st March, 2021, and of the Loss of the Company for that year.
- c. proper and sufficient care was taken for the maintenance of adequate accounting records in accordance with the provisions of this Act for safeguarding the assets of the Company and for preventing and detecting fraud and other irregularities.
- the annual accounts of the Company have been prepared on a going concern basis.
- internal financial controls have been laid down to be followed by the Company and that such internal financial controls are adequate and were operating effectively.
- f. proper systems have been devised to ensure compliance with the provisions of all applicable laws and that such systems were adequate and operating effectively.

C. COMMITTEES OF BOARD:

The Company has the following three (3) board level Committees which have been established in compliance with the requirements of the business and relevant provisions of applicable laws and statutes:

D. POLICIES:

(I) Vigil Mechanism Policy:

In compliance of the requirements of section 177 of the Companies Act, 2013, Regulation 22 of Listing Regulations and as measure of good Corporate Governance practice, the Board has formulated a Vigil Mechanism Policy. The policy comprehensively provides an opportunity for employees / directors of the Company to raise issue concerning breaches, accounting policies or any act resulting in financial or reputation loss and misuse of office or suspected or actual fraud. The policy is adequate safeguard against victimization.

The Board of Directors of the Company has, pursuant to the provisions of Section 178(9) of the Companies Act, 2013 read with Rule 7 of the Companies (Meetings of Board and its Powers) Rules, 2014, framed "Vigil Mechanism Policy" for Directors and Employees of the Company to provide a mechanism which ensures adequate safeguards to employees and Directors from any victimization on raising of concerns of any violations of legal or regulatory requirements, incorrect or misrepresentation of any, financial statements and reports, etc. and the same is also hosted on the website of the Company.

The employees of the Company have the right/option to report their concern/grievance to the Chairman of the Audit Committee.

The Company is committed to adhere to the highest standards of ethical, moral and legal conduct of business operations.

(II) Risk Management Policy:

The Board of Directors of the Company has designed Risk Management Policy and Guidelines to avoid events, situations or circumstances which may lead to negative consequences on the Company's businesses and define a structured approach to manage uncertainty and to make use of these in their decision-making pertaining to all business divisions and corporate functions. Key business risks and their mitigation are considered in the annual/strategic business plans and in periodic management reviews.

E. Internal Control Systems:

Adequate internal control systems commensurate with the nature of the Company's business and size and complexity of its operations are in place and have been operating satisfactorily. Internal control systems comprising of policies and procedures are designed to ensure reliability of financial reporting, timely feedback on achievement of operational and strategic goals, compliance with policies, procedure, applicable laws and regulations and that all assets and resources are acquired economically, used efficiently and adequately protected.

VI. AUDITORS AND AUDITOR'S REPORTS:

a. Statutory Auditor and their report:

Pursuant to the provisions of Section 139 of the Companies Act, 2013 and the Companies (Audit and Auditors) Rules, 2014, M/s Raman S. Shah & Associates, Chartered Accountants, registered with the Institute of Chartered Accountants of India (ICAI) bearing registration number 119891W, was appointed as the Statutory Auditors of the Company, from the conclusion of the twenty-Seventh Annual General Meeting (AGM) held on 29th September, 2017 till the conclusion of the thirty second AGM of the Company, subject to the ratification of their appointment at every AGM.

Pursuant to Companies (Amendment) Act, 2017 the proviso regarding ratification of appointment of auditors in every general meeting by the members removed vide notification dated 7th May 2018. Therefore M/s Raman S. Shah & Associates continues to hold office upto thirty second AGM.

M/s Raman S. Shah & Associates has provided their respective consent, certificates and declaration as required under Section 139 and 141 of the Act and the Companies (Audit and Auditors) Rules, 2014. The Report of the Auditors on the financial statement for the year ended 31st March 2021 contains qualification as under:

Qualification:-

- I. Notice is issued by Saraswat Bank dated 18th February, 2020 under section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act 2002 for non-payment of principal and interest of Rs. 76.24 Crores up to 18th February, 2020, after the due date by the company and therefore all loan accounts became Non-Performing Assets effective from respective dates mentioned in such notice.
- We draw attention regarding impact of permanent decline in respect of non-current investments 11. (Long term investments) in Tekno Point Mercantile Private Limited ("the Party Company") for Rs. 4.15 Crores which is shown as Current Investment (Short Term Investment). Out of the above 4.15 Crores, the management has provided for a diminution of Rs. 4.00 Crores, thus reducing the Investments in the Party company to Rs. 15 Lakhs. In the absence of financial statement for the year ended 31st March, 2021 of the party company, it has been observed from the perusal of the financial statements of F.Y. 2018-19, that the Party Company has accumulated losses of Rs 289.55 Lakhs for the year ended 31st March, 2019. The Party Company is under losses since a past few years. The Party Company's Independent Auditors' Report, audited by the other auditor, shows qualified opinion on non-provision of losses to the extent of Rs.7.54 Crores on account of valuation of stock at cost instead of lower of Cost or market value for the year ended 31st March, 2019. As a result of this, the net worth of the Party Company has eroded significantly. These conditions, along with absence of clear indications or plans for revival, in our opinion, indicate that there is significant uncertainty and doubt about the correct Fair market value of the said investment. In our opinion, management has not adequately or sufficiently accounted for the imminent diminution, if management accounted for such diminution, the profit for the year ended 31st March 19 would have been further reduced and accordingly carrying value of investment would have also been reduced. We were unable to determine the impact on the Audited financial result, of potential adjustment for provision of diminution in the value of investment made in the said party company.
- III. During the year, the Company has carried out the impairment/obsolete testing exercise on the inventory and found it necessary to provide for impairment of Work in progress and intermediate products inventory. Based on the management's estimate of the fair realizable value of inventory as per Ind AS 2 an impairment provision of Rs. 25.21 Crores has been provided based on the management's best judgment and subject to technical review by a technical team of consultants. In view of uncertainty, we were unable to determine the impact on the Audited financial result, of potential adjustment for impairment provision of inventory that might have been necessary to present the inventory at its estimated realizable value. The Saraswat bank have took over the balance stock of Rs.3.55 Crores as the bank declared the Company as Non-performing Asset and has initiated Notice u/s.13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security interest Act 2002.

- IV. As per section 17(5) (h) of CGST Act, 2017, the liability to forego the Input Tax Credit (ITC) arises when the value of inventory is fully written off from the books of accounts on impairment of inventory. Taking into consideration the above point, the Company has failed to reverse the ITC to the extent of inventory written off on account of impairment. In view of uncertainty, we were unable to determine the impact on the Audited financial result, of potential adjustment for reversal of ITC. The losses, in our opinion, would have substantially increased if the Company had provided for the liability of reversal of Input Tax Credit.
- V. According to Ind AS-19, related to employees' benefits, the company has not given any effect of gratuity liabilities as per actuarial valuation; hence the effect of gratuity expenses as per Ind AS-19 is not reported in other comprehensive income. As per information provided by the company, its operational activities are standstill since February' 2020 and due to non-availability of key personnel there is no detail available for actuarial valuation.
- VI. The company has shareholding of 33.58% in Paid Up Capital of Techno Point Mercantile Private Limited. Therefore, Techno Point Mercantile Private Limited is an associate company within the meaning of Section 2(6) of the Companies Act, 2013; the company has a significant influence as the Company controls at least 20% voting power of the other Company. The company has not prepared consolidated financial statement of the company and Techno Point Mercantile Private Limited which is an associate Company in the same form and manner as it prepares its own financial statements. The consolidated financial statement of the Company needs to be laid before the shareholders of the Company with its own financial statements. However, the company is of the view that there is no significant influence in determining an associate company with control over voting power, rather than control over share capital.
- VII. The Company has not considered the possible effects that may result from the pandemic relating to COVID-19 on the carrying amounts of Audited financial statements. In developing the assumptions relating to the possible future uncertainties in the global economic conditions because of this pandemic, the Company, as at the date of approval of these financial statements has not used internal and external sources of information including credit reports and related information and economic forecasts. Basis such uncertainties, we were unable to determine the adverse impact on its future cash flows and its ability to meet its obligations as and when they fall due.
- VIII. With reference to note no. 2.2 regarding Property, Plant and equipment, the Saraswat Bank have taken over entire property under fixed assets and balance remaining under CWIP is Rs. 11,97 Lacs towards advance of lands. In the absence of third-party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its recoverability in cash or kind, if any. Further in the absence of future cash flow information about the value of fixed assets in use, we are unable to comment upon its impairment provision, if any as per IND AS- 36 "Impairment of Assets".
- IX. With reference to Trade Receivables of Rs. 1.08 Crores as at 31st March, 2021 in the absence of third-party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its balance recoverability, if any.
- X. With reference to Other Current Assets (Security Deposit, Loans and advances to employees and balances with government authorities) of Rs.4.47 Crores as at 31st March, 2021 in the absence of third-party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its balance recoverability, if any.
- XI. With reference to Trade Payable of Rs.9.76 Crores as at 31st March, 2021 in the absence of third-party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its balance outstanding, if any.

XII. With reference to note no. 12 regarding Deferred Tax Liabilities, In FY 2020-21, the saraswat bank has taken possession all property, plant & equipment and auctioned it to recover their dues of under SRFESIA Act, 2002, hence there is no differences arises on account of deferred tax liabilities. In absence of future taxable profit, the utilisation of deferred tax asset generated in the current year for Rs. 17,48,83,233/- has not been recognised in compliance of IND AS 12 as contemplated in Companies Act, 2013.

Emphasis of Matter

- 1. We draw attention to the Note No. 10 in the financial Statements. The company has incurred net loss after exceptional items of Rs. 23.66 Crores during the year ended 31st March, 2021 and as of that date, the Companys accumulated losses aggregate to Rs. 19.10 Crores resulting into eradication of entire net worth, negative working capital, loss of key personnel and negative cash flow. Hence the Company's future performance is doubtful and has not been able to pay liabilities of banks, creditors. These factors along with other matters as set forth in said note raise substantial doubt about the companys ability to continue as a going concern in the foreseeable future.
- 2. We draw attention to Note 10 of the accompanying financial statements, during the year under review; the Company incurred huge losses, which resulted into eradication of entire net worth, negative working capital, loss of key personnel and negative cash flow. Hence the Company's future performance is doubtful and has not been able to pay liabilities of banks, creditors. As informed to us and relied as per management view, during the financial year 2019-20, Company has written off huge stock on account of closure of plant by Pollution control Board in periodic interval for different manufacturing units, power/water disconnection due to closure notice, batch failure and COVID 19 situation has lost key personnel responsible for production and Loss of skilled workers. The Company has been facing many problems related to pollution issues and received closure notice from Maharashtra Pollution control Board since past three years in different occasions. Lastly under COVID 19 it could not produce material.
- 3. We draw attention to Note No. 3 of accompanying financial result regarding notice issued by the Saraswat Co-Operatve Bank Limited under section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act 2002 for non-payment of principal and interest thereon after the due date by the company and therefore all loans accounts became Non-Performing Assets effective from respective dates mentioned in such notice. These factors along-with other matters as set forth in said notice raise substantial doubt about the company's ability to continue as a going concern in the foreseeable future.

In view of the same and events stated in points I, II, III, IV, V, VI, VII, IX,X, XI and XII in the para above "Basis for Qualified Opinion", indicate that a material uncertainty exists that may cast a significant doubt on the Company's ability to continue as a going concern. (Note No. 30 of accompanying financial statements)

Reply to the qualification: -

Company's Banker Saraswat Co-Operative Bank Limited under section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act 2002 for non-payment of principal and interest thereon after the due date by the company and therefore all loans accounts became Non-Performing Assets effective from respective dates mentioned in such notice.

The Company is in negotiation with Banks to grant loan and overdraft facilities. Further Company is exploring possibilities of receiving investments in order to get sufficient funds to run the business.

The Company is hopeful to revive its business and start full fledge operations in near future.

Management's Responsibilities for the Standalone Financial Results

The Statement has been prepared on the basis of the standalone annual financial statements. MANAGEMENT DISCUSSION AND ANALYSIS REPORT

INDIAN ECONOMIC REVIEW

It is over a year since the COVID-19 pandemic hit us hard through public health crisis and economic disruption. Though the accumulating human toll continues to raise concerns, the growing vaccine coverage is lifting sentiments. In this scenario, high uncertainty surrounds the global economic outlook, primarily related to the path of the pandemic. The contraction of activity in 2020 was unprecedented. As per IMF, the global economy contracted -3.3 percent in 2020. IMF now projects the global economy to grow at 6 percent in 2021, and moderating to 4.4 percent in 2022. Over the medium term, global growth is expected to moderate to 3.3 percent.

The COVID-19 recession is likely to leave smaller scars than the 2008 global financial crisis. However, emerging market economies and low-income developing countries have been hit harder and are expected to suffer more significant medium-term losses. Future developments will depend on the path of the health crisis, including whether the new COVID-19 strains prove susceptible to vaccines or they prolong the pandemic; the effectiveness of policy actions to limit persistent economic damage; the evolution of financial conditions and commodity prices; and the adjustment capacity of the economy.

Pharmaceutical Industry

India is third in the world by volume and 14th by value in terms of pharmaceutical production. The domestic pharmaceutical sector consists of a network of 3,000 pharmaceutical companies and 10,500 production facilities. The Indian Economic Survey 2021 forecasts that the domestic market would triple in size over the next decade. Domestic pharmaceutical sales in India were \$42 billion in 2021, and is projected to reach \$65 billion by 2024 and \$120 billion by 2030. In January 2022, the Indian pharmaceutical market grew by 13.9%. India is a prominent and expanding participant in the global pharmaceutical industry. India is the world's largest supplier of generic pharmaceuticals, accounting for 20% of the global supply by volume and fulfilling over 60% of the global demand for vaccinations.

API INDUSTRY

The global Active Pharmaceutical Ingredient market is expected to grow at a high single digit CAGR from 2020 to 2027 to reach US\$ 364.17 billion by 2027. Increased healthcare expenditure by the urban population and an increase in the geriatric population are influencing the market growth of APIs. The captive API segment, which holds the dominant market share, is anticipated to grow at a significant rate in the coming years owing to the easy availability of raw materials and greater investments by major players to develop manufacturing facilities. Major companies are also looking to expand their production capabilities. NCE APIs saw a huge growth in 2020 on the back of R&D initiatives for novel drug development and favourable government regulations. The API market is undergoing immense changes due to supply chain disruption by COVID-19. There is increasing preference to reduce dependence on China for API products.

OPPORTUNITIES

Big pharmaceutical companies tend to make money, by generally developing those drugs that offer the greatest profit potential. However, these companies face a huge drop in revenue from blockbuster drugs coming off patent. Without generating revenues through sales, these companies will struggle to fund the development of new life-saving drugs. Artificial intelligence (AI) can be a powerful tool in the pharmaceutical industry's research and development. So, with the help of modern technologies, pharmaceutical companies are aiming for quality but cheap products for the common people and to serve society better. In this way pharmaceutical companies can plan to serve societal needs for longer period of time.

Indian pharmaceutical companies are experiencing difficulty to survive in global markets due to the competition, lack of market knowledge, complex regulatory pathway, and not embracing the latest digital technologies. The studies have found out that there is a clear need for domain-based digital tools for Indian pharma companies to compete and sustain in global markets. The leading generic companies of the industry have mixed performance.

The Indian pharma industry has the capacity to grow. The growth drivers of domestic pharma industry incorporate increasing economic domestic growth, strong growth in the US market, introduction of new innovative products, and increased grip in markets, such as, Japan. The Indian pharmaceutical industry, being global drug supplier, has huge potential in terms of (i) establishing a market in the US generics and developing trade with other countries making it world's biggest drug supplier (ii) manufacturing high-quality medicines at an affordable price, to offer the low-priced drugs to reduce patients' costs and become a part of the scheme to implement universal healthcare in the country (iii) as a world leader to set a goal of launching of 3–5 molecular entities or doing of late clinical trial phases and about 10–12 innovations launches per year till 2030.

Big pharmaceutical companies are no longer providing the service they once did. So, the government should create an environment to start healthcare start-up firms so the patients and companies can co-exist without being a burden on each other.

Threats, Risks and Concerns

The Indian pharmaceuticals industry is globally respected and is one of the successful industries in the country. It has contributed significantly to the healthcare by ensuring quality, accessible and affordable generic medicines around the globe. It has also immensely contributed to India's economic growth. The low cost of production and R&D benefited the competitiveness of the Indian pharma industry in the international market. The Government of India has recently approved production linked incentives (PLI) Scheme for the pharmaceuticals sector which will further improve the competitiveness of the Indian Pharma Industry and will also attract additional investment in the sector. Indian pharmaceutical companies have also carved out a niche in both the Indian and world market with expertise in reverse engineering new processes for manufacturing of pharmaceuticals at low cost, which became the advantage for this industry. India is amongst the largest provider of generic drugs and vaccines globally and is known as the pharmacy of the world. Although economic woes of certain geographies are impending the pharmaceutical market growth, the long term outlook for the industry remains positive. The industry growth is driven by ageing population and ever growing middle income group in emerging economies

Additionally, the emergence of new viruses, the latest being SARS-CoV-2 and drug resistant infections, biological agents, immune therapies, etc. will spur research and development activities providing the industry with more products in their drug pipeline with revenue and growth streams.

The Indian pharmaceuticals market is the third largest in terms of volume. India is the biggest provider of generic medications globally and enjoys a strong position in the world pharmaceuticals sector. The country also has a huge talent pool and scientists having the capability to steer this industry forward to a much greater degree. The cost efficiency also continues to create opportunities for Indian pharmaceutical companies in the emerging global economies. The Indian pharmaceutical industry is expected to outperform the global pharmaceutical industry and grow in the next couple of years and thereby emerge as one of the top 10 pharmaceutical market globally by absolute value size. Indian pharmaceutical companies are focusing on global generic and API business, R&D activities and contract research and manufacturing alliances. India is also fast emerging as a preferred pharmaceuticals manufacturing location. Increasing use of pharmaceutical generics in developed markets to reduce healthcare cost will also provide attractive growth opportunities to Indian generic formulations manufacturers and thus Indian pharmaceutical industry is poised for an accelerated growth in the coming years. However, poor public healthcare funding and infrastructure, low per capita consumption of medicines in developing and under developed countries including India, currency fluctuations, regulatory issues, government mandated price controls, inflation and resultant all round increase in input costs are few causes of concern.

During the year under report, there was no change in the nature of Company's business. The pharmaceutical industry still faces significant risk despite some recovery in consumer confidence. The COVID-19 pandemic exposed weaknesses in the industry's global supply chain and while consumer confidence is recovering, it is nowhere near normal levels just yet. After one of the most chaotic years on record, pharmaceutical manufacturers are on track for recovery. Those businesses that can weather the last few months of lower-than-average demand, the future looks good.

Pharmaceutical companies are under major scrutiny from customers, and they are expecting more from the pharmaceutical industry, and it is becoming increasingly common for customers to carefully consider the dollar value a medicine provides and shop around when buying medicine. Pharmaceutical companies will need to manage growing consumer expectations and be prepared to respond to brand crises in the coming times. The supply chain may also be vulnerable to intentional disruption by cybercriminals. As cyberattacks become a more serious threat to the industry, investment in cybersecurity will need to increase.

Internal Control Systems and its adequacy

The Company has adequate internal control systems including suitable monitoring procedures commensurate with its size and the nature of the business. INDEPENDENT AUDITOR'S REPORT

To the Members of NUTRAPLUS INDIA LIMITED

Report on the Audit of the Financial Statements

Qualified Opinion

We have audited the Financial Statements of NUTRAPLUS INDIA LIMITED ("the Company"), which comprise the Balance Sheet as at March 31, 2021, and the Statement of Profit and Loss, Statement of Changes in Equity and Statement of Cash Flows for the year then ended, and notes to the Financial Statements, including a summary of significant accounting policies and other explanatory information (hereinafter referred to as "the Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, except for the incomplete disclosure of the information referred to in the Basis for Qualified Opinion section of our report, the aforesaid Financial Statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under Section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended ("Ind AS") and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2021, and its loss (including other comprehensive income) and changes in equity and its cash flows for the year ended on that date.

Basis for Qualified Opinion

- I. Notice is issued by Saraswat Bank dated 18th February, 2020 under section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act 2002 for non-payment of principal and interest of Rs. 76.24 Crores up to 18th February, 2020, after the due date by the company and therefore all loan accounts became Non-Performing Assets effective from respective dates mentioned in such notice.
- 11. We draw attention regarding impact of permanent decline in respect of non-current investments (Long term investments) in Tekno Point Mercantile Private Limited ("the Party Company") for Rs. 4.15 Crores which is shown as Current Investment (Short Term Investment). Out of the above 4.15 Crores, the management has provided for a diminution of Rs. 4.00 Crores, thus reducing the Investments in the Party company to Rs. 15 Lakhs. In the absence of financial statement for the year ended 31st March, 2021 of the party company, it has been observed from the perusal of the financial statements of F.Y. 2018-19, that the Party Company has accumulated losses of Rs 289.55 Lakhs for the year ended 31st March, 2019. The Party Company is under losses since a past few years. The Party Company's Independent Auditors' Report, audited by the other auditor, shows qualified opinion on non-provision of losses to the extent of Rs. 7.54 Crores on account of valuation of stock at cost instead of lower of Cost or market value for the year ended 31st March, 2019. As a result of this, the net worth of the Party Company has eroded significantly. These conditions, along with absence of clear indications or plans for revival, in our opinion, indicate that there is significant uncertainty and doubt about the correct Fair market value of the said investment. In our opinion, management has not adequately or sufficiently accounted for the imminent diminution, if management accounted for such diminution, the profit for the year ended 31st March 19 would have been further reduced and accordingly carrying value of investment would have also been reduced. We were unable to determine the impact on the Audited financial result, of potential adjustment for provision of diminution in the value of investment made in the said party company.

- III. During the year, the Company has carried out the impairment/obsolete testing exercise on the inventory and found it necessary to provide for impairment of Work in progress and intermediate products inventory. Based on the management's estimate of the fair realizable value of inventory as per Ind AS 2 an impairment provision of Rs. 25.21 Crores has been provided based on the management's best judgment and subject to technical review by a technical team of consultants. In view of uncertainty, we were unable to determine the impact on the Audited financial result, of potential adjustment for impairment provision of inventory that might have been necessary in order to present the inventory at its estimated realizable value. The Saraswat bank have took over the balance stock of Rs.3.55 Crores as the bank declared the Company as Non-performing Asset and has initiated Notice u/s.13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security interest Act 2002.
- IV. As per section 17(5) (h) of CGST Act, 2017, the liability to forego the Input Tax Credit (ITC) arises when the value of inventory is fully written off from the books of accounts on impairment of inventory. Taking into consideration the above point, the Company has failed to reverse the ITC to the extent of inventory written off on account of impairment. In view of uncertainty, we were unable to determine the impact on the Audited financial result, of potential adjustment for reversal of ITC. The losses, in our opinion, would have substantially increased if the Company had provided for the liability of reversal of Input Tax Credit.
- V. According to Ind AS-19, related to employees' benefits, the company has not given any effect of gratuity liabilities as per actuarial valuation; hence the effect of gratuity expenses as per Ind AS-19 is not reported in other comprehensive income. As per information provided by the company, its operational activities are standstill since February' 2020 and due to non-availability of key personnel there is no detail available for actuarial valuation.
- VI. The company has shareholding of 33.58% in Paid Up Capital of Techno Point Mercantile Private Limited. Therefore, Techno Point Mercantile Private Limited is an associate company within the meaning of Section 2(6) of the Companies Act, 2013; the company has a significant influence as the Company controls at least 20% voting power of the other Company. The company has not prepared consolidated financial statement of the company and Techno Point Mercantile Private Limited which is an associate Company in the same form and manner as it prepares its own financial statements. The consolidated financial statement of the Company needs to be laid before the shareholders of the Company with its own financial statements. However, the company is of the view that there is no significant influence in determining an associate company with control over voting power, rather than control over share capital.
- VII. The Company has not considered the possible effects that may result from the pandemic relating to COVID-19 on the carrying amounts of Audited financial statements. In developing the assumptions relating to the possible future uncertainties in the global economic conditions because of this pandemic, the Company, as at the date of approval of these financial statements has not used internal and external sources of information including credit reports and related information and economic forecasts. Basis such uncertainties, we were unable to determine the adverse impact on its future cash flows and its ability to meet its obligations as and when they fall due.
- VIII. With reference to note no. 2.2 regarding Property, Plant and equipment, the Saraswat Bank have taken over entire property under fixed assets and balance still remaining under CWIP is Rs. 11,97 Lacs towards advance of lands. In the absence of third party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its recoverability in cash or kind, if any. Further in the absence of future cash flow information about the value of fixed assets in use, we are unable to comment upon its impairment provision, if any as per IND AS- 36 "Impairment of Assets".

- IX. With reference to Trade Receivables of Rs. 1.08 Crores as at 31st March, 2021 in the absence of third party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its balance recoverability, if any.
- X. With reference to Other Current Assets (Security Deposit, Loans and advances to employees and balances with government authorities) of Rs.4.47 Crores as at 31st March, 2021 in the absence of third party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its balance recoverability, if any.
- XI. With reference to Trade Payable of Rs.9.76 Crores as at 31st March, 2021 in the absence of third party confirmation, reconciliation, if any and other supportive audit evidence, we are unable to comment upon its balance outstanding, if any.
- XII. With reference to note no. 12 regarding Deferred Tax Liabilities, In FY 2020-21, the saraswat bank has taken possession all property, plant & equipmentand auctioned it to recover their dues of under SRFESIA Act, 2002, hence there is no differences arises on account of deferred tax liabilities. In absence of future taxable profit, the utilisation of deferred tax asset generated in the current year for Rs. 17,48,83,233/- has not been recognised in compliance of IND AS 12 as contemplated in Companies Act, 2013.

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under Section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements Section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the Financial Statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter

- 1. We draw attention to the Note No. 10 in the financial Statements. The company has incurred net loss after exceptional items of Rs. 23.66 Crores during the year ended 31st March, 2021 and as of that date, the Company's accumulated losses aggregate to Rs. 19.10 Crores resulting into eradication of entire net worth, negative working capital, loss of key personnel and negative cash flow. Hence the Company's future performance is doubtful and has not been able to pay liabilities of banks, creditors. These factors along with other matters as set forth in said note raise substantial doubt about the company's ability to continue as a going concern in the foreseeable future.
- 2. We draw attention to Note 10 of the accompanying financial statements, during the year under review; the Company incurred huge losses, which resulted into eradication of entire net worth, negative working capital, loss of key personnel and negative cash flow. Hence the Company's future performance is doubtful and has not been able to pay liabilities of banks, creditors. As informed to us and relied as per management view, during the financial year 2019-20, Company has written off huge stock on account of closure of plant by Pollution control Board in periodic interval for different manufacturing units, power/water disconnection due to closure notice, batch failure and COVID 19 situation has lost key personnel responsible for production and Loss of skilled workers. The Company has been facing many problems related to pollution issues and received closure notice from Maharashtra Pollution control Board since past three years in different occasions. Lastly under COVID 19 it could not produce material.
- 3. We draw attention to Note No. 3 of accompanying financial result regarding notice issued by the Saraswat Co-Operative Bank Limited under section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act 2002 for non-payment of principal and interest thereon after the due date by the company and therefore all loans accounts became Non-Performing Assets effective from respective dates mentioned in such notice. These factors along-with other matters as set forth in said notice raise substantial doubt about the company's ability to continue as a going concern in the foreseeable future.

In view of the same and events stated in points I, II, III, IV, V, VII, VII, IX,X, XI and XII in the para above "Basis for Qualified Opinion", indicate that a material uncertainty exists that may cast a significant doubt on the Company's ability to continue as a going concern. (Note No. 30 of accompanying financial statements)

Based on the management's estimate of the fair realizable value of inventory as per Ind AS 2 an impairment provision of Rs. 25.21 Crores has been provided based on the management's best judgment and subject to technical review by a technical team of consultants. The Saraswat bank have took over the balance stock of Rs.3.55 Crores as the bank declared the Company as Non-performing Asset and has initiated Notice u/s.13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security interest Act 2002.
- (iii) In our opinion and according to the information and explanation given to us, the Company has not granted any loans to parties covered in the register maintained under Section 189 of the Act. There are no firms /LLPs/ other parties covered in the register maintained under Section 189 of the Act. Accordingly, the provisions of clause 3(iii) of the Order are not applicable to the Company.
- (iv) In our opinion and according to the information and explanation given to us, the Company has complied with provisions of Section 185 and Section 186 of the Act with respect to loans and investments made.
