
In continuation of our earlier letter dated December 16, 2024 on the captioned subject, we wish to inform you that the QIP Committee at its meeting held today, i.e., December 16, 2024, approved the issue and allotment of 83,26,394 Equity Shares to eligible qualified institutional buyers at the issue price of ₹ 1,201 per Equity Share (including a premium of ₹ 1,199 per Equity Share), which includes a discount of ₹ 13.98 per Equity Share (1.15% of the floor price, as determined in terms of the SEBI ICDR Regulations) to the floor price, aggregating to ₹ 9,99,99,99,194 (Rupees Nine Hundred Ninety Nine Crores Ninety Nine Lacs Ninety Nine Thousand One Hundred and Ninety Four Only), pursuant to the Issue.

The Issue opened on December 12, 2024 and closed on December 16, 2024 and the same was intimated through our letters dated December 12, 2024 and December 16, 2024, respectively.


