## Hooch kills 14 in TN, 40 others hospitalised

**Kallakurichi:** Fourteen people died on Wednesday after consuming illicit arrack near Kallakurichi in Tamil Nadu on Tuesday night. More than 40 others are being treated in hospitals in Kallakurichi, Villupuram, Salem and Pudukchery. Samples tested at a forensic laboratory were found to have the poisonous methanol.

Police arrested a bootlegger, K Govindaraj alias Kannukutti, on charges of selling illicit arrack and seized more than 200 litres of the brew. Police said dozens of people from



200 litres of the brew mixed with methanol has been seized

Kallakurichi town and neighbouring areas had consumed illicit arrack sold by bootleggers at Karunapuram on Tuesday night. On reaching home, most of them complained of giddiness, headache, vomiting, nausea, stomach pain and irritation in the eyes.

Their family members rushed them to a private hospital in the town and Kallakurichi Govt Medical College and Hospital where seven people died. Of the 18 men admitted to Jipmer, three died. Four more patients died in Salem and Villupuram, taking the toll to 14 so far. A team led by the Tamil Nadu Health System project director M Govinda Rao reached the place to oversee the treatment. CM MK Stalin asked public works minister EV Velu and health minister Ma Subramanian to visit the hospital and extend all necessary help to the patients. In May last year, 22 people died and several others were hospitalised after they

## Over 100 take ill after eating panipuris

**Nashik:** Over hundred people from three villages fell ill after consuming panipuris in Maharashtra's Jalgaon district.

On Monday, villagers from nearby areas visited the weekly market at Kamalgaon village in Jalgaon and consumed panipuri from a kiosk. On Tuesday, many people experienced symptoms like vomiting and loose motions, and were admitted to various healthcare facilities.

Sachin Bhahekar, Jalgaon district health officer, said that condition of all the patients is stable and many have been discharged. As of now, 50 patients are receiving treatment at various hospitals. Authorities have identified the panipuri vendor and the Food and Drug Administration (FDA) officials in Jalgaon have collected samples of all the ingredients for analysis.

# Prolonged heat wave in country as monsoon takes longer hiatus

## Sowing Of Kharif Crops In North & Northwest India Too Delayed

**New Delhi:** The monsoon, which made its onset over Kerala two days in advance and arrived in the north-east six days before its normal date, has remained almost at a standstill since June 12 after making gradual progress and covering roughly 40% of the geographical area during the first 14 days. The current hiatus, relatively longer, has not only contributed to the current heat wave phase but also delayed sowing operation of kharif (summer sown) crops in north and northwest India.

Though the India Meteorological Department (IMD), banking on upcoming La Nina formation, still maintains that the country is most likely to get fairly good rainfall during July-September, it has downgraded its forecast for June rainfall for the country as a whole from 'normal' to 'below normal' due to the current pause in the movement of monsoon.

La Nina conditions — climate pattern associated with the periodic cooling of ocean surface temperatures in the central and east-central equatorial Pacific — are generally associated with good monsoon rainfall in India. Past data shows that the summer monsoon was either 'normal' or 'above normal' in most of the last 22 La Nina years since 1954 except 1974 and 2000 when it was below normal. IMD has already predicted 'above normal' monsoon rainfall for the country as a whole this year.

"Monsoon hiatus is very common in the monsoon season. Monsoon does not progress in one stretch. But the current hiatus is relatively longer. It could be associated with the intra-seasonal activity and also Madden Julian Oscillation (MJO)," said Madhavan Rajeevan, climate scientist and former secretary, ministry of earth sciences. MJO is one of the

most important atmospheric-ocean coupled phenomena in the tropics, which has a profound influence on the Indian summer monsoon.

Delayed monsoon, however, has implications on farming operation as it would delay sowing of kharif crops, mainly water-guzzling paddy, which will eventually reduce the gap between harvest of kharif crops and sowing of next (rabi) crops — a situation which invariably leads to more stubble burning episodes in north-west India as farmers have to rush to prepare ground for sowing wheat and mustard.

"We will advise farmers to go for direct seeded rice (DSR) method of cultivation to save time. But this method has, so far, not got universal acceptance. Farmers continue to go for the traditional method of prior nursery preparation and transplantation that consumes a lot of time," said an official in the agriculture ministry.

## Heat wave claims 4 lives in Firozabad in 48 hours

**Agra:** Blistering heat became deadly in Firozabad when in 48 hours, four individuals who arrived at the district's govt trauma centre in critical condition after suffering a heat stroke, died. They were brought to the emergency ward for treatment of fever, diarrhoea, and high blood pressure triggered by heat stroke, officials said.

Two persons died while entering the emergency gate, and the other two passed away shortly after being admitted, as per hospital officials. Six patients with heat stroke are currently admitted in critical condition and undergoing treatment, the officials added.

More than 90 people have been admitted to the centre in the past 24 hours, according to the hospital administration, the number of those affected by the intense heat is increasing daily. The emergency ward is overcrowded, with two patients sharing one bed in some cases. Patients can be seen crowding the registration counter and sitting in the corridors.

## Govt cancels UGC-NET test over 'paper leak'

**New Delhi:** Govt on Wednesday cancelled the UGC-National Eligibility Test after an alert by the national anti-crime agency that the paper had been leaked.

"On June 19, University Grants Commission received certain inputs from the National Cyber Crime Threat Analytics Unit of Indian Cyber Crime Coordination Centre under the ministry of home affairs. These inputs prima facie indicate that the integrity of the examination may have been compromised," an official release said.

The order came amid persistent demands for cancellation of NEET-UG exam over alleged irregularities.

Sources confirmed that the education ministry, which examined the inputs, took the decision after concluding that the paper had leaked. The exam is conducted by National Testing Agency.

The matter has been handed over to CBI for a criminal investigation, and fresh dates for the exam will be announced. The test in OMR (pen and paper) mode was held on June 18 in two shifts across different cities.

UGC-NET determines the eligibility of Indian nationals for junior research fellowships, appointments as assistant professors, and admission to PhD programmes in Indian universities and colleges. Besides, the high rankers in the exam also get a stipend.

## Forged docu: NEET aspirant faces action

**Lucknow/New Delhi:** Allahabad High Court on Tuesday dismissed a petition filed by a NEET-UG aspirant who had alleged that National Testing Agency (NTA) had failed to declare her result and that her OMR answer sheet was found torn. The court said the girl had submitted forged documents. "NTA can take legal action in the matter," Justice Rajesh Singh Chauhan said in his order. NTA told the court that the decision to initiate legal action against the student, Ayushi Patel of Lucknow, had already been taken. The order came after NTA, as per the court's direction, produced the original OMR answer sheet of the student, which was found to be intact. Ayushi's sensational claim added fuel to the demand for cancellation of the NEET-UG exam, and was embraced by Congress leader Priyanka Gandhi to attack the Modi govt. With the HC adjudging Ayushi's claim to be a hoax, BJP slammed Priyanka and sought an apology. "You remember this tweet by Priyanka Vadra, here is how Congress peddles fakery," party spokesperson Shehzad Poonawalla said while dubbing Congress "jhooth ki dukaan".

The official release also addressed the controversy surrounding the NEET-UG test and said a decision on the demand for a fresh test would be taken on the basis of the report of the economic offences unit of Bihar Police which has claimed to have found evidence "suggestive" of a leak in the medical entrance exam.

The govt said it has already reversed its decision to grant grace marks to NEET applicants who did not get the full 3 hours and 20 minutes to complete the exam. "Govt is committed to ensure the sanctity of examinations and protect the interests of students. It is reiterated that any individual or organisation found to be involved in the matter will face strictest action," the release said.

## Good sleep can help reduce high blood pressure risk in children, teens: Study

**New Delhi:** It is not just the adults. Many children also suffer from hypertension or high blood pressure.

While earlier it was thought that changing the diet and improving physical activity are the best non-pharmacological interventions to manage it, new research published in the journal Paediatrics suggests adequate sleep and going to bed earlier are equally important.

"We recommend that when a paediatrician identifies a patient (children and teenagers) with elevated blood pressure, in addition to standard counselling, a pa-

tient would benefit from counselling on optimal sleep health," study author Amy J Kogon, a paediatric nephrologist at the Children's Hospital of Philadelphia, said in a video abstract.

Kogon and his team studied the link between sleep and blood pressure in 539 children and teens who were being evaluated for high blood pressure at the hospital's paediatric nephrology clinic.

According to the Paediatrics study, they found that on average the children and teens slept just over nine hours per night. Every extra hour of sleep duration was

associated with reduced odds of increased blood pressure in the morning.

In India, some studies suggest that nearly 7% of school going children suffer from

hypertension. Dr Krishan Chugh, principal director of paediatrics at Fortis Gurugram said the Philadelphia hospital study scientifically proves what has been widely believed earlier also that a good sleep is essential for maintaining the normal blood pressure and working of the heart, besides that of the brain and the mind.

"In recent times, it has been noticed that many adolescents are having high blood pressures, both systolic and diastolic, even when they're not suffering from any other illness," Dr Chugh said. He added that it is important to sleep at the right time.

## Flyers fret as SpiceJet aircraft boils in heat; all good, says airline

**New Delhi:** A video by news agency ANI on X has shown passengers on a SpiceJet Delhi to Darbhanga flight sitting inside the plane at Delhi airport with inefficient air conditioning in the middle of a heatwave.

The video showed the passengers sweating and in distress on the flight that seemed full up to its capacity. Some of the passengers were seen using flight brochures to fan themselves to cope with the heat. The footage shows some passengers visibly uncomfortable in the stuffy cabin. SpiceJet, when asked to respond to the incident, denied the allegations. The airline said that the air conditioning system initially faced "slight inefficiency" due to the extreme heat and the fact that both doors of the aircraft were open.

However, the system started functioning properly shortly after, the airline said. The airline's statement aimed at clarifying the matter and address the concerns raised by the passengers. "SpiceJet flight SG 476 from Delhi to Darbhanga on June 19, scheduled to depart at 11am, depar-

ted on time without any delays. The air conditioning was working normally throughout the flight, which was verified and cross-checked. The same aircraft operated the return flight to Delhi, and there were no issues with the air conditioning on the return flight either," a SpiceJet spokesperson said. "The official added that there was, however, a minor flaw in the air conditioning due to extreme heat and because both the aircraft doors were open as the flight was not docked at the aerobridge. "During boarding in Delhi, the air conditioning initially experienced slight inefficiency due to extreme weather conditions and both doors of the aircraft being open, as boarding was not via the aerobridge," the SpiceJet spokesperson said.

## Landlord demolishes staircase, traps tenants over unpaid rent in TN

**Chennai:** Tamil Nadu fire and rescue personnel were called to Vanavil Nagar in Kancheepuram to rescue a family trapped on the first floor of their home after their landlord demolished the staircase in an escalation of a prolonged rent dispute.

Tenant Venugopal had rented the first floor of the house last year. However, after falling ill and becoming partially disabled, his ability to work and earn an income was severely impacted. As a result, he was unable to pay rent for six months. Despite being granted an additional month to settle the arrears, Venugopal and his family could not make the payment, prompting their landlord Srinivasan

to take drastic measures. Srinivasan, who runs an offset printing unit in Kancheepuram, had already cut off the electricity, water, and sewage lines to the property the previous week. On Tuesday evening, he hired an earthmover and ten workers to demolish the staircase, trapping the family on the first floor.

The family, unable to escape, called police for help. They alerted Tamil Nadu Fire and Rescue Services (TNFRS). The rescue team arrived at the scene within 20 minutes. Using a fire ladder from a neighbouring terrace, they managed to rescue Venugopal's wife Leela and their son. However, due to Venugopal's inability to walk, the team had to tie him to a rope and carefully lower him to safety.
