## Ref: Our stock exchange intimation dated September 10, 2024 (Closing intimation under Share Purchase Agreement)

Dear Sir/Madam,

This is in furtherance to our intimation dated September 10, 2024, *inter alia* informing about the execution of the share purchase agreement (SPA) entered into by and amongst 2726247 Ontario Inc ('OMERS'), OMERS Infrastructure Asia Holdings Pte Ltd ('OMERS Infrastructure') and Allianz Infrastructure Luxembourg II S.A.R.L ('Allianz').

Pursuant to the: (i) approval of unitholders under Regulation 22(5C) SEBI InvIT Regulations on October 8, 2024 and (ii) approval of unitholders and SEBI under Regulation 22(5)(a) of SEBI InvIT Regulations, and based on the closing intimation received from the party(s) to the aforesaid SPA, the Allianz has transferred their entire units held in Interise Trust (Trust) an aggregate of 1,40,558,623 units constituting approximately 13.48% of total units to OMERS and OMERS Infrastructure on December 12, 2024, of which 85,617,507 units (~8.21%) were transferred to OMERS and balance units, 54,941,116 units (~5.27%) were transferred to OMERS Infrastructure. Further, Allianz has transferred their entire equity shares held in the Interise Investment Managers Limited (Company), being Investment Manager of Interise Trust (Trust), an aggregate of 14,172,501 equity shares having face value of Rs.10 each of the Company to OMERS Infrastructure on December 12, 2024.

In view of the above, since the Allianz has transferred their entire units held in the Trust, therefore Ms. Anjali Gupta, being unitholder nominee Director of Allianz, has resigned from the Board of Directors of the Company with effect from the close of business hours on December 12, 2024.
