Bhraich violence: 5 accused held, two injured in police encounter

MANISH SAHU LUCKNOW, OCTOBER 17

TWO OF the five persons arrested in connection with the violence that broke out in Uttar Pradesh's Brahach district were shot at by police personnel on Thursday when they allegedly tried to escape by opening fire after they were taken to the Nanpara area to recover a weapon that police suspect was used during Sunday's violence.

The two accused, identified as Mohammad Taleem and Mohammad Sarfaraz, were "seriously injured" and are undergoing treatment, police said.

The others arrested were identified as Abdul Hameed, Mohammad Fahin, and Mohammad Afzal.

The clashes on Sunday began after some local residents allegedly asked for music to be turned off as a Durga idol procession passed through a Muslim-majority area. After a heated argument

escalated into clashes and stone-pelting between two groups, 22-year-old Ram Gopal Mishra, a local resident, was allegedly shot and killed.

Police said Mishra was killed inside Abdul Hameed's house. Additional Superintendent of Police Pavitra Mohan Tripathi said Hameed and his sons, Sarfaraz and Fahin, were booked in the murder case, and that the alleged involvement of Taleem and Afzal emerged later. **FULLREPORTON** www.indianexpress.com

13 MINISTERS ALSO SWORN IN HARYANA

Saini takes oath as CM, event marks BJP's show of strength

NAYAB SINGH Saini, the proverbial dark horse who became star of the BJP's victory in the Haryana assembly elections, was sworn in as chief minister of the state on Thursday in a grand ceremony attended by Prime Minister Narendra Modi and a galaxy of NDA leaders.

Thousands of people packed into the Dussehra Ground to watch Governor Bandaru Dattatreya administer the oath of office to the low profile OBC leader and 13 others. For the BJP, the messaging was not just in its show of strength with a power packed dais seating its chief ministers, ministers and NDA partners but also in its choice of the day - Valmiki Jayanti.

Sage-poet Valmiki is the author of the Hindu epic Ramayana and a revered figure, especially among Dalits.

The Prime Minister congratulated Saini and his ministerial colleagues on their swearing-in and described the team as a wonderful mix of good governance and experience.

"This government will realise

the dreams of people and take the state's development to a new high," he said in a post on X in Hindi.

"I am confident that the double engine government will leave no stone unturned in serving the poor, farmers, youths and women besides all other sections of society," Modi said.

Saini also thanked 2.8 crore people of Haryana for their mandate and the prime minister for his "inspirational leadership".

"For the third time with full majority, the BJP government will

work with full energy for good governance, equality and welfare of the poor," Saini said in a post on X after being sworn in for the second time as chief minister.

The 54-year-old, who was the surprise pick to replace strongman M.L. Khattar as chief minister ahead of the assembly elections, proved his naysayers wrong by steering the BJP to a win in an election many thought would go to the Congress.

Saini is heading the BJP's third consecutive government in the state, a strategic victory after the Lok Sabha elections that many party leaders hope sets the pace for next month's crucial assembly polls in Maharashtra and Jharkhand.

The BJP won 48 seats in the 90-member assembly. Three Independents, including Hisar MLA Savitri Jindal, also extended support to the party.

Haryana can have a maximum of 14 ministers, including the chief minister.

The 13-member council of ministers includes the party's most senior leader and seven-time MLA Anil Vij, Ahir leader Rao Narbir Singh and Jat leader Mahipal Dhanda. It also has two women - former Congress leader

Shruti Choudhary, daughter of Rajya Sabha MP Kiran Choudhary, and first time MLA Arti Singh, the daughter of Union minister Rao Inderjit Singh.

Rajesh Nagar and Gaurav Gautam took oath as state ministers (independent charge).

All the newly inducted ministers except Choudhary took their oath in Hindi. Choudhary took her oath in English.

Besides giving representation to various castes, including five from the OBC category, two Dalits, two Jats and two Brahmins, the Saini ministry has also accommodated leaders from various regions, including Ahirwal belt, GT road belt and the Faridabad-Palwal region.

"It is teamwork... We will fulfil all the responsibilities given to us by the CM (Nayab Singh Saini)," BJP's Shyam Singh Rana said after taking oath as Haryana minister.

Union minister Khattar, who had ceded space to Saini, took the occasion to thank all the NDA leaders, chief ministers and others who had gathered.

"This is the first time since 1980 that any party has formed government thrice in Haryana or any other state," he told PTI Videos after the event.

Among those present were Union ministers Amit Shah, Rajnath Singh, Nitin Gadkari and BJP president J P Nadda. Chief ministers of several BJP-ruled states, including Uttar Pradesh's Yogi Adityanath, Assam's Himanta Biswa Sarma, Chhattisgarh's Vishnu Deo Sai, Gujarat's Bhupendra Patel and Uttarakhand's Pushkar Singh Dhami, NDA partner, TDP leader and Andhra Pradesh Chief Minister N Chandrababu Naidu, was there too.

25 deaths linked to illicit liquor in 2 Bihar districts over three days

AT LEAST 25 people suspected to have consumed hooch (illicit liquor) have died over a period of three days in Bihar's Siwan and Saran districts, while several others have been hospitalised with complaints of stomach ache, nausea, and blurring of vision.

After CM Nitish Kumar ordered a probe into the matter, DGP Alok Raj said: "We confirm 20 deaths in Siwan and five in Saran. Over a dozen liquor traders and manufacturers have been arrested so far." Officials in the Siwan and Saran administrations had earlier said that those who died consumed some "intoxicating substance". The state police, however, now confirm deaths due to consumption of illicit liquor.

Siwan police has suspended Bhagwanpur Haat police station in-charge, and Saran police have issued a show-cause notice to Masrakh police station in-charge, Excise Commissioner Krishna Kumar visited Siwan and Saran.

According to Siwan police, 20 deaths took place in Bhagwanpur, Madhar and Koudia over the last three days. Saran police said five deaths took place in the district during this period. All the victims are aged between 22 and 40.

According to relatives of the deceased in Siwan, around 20 people had consumed country liquor on Monday and Tuesday. "Ten of them reported stomach ache after drinking suspected illicit liquor and later died either on way to hospital or at Siwan hospital," said Prakash Kumar, a relative of one of the victims.

Siwan SP Amitesh Kumar said: "We have been talking to victims' families to know the exact reasons for the deaths. Post-mortem is also being conducted. Raids are underway to arrest liquor traders and manufacturers."

Domestic help held for mixing urine in dough, say police

THE FAMILY members of a Ghaziabad businessman had been suffering from liver-related issues for the past few months. Suspicious, his wife hid a mobile phone camera in the kitchen. The footage led to a shocking revelation - their cook of eight years was allegedly seen mixing her urine in the dough, Ghaziabad police said Wednesday.

"Her employer hid a mobile phone in the kitchen. In the recorded video, she was seen allegedly urinating in the kitchen utensil and making chapatis using the urine," said Preeti Garg, SHO of Crossing Republic police station.

The domestic help has been arrested under Section 272 (malignant act likely to spread infectious disease dangerous to life) of the BNS. Garg said, the help initially denied the allegations but admitted to the act when shown the video. "The domestic help claimed she was driven by revenge after being frequently scolded by her employer for minor mistakes," said ACP Wave City Lipi Nagaich, a PTI report said.
