Dear Sir/Madam,

We wish to inform you that Dalmia Cement (Bharat) Limited ('**DCBL**') wholly owned subsidiary of the Company, has received order on August 28, 2024 at 3:00 P.M. under Section 73 of the Central Goods and Services Tax Act, 2017 and Delhi Goods and Services Tax Act, 2017 from the Assistant Commissioner, Central GST, Division - Cannaught Place, New Delhi confirming demand for allegedly passing duplicate Input Tax Credit ('**ITC**') and for availing ineligible ITC due to non-payment of GST by supplier for the period 2019-20.

The authority has confirmed demand of-

- 1) tax amounting to Rs. 81.10 Lacs along with interest; and
- 2) penalty amount of Rs. 8.20 Lacs.

The matter is contestable before the Appellate Authorities and DCBL will file an appeal against the said order before the Joint Commissioner (Appeals) within prescribed timelines.

The details as required under Regulation 30 of the Listing Regulations read with SEBI circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 are provided in the Annexure hereto.
