Sub: Clarificatory Statement in respect of the Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) made on 04th October 2024 at 1:40 PM.

Dear Sir/ Ma’am,

Pursuant to Regulation 30 read with Clause no. 20 of Para A of Part A of Schedule III of the Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 (“SEBI Circular”), Honasa Consumer Limited (“Company”/“Honasa” in this case) had made disclosure on 4th October 2024 at 1:40 PM. In the interest of limiting misinterpretation of the disclosure, Honasa finds it necessary to release the additional clarificatory statement in relation to ongoing litigation between Honasa and RSM General Trading LLC (“RSM”).

RSM filed a precautionary attachment application for attaching assets of the Company. However, to clarify the order on 3rd October 2024, there shall be no attachment of the Company assets, as the Company (**Honasa Consumer Limited**) has no assets located in UAE. Honasa Consumer General Trading LLC (subsidiary of Honasa Consumer Limited) has been exempted from this order.

In furtherance of above, the Company had filed Section 9 petition before Delhi High Court seeking ad-interim injunction which was granted in favour of Honasa Consumer Limited and ordered RSM to withdraw the execution proceedings in UAE and deposit Rs. 57 Crores to its registry, which shall be released to Honasa, upon the execution proceedings being successful in Dubai. Whereas RSM is in non-compliance of this order, hence, Honasa will file contempt against RSM in Delhi Court for such non-compliance.

Kindly take the same on record.
