Ukraine wants partner countries to join in post-war development

Ukraine wants to collaborate with partner countries on postwar projects worth billions of dollars not just in mining rare earth elements, but also in energy and construction sectors to help rebuild the country, Ukrainian Foreign Minister Andrii Sybiba said Wednesday.

Sybiba responded to comments by President Donald Trump who said Monday that he wanted to gain access to Ukraine's valuable rare earth materials as a condition for continuing support for its war against Russia. Ukrainian officials have said Russia wants to get its hands on Ukraine's vast natural resources.

Kyiv intends to offer "guarantees" of the presence of major businesses in Ukraine and the vested interests of our closest allies — the United States — in developing these (rare earth) deposits and ensuring their protection," the foreign minister said.

But cooperation should not be limited to rare earth materials, Sybiba said in a news conference alongside visiting U.K. Foreign Secretary David Lammy. Ukraine has "huge potential" to become a guarantor of energy security in Europe by buying liquefied natural gas from the United States and storing it in its massive underground tanks for later distribution, he said.

Sybiba also said there was "joint interest" from Ukrainian and American businesses in the postwar reconstruction of Ukraine, estimated to cost more than \$400 billion. "This will be one of the largest projects of this century and, accordingly, one of the largest opportunities for our allies."

Meanwhile, Zelenskyy said in an interview broadcast Tuesday night that the war has killed 45,100 Ukrainian troops. The fighting also has injured close to 390,000 troops, he told Piers Morgan Uncensored on YouTube.

On December 8, he said Ukraine had lost some 43,000 soldiers on the battlefield and 370,000 wounded. Russia has not given its number of killed since September 2022, seven months after its all-out invasion.

If the US stops sending vital military aid, that could also jeopardize European support, Zelenskyy said in the interview. "Without a doubt, we cannot do without this kind of (Western) support," he said. Zelenskyy said Wednesday that the United States must be part of any Western troop deployment to safeguard a peace deal with Russia and shield against another invasion. Sending only European troops would not be enough, he said.

Rwanda-backed rebels seize another town in Congo

Goma (PTI): Rwanda-backed rebels gained ground in eastern Congo on Wednesday despite the unilateral ceasefire they declared earlier this week, taking control of a town 100 kilometers (60 miles) from the provincial capital of Bukavu, she added.

Van de Perre said all exit routes from Goma and its airport are under control of the M23 and Rwandan military forces backing them, and movements of the U.N. peacekeeping force known as MONUSCO in the city have been restricted. She said reopening the damaged Goma airport is critical for ongoing civilian and humanitarian use. The United Nations is also "gravely concerned" at losing Bukavu's Kavumu airport, which is now used by Congo's military, she said. Néné Bintou, president of the civil society of South Kivu province, told the AP that the mining town of Nyabibwe was under the control of the M23. Nyabibwe is midway between Bukavu and Goma, the city the rebels seized last week and still control.
