Review Report to The Board of Directors, Agritech (India) Limited

- 1. We have reviewed the accompanying statement of unaudited Standalone Ind-AS financial results of Agritech (India) Limited (the Company') for the quarter ended 30th June 2023 and year to date results for the period 1st April 2024 to 30th June 2024 ('The Statement') being submitted by the Company pursuant to the requirements of regulation 33 of the Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulation 2015 as amended.
