Pursuant to Regulation 30 of the SEBI (LODR) Regulations 2015, we reproduce below the proceedings of the **33rd Annual General Meeting** of **Rekvina Laboratories Limited** (the "Company") held on **Monday**, **12th August**, **2024** at 02:00 PM at the Registered Office of the Company Paradise Complex, 328-329, 3rd Floor, Sayajigunj, Vadodara, Gujarat, 390005.

Mr. Amit Mukesh Shah, Managing Director of the Company chaired the proceedings of the Meeting. The requisite quorum being present, the meeting was called to order.

The Chairperson welcomed all members present and fellow members on the Board.

Total 17 Members attended the Meeting as per the Records of attendance.

The Chairman gave overview on the performance of the Company along with its future outlook.

Item No. 1 as stated in the notice were covered in the meeting. The Chairman also gave opportunity to Members to ask questions or seek clarifications on the agenda items.

Annual General Meeting Proceeding

The Chairman of the meeting informed the shareholders that the Annual General Meeting is being convened as per the provisions of the Companies Act, 2013 for the purpose of conducting the following ordinary business:

Item No. 1 was placed before for voting at the AGM and passed by Ordinary Resolution.

Thereafter, the Chairman requested the members who have not casted vote through remote e-voting are entitled to exercise their right to vote by e-voting and also requested CS Anuj Gupta, Practicing Company Secretary to take charge of the voting process and to conduct voting in fair and transparent manner.
