The aforesaid appointment by MOPNG was on co-terminus basis, owing to the aforesaid letter from the Administrative Ministry, Shri Mrityunjay Jha, (DIN: 08483795) ceased to be the Government Nominee Director of the Company with effect from 1st October, 2024 owing to withdrawal of nomination by MOPNG.
