Lost your voter ID Download it from EC portal

Gurgaon. Those who have lost their voter identity card or want to have a digital copy of it can download it on their mobile or computer from Voter Helpline app or the Election Commission's website voters.eci.gov.in. The digital voter card e-EPIC can also be uploaded to DigiLocker and can be printed as well. District election officer and deputy commissioner of Gurgaon, Nishant Yadav, said the EC has made all election-related tasks available online. The EC has introduced the facility of digital voter ID cards or electronic electoral photo ID cards, known as e-EPIC, across the country. The e-EPIC voter card is a non-editable PDF version of the original voter ID card. This can be easily accessed by storing it on a mobile phone or Dig

Elaborating on how one can download the digital card, he said that once a person visits the National Voter Portal at eci.gov.in, new users need to register first, then click on the option to download e-EPIC, enter the e-EPIC number or form reference number. Then, an OTP will be sent to their registered mobile number, and then the option to download e-EPIC will appear.

The digital voter card is a convenient and secure way to keep your voter ID card with you at all times, officials said.It can be downloaded and stored on your mobile phone or computer, making it easily accessible whenever you need it. Meerut gets its first substation to power rapid rail and metro

Ghaziabad. The first receiving substation (RSS) for the rapid rail corridor near Shatabdi Nagar station was completed on Tuesday and is now ready for power supply. This is the first of two substations in Meerut providing electricity to the rapid rail and Meerut Metro corridors. The construction of the second substation in Modipuram is ongoing."With the building ready and electrical equipment fully installed, the 70 MW RSS at Shatabdi Nagar is currently undergoing final transformer testing," said an official from NCRTC.The Shatabdi Nagar RSS will supply power to several stations in Meerut, including Rithani (metro), Shatabdi Nagar (RRTS), Brahmpuri

(metro), Meerut Central (underground metro), Bhaisali (underground metro), Begumpul (underground RRTS), and MES Colony (metro).

According to officials, NCRTC has partnered with UPPTCL and PVVNL for power supply to the receiving substation in UP. Power will be supplied to this RSS from the UPPTCL grid substation via 220 kV extra high tension (EHT) cables. The RSS will then distribute 25 kV power for train operations and 33 kV power to meet the needs of the RRTS stations."Each station along the corridor is equipped with an auxiliary substation (ASS) that receives 33 kV power from the RSS via ring main cables and distributes.
