PROCEEDINGS OF THE 33rd ANNUAL GENERAL MEETING OF THE MEMBERS OF INDIAN SUCROSE LIMITED HELD ON MONDAY, 30TH SEPTEMBER, 2024 THROUGH VIDEO CONFERENCING/OTHER AUDIO VISUAL MEANS ("VC/OAVM"), WHICH COMMENCED AT 10.30 A.M. AND CONCLUDED AT 11.43 A.M.

The 33rd Annual General Meeting ("AGM") of the members of Indian Sucrose Limited ("the company") was held on Monday, 30th September, 2024 at 10.30 A.M. (IST) through Video Conferencing ("VC")/other Audio Visual Means Mo("OAVM") without the physical presence of the members at the AGM venue in compliance with the General Circular numbers 14/2020, 17/2020, 20/2020, 02/2021, 19/2021, 21/2021, 02/2022 and 10/2022 dated April 8, 2020, April 13, 2020, May 5, 2020, January 13, 2021, December 08, 2021, December 14, 2021, May 05, 2022, December 28, 2022 and September 25, 2023 and all other relevant circulars issued from time to time respectively by the Ministry of Corporate Affairs ('MCA') and Circular Nos. SEBI/HO/CFD/CMD1/CIR/ P/2020/79, SEBI/HO/ CFD/CMD2/CIR/P/2021/11 and SEBI/HODDHS/P/ CIR/2022/0063 and SEBI/ HO/CFD/PoD-2/P/CIR/2023/4 dated May 12, 2020, January 15, 2021, May 13, 2022 and January 5, 2023 and October 7, 2023 respectively issued by the Securities and Exchange Board of India (collectively referred to as 'SEBI Circulars') and as per the applicable provisions of the Companies Act, 2013 read with Rules made thereunder, Secretarial Standards and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Mr. Kunal Yadav, Chairman & Managing Director, chaired the meeting.

Mrs. Anamika Raju, Company Secretary of the company welcomed all the members of the company, chairman, Board of Directors, other stakeholders, dignitaries present at the meeting and confirmed that the requisite quorum was present for the meeting, as informed by the moderator, pursuant to the provisions of section 108 of the companies Act, 2013 read with Rules 20 of the Companies (Management and Administration) Rules, 2014 (as amended). The meeting was called to order at 10:37 A.M. (IST).

The Company Secretary informed that the company has appointed National Securities Depository Limited (NSDL) to conduct the AGM through Video Conferencing and for providing the facility of remote e-voting.

The Company Secretary informed that the electronic copy of the Notice convening the AGM along with Annual Report for FY 2023-2024 was sent to all the shareholders whose email id's were registered with the Company/RTA/Depositories and to all other who were entitled for the same through electronic mode.

Statutory Registers as per the requirements of the Companies Act, 2013 Auditors' Report, Secretarial Audit Report and documents referred to in the notice convening 33rd Annual General Meeting (AGM) were available electronically, during the meeting.

The Chairman welcomed all person present at the 33rd AGM and confirmed that the company has made all efforts feasible under the current circumstances to enable the members to participate in the meeting through the video conferencing facility and vote electronically.

Directors, Key Managerial Personnel and Invitees who were present in the meeting through Video Conferencing briefly introduced themselves.

The Company Secretary also informed that the Chairperson of the Audit Committee, the Nomination and Remuneration Committee, the Stakeholders Relationship Committee and the Corporate Social Responsibility Committee were present and participated at the AGM through VC.

Since the Notice convening the AGM had already been circulated to all members, the chairman took the notice convening the AGM as received and read.

As there were observations or comments in the Auditor's Report on financial transactions or matters which have adverse effect on the functioning of the Company, with permission of chairman the Company Secretary taken same as read.

The Company Secretary further informed that, the company has provided the facility to cast the votes electronically during September 27th, 2024 to September 29th, 2024, on all resolutions set forth in the 33rd AGM Notice. Members who were participating in the meeting and had not cast their votes through remote e-voting were provided an opportunity to cast their votes through e-voting at the meeting.

Ms. Sheetal Sharma proprietor of M/s Sheetal & Company, Practicing Company Secretary was appointed as scrutinizer to scrutinize the remote e-voting and voting at AGM in a fair and transparent manner.

The chairman then thanked the members present at the meeting and declared the meeting closed at 11.43 A.M.(IST).
