#### Summary of proceedings of NCLT Convened Meeting of Unsecured Creditors

The Meeting of the unsecured creditors of Rane Brake Lining Limited convened by the Hon'ble National Company Law Tribunal, Chennai Bench ('NCLT') on Thursday, November 21, 2024 through video conferencing (VC) / Other Audio Visual Means (OAVM) at 12:00 hrs (IST) ('meeting') for approving the Scheme of Amalgamation of Rane Engine Valve Limited, Rane Brake Lining Limited with and into Rane (Madras) Limited, commenced at 12:05 hrs (IST).

Mr. Siva Chandrasekaran, Authorized Person, welcomed the unsecured creditors to the meeting. He informed that all documents for inspection mentioned in notice convening the meeting are available for inspection along with the transcript of the proceedings of the meeting are being made available on the website of the Company. He introduced Mr. P S N Prasad, Chairman appointed by NCLT for the meeting and introduced Mr. Raymond Albyness, Advocate, who has been appointed as Scrutinizer for this meeting by the NCLT. Mr. Siva Chandrasekaran handed over the proceedings to the Chairman.

Mr. P S N Prasad, Former Judicial Member and Chairman appointed by NCLT, chaired the meeting. The despatch of Notice and issuance of public notice in newspapers were made on October 17, 2024.
