COMMENCEMENT OF COMMERCIAL PRODUCTION OF INSTANT COFFEE AT ITS INSTANT COFFEE SUBSIDIARY UNIT BY ADDING 2000MTPA

Vintage Coffee and Beverages Limited ("VCBL") is pleased to announce an increase of it's commercial production by commissioning additional line with the Production capacity of 2000 MTPA (Spray dried and Agglomerated Instant Coffee) from 27-01-2025, ahead of it's planned timeline of March 2025 at it's 100% Subsidiary namely Vintage Coffee Private Limited, an instant coffee manufacturing unit located near Hyderabad.

Further, the company is trying to focus more on consumer packs to fetch higher margins. This expansion is inline with the company's vision of expansion YOY.
