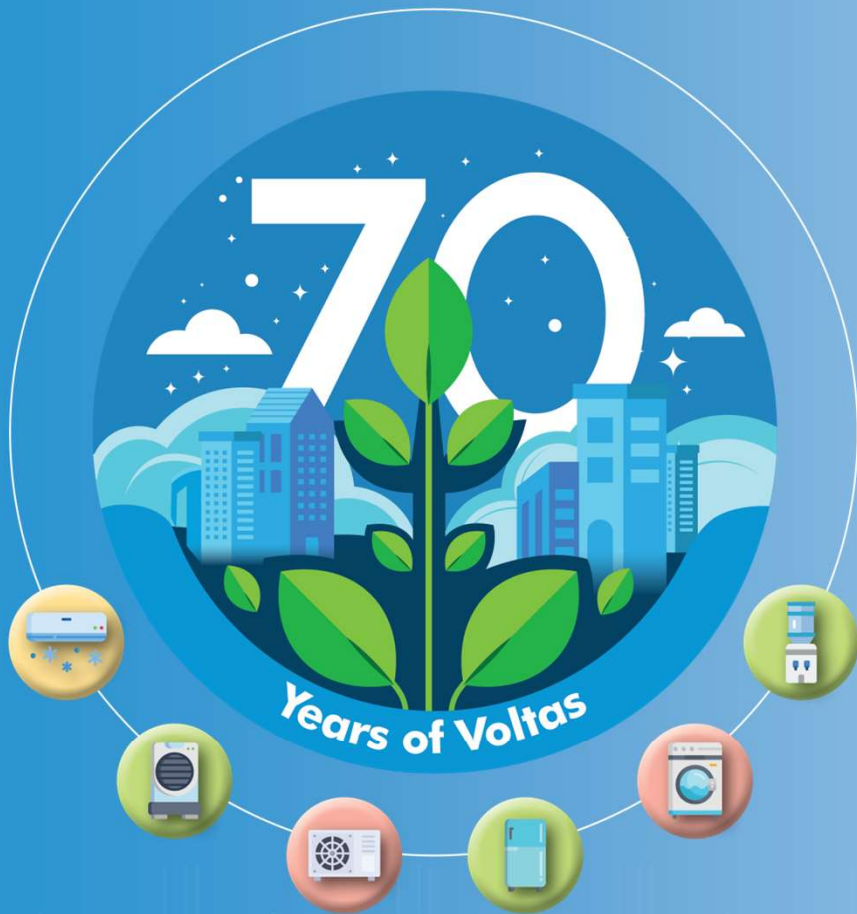

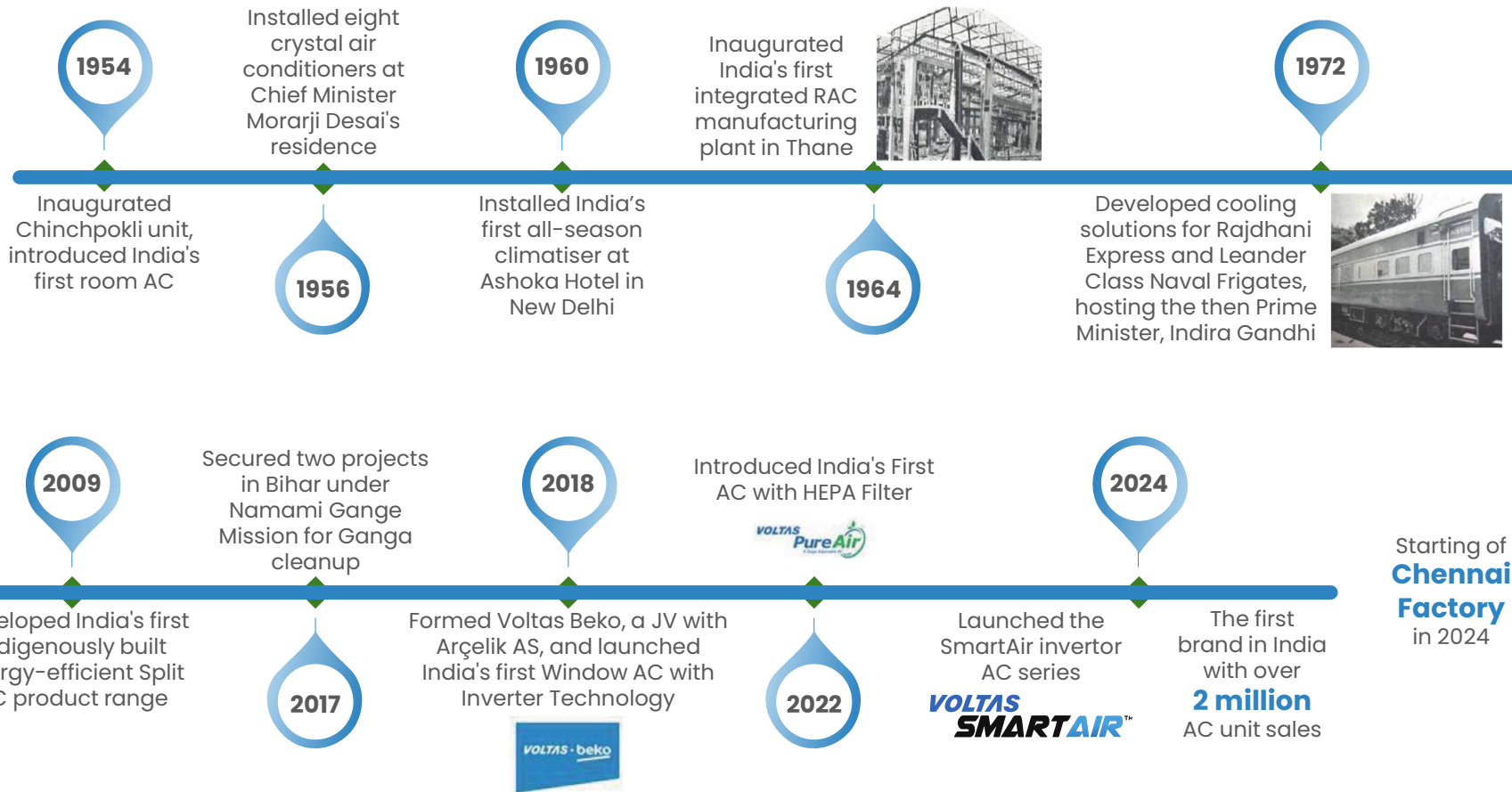

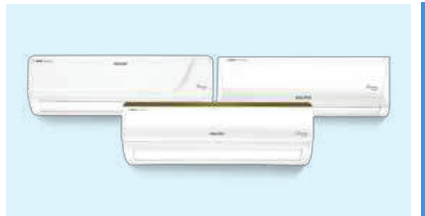

### Highlights

- Achieved the fastest sales of 1 Mn ACs in a quarter and maintained the top market position with 21.2% market share in July'24

- The overall segment order book is Rs. 7,503 crores, with carry-forward orders at Rs. 2,734 crores

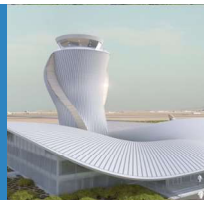

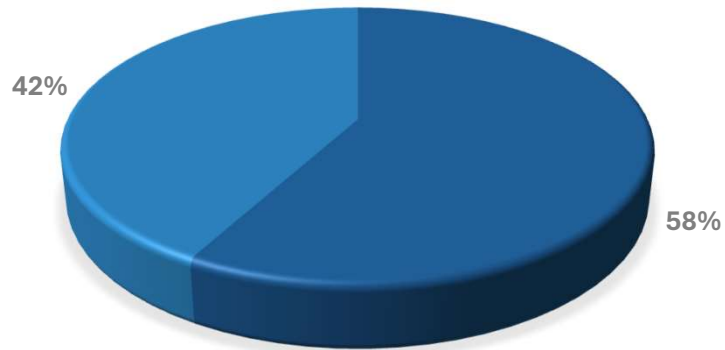

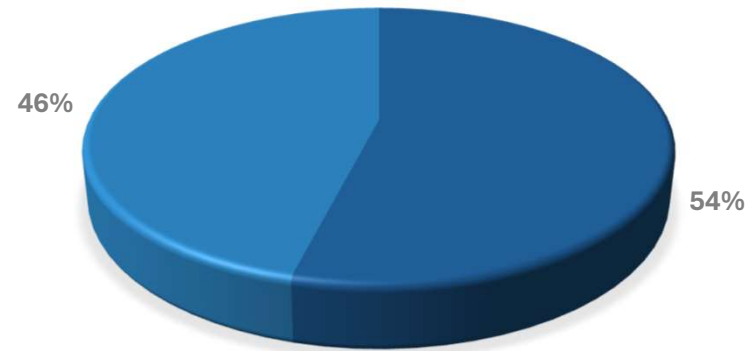


## Revenue – Segment B

**Q1 FY 25 PENDING ORDERS** Rs. In Crs



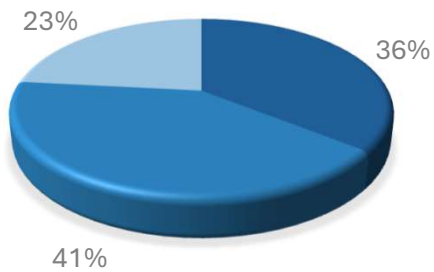

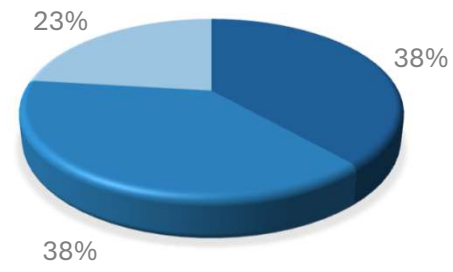

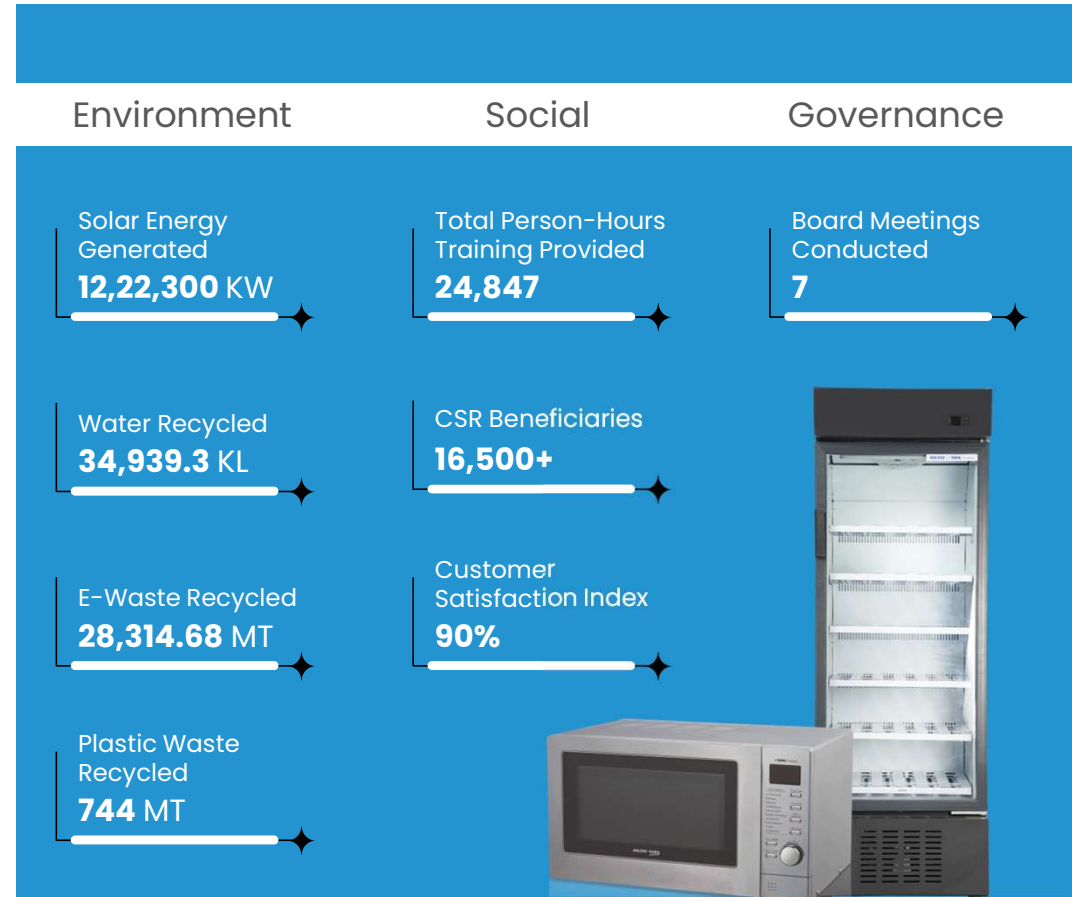
