This intimation is in furtherance to our letters dated December 5, 2024 and December 6, 2024.

We wish to inform that pursuant to the provisions of Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014, as amended from time to time, the Company has conducted the Postal Ballot through remote e-voting process, seeking approval of the Members for the resolutions as set out in the Postal Ballot Notice ("Notice") dated December 5, 2024.

The remote e-voting commenced on Friday, December 6, 2024, at 9:00 a.m. (IST) and concluded on Saturday, January 4, 2025, at 5:00 p.m. (IST).
